# **Superintendent's Report:**

Mr. Burch discussed our CSIP updates. Under Teacher & Staff Recruitment & Retention, the district will add a new recruitment strategy. The committee will meet on March 21, and our principals went to CMU for a career day, which resulted in a new hire; tax collections, Prop C, and state revenue are coming in slightly higher than projected; with the largest increase in expenditures coming from transportation.

### **Unfinished Business:**

Capital Projects: The bleacher project is completed, the concession stand construction is in progress, and the sewer system and water line will be completed soon. Irrigation and grading are also in progress and will be constrained by weather. The back parking lot crossing is also in progress with fill dirt being dumped.

*Preschool*: Mr. Burch presented the project dashboard from Navigate Building Solutions about the progress of the preschool.
