We're cruising

This week we are just along for the ride.

The seller has one more registration to do after today, before the anticipated closing early next week. He is doing one this morning his time, and one more on the 7th after his money is unlocked.

After today's registration he and his staff - at the expense of the buyers - are off to the closed trade show (meaning not open to the public) somewhere on the East Coast to showcase the new company.

As you know all we need is the seller's bank to unlock the \$3MM and we are good to go.

The red eye

Last night after a hectic day including the next to last registration needed, our seller hopped a flight to the East Coast for a private trade show for IT pros and their personnel which I reported already has been paid for by the buyers.

A little advance on this but I don't think I'm necessarily premature, next Monday morning the seller will need to do his final registration showing that his \$3MM being held by his bank has been released to him.

The seller

Again, at this point, all of this is conjecture, and we will not know for another full day and a half, which of course adds to the final time frame for the closing.

No one - not the bank, not the buyers, not the seller, not the attorneys - is concerned about our transaction going south.

The worst case scenario if the fifth buyer wishes to bow out (apparently there are some personality conflicts), not only will he lose enough money to quadruple his over \$100B net worth, which of course will go to a new fifth buyer if all this should unfold. Frankly, no one knows just yet.

Anyways, should any of this develop, it will only add a day or two to the timeline and I will obviously keep you posted on this.

However, please rest assured, don't get your knickers in a not... My partner, Garry, said I am absolutely assured by the seller and after his last night's dinner meeting with the banker from Seoul, our transaction is NOT in jeopardy.

Better news today

I just finished my morning meeting with Garry, my partner, who in turn just finished his morning meeting with the seller who is in L.A.

Last night was the Manager's meeting (these are the high level execs that run the various businesses the buyers own). And tonight is the Board meeting (these are the people who vote on and make policy, for the various businesses all five billionaire buyers own).

Last night the seller was instructed to get a new COVID test this morning, which he will have done by the time you receive this update.

It generally takes, wherever he gets them done, about 24 hours to get the results, and then from the time stamp of that 'all clear' email, expected, under Hawaii law it is only good for 72 hours.

As I have mentioned before a lot of this stuff takes place behind closed doors and often the seller is not privy to it, therefore neither are Garry and I.

Nevertheless it's a great sign for the Managers to instruct him to get his COVID test first thing this morning.

Brief update today

Registration

We now know, the Board in their Wednesday night meeting, voted OUT one of the five buyers, under the direction of their billionaire bosses due to presumably, I'm told, personality conflicts.

Typical Monday today...

The start of a whole new week, and the process continues with excitement from all people, moving forward. So first...

The seller

The seller left his home at 6:30am his time this morning driving to L.A. to pick up the newest document from the legal beagles - you know the guys who work for the buyers - to drive back to Nevada today and register it. (He's not being slowed down by his positive COVID test).

Apparently it is a complicated registration because it involves required legal language telling the court and of course the bank in Seoul that already knows about all this, but it still must be registered, the details of the change from five buyers to four.
