

Community Flood Resilience Task Force Equity & Metrics Committee Meeting Minutes

Tuesday, July 6, 2021, 5:30 – 6:30 p.m. Virtual Meeting via Zoom

1. Community Norms

2. Review of the Data Memorandum Comments

- a. The Equity and Metrics Committee, including members of the Infrastructure Resilience Team (IRT) and the Harris County Judge's Office discussed and reviewed comments on the data request memo from other Community Flood Resilience Task Force (CFRTF) members.
 - i. The Equity and Metrics Committee discussed the importance of equity when measuring flood risks in different communities.
 - ii. The Equity and Metrics Committee discussed the comments in the data regarding the resiliency of structures during flood events. The committee decided this information was not needed for the baseline calculation.
 - iii. The Equity and Metrics Committee discussed the construction cost data for drainage infrastructure. The committee decided to extract construction costs from various data sets to simplify the calculation process.
 - iv. The Equity and Metrics Committee discussed the possibility of requesting data from other cities in Harris County. It was decided that the committee should focus on the City of Houston for the moment.
 - v. The Equity and Metrics Committee discussed the money spent on flood risk in relation to the current estimate on the current population, and how that differs from a cumulative costs comparison.
 - vi. The Equity and Metrics Committee discussed population density as support for why they would use the latest census data.

- vii. The Equity and Metrics Committee clarified that the data and calculation would include businesses along with communities.
- viii. The Equity and Metrics Committee clarified that they will be using the latest census data available to conduct their research.
