

RED THREAD: Loose Threads - Prince Andrew, Peter Mandelson & Epstein

THE ARREST - February 19, 2026

Prince Andrew (now Andrew Mountbatten-Windsor) was arrested on the morning of his 66th birthday following revelations from the January 30, 2026 Epstein Files release when the FBI released over 3.5m documents. The charge relates to his conduct as the UK's Special Representative for International Trade and Investment, not directly to sexual misconduct allegations, as Andrew held the trade representative role from 2001 until 2011 (and was a working royal until giving up public duties following controversy over his relationship with Epstein in 2019).

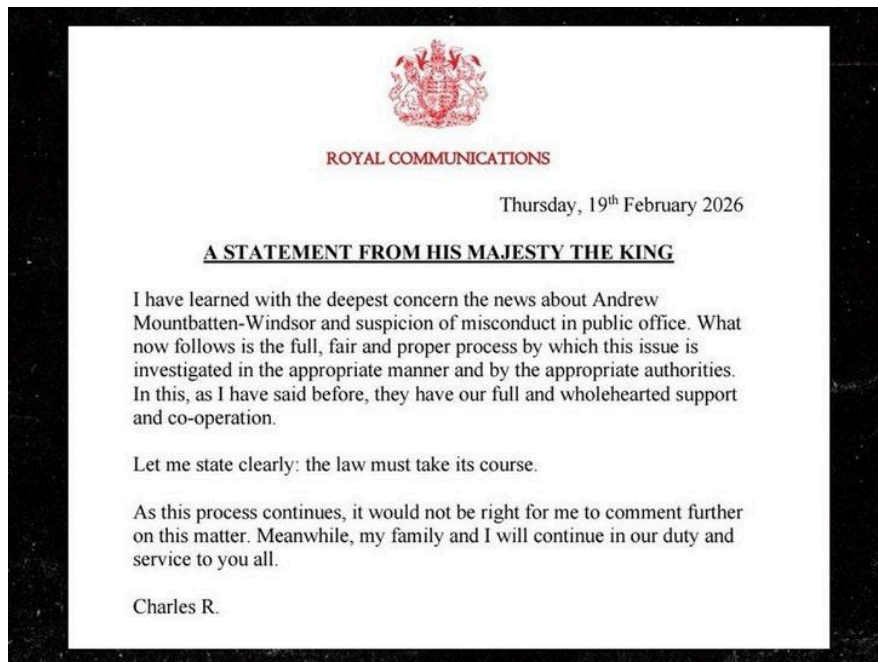

LEAKED EMAILS - Confidential Information Sharing

The following emails were released as part of the DOJ's January 30, 2026 disclosure of ~3.5 million pages of FBI Epstein files under the Epstein Files Transparency Act (H.R.4405). In it, they show an incredibly large amount of confidential information sharing between Andrew Mountbatten-Windsor and Jeffrey Epstein while Andrew Mountbatten-Windsor was still a working royal and trade envoy. This was all shared to

maintain a friendship with Jeffrey Epstein; whether out of fear of secrets being divulged or out of mutual benefit is up for debate.

- **Content:** Andrew stated he spoke with UAE Foreign Affairs Minister Sheikh Abdullah bin Zayed Al Nahyan about a meeting with Epstein. This meeting with the Sheik took place while on an official UK state visit to the United Arab Emirates with the Queen and Prince Philip in 2010.
- **Context:** Earlier emails show Andrew consulted with Epstein about how to approach these conversations, where Epstein gave explicit advice on how to approach the conversation for the best success for Epstein.
- **Significance:** Andrew used his trade envoy position to facilitate Epstein's access to foreign government officials.

These emails prove Andrew maintained an active business relationship with Epstein throughout 2010, which was the exact year that he had claimed to have visited Epstein solely to end their friendship. David Stern, Andrew's liaison and aide, acted as a go-between, forwarding information from Andrew to Epstein. Interestingly enough, David Stern's association with Andrew began in February 2010 when Andrew's wife, Sarah Ferguson, then the Duchess of York, said in an email to an unknown recipient that Epstein had introduced her to Stern and that Stern had come to the Royal Lodge in

Windsor for dinner. So, in that sense, David Stern is obviously an asset of Jeffrey Epstein, that Epstein had used in conjunction with Andrew.

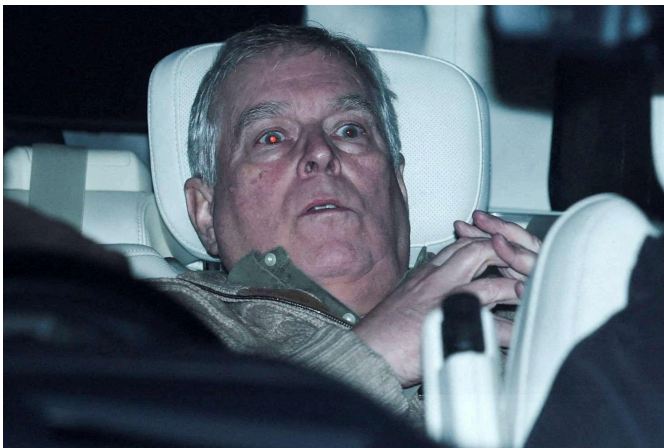

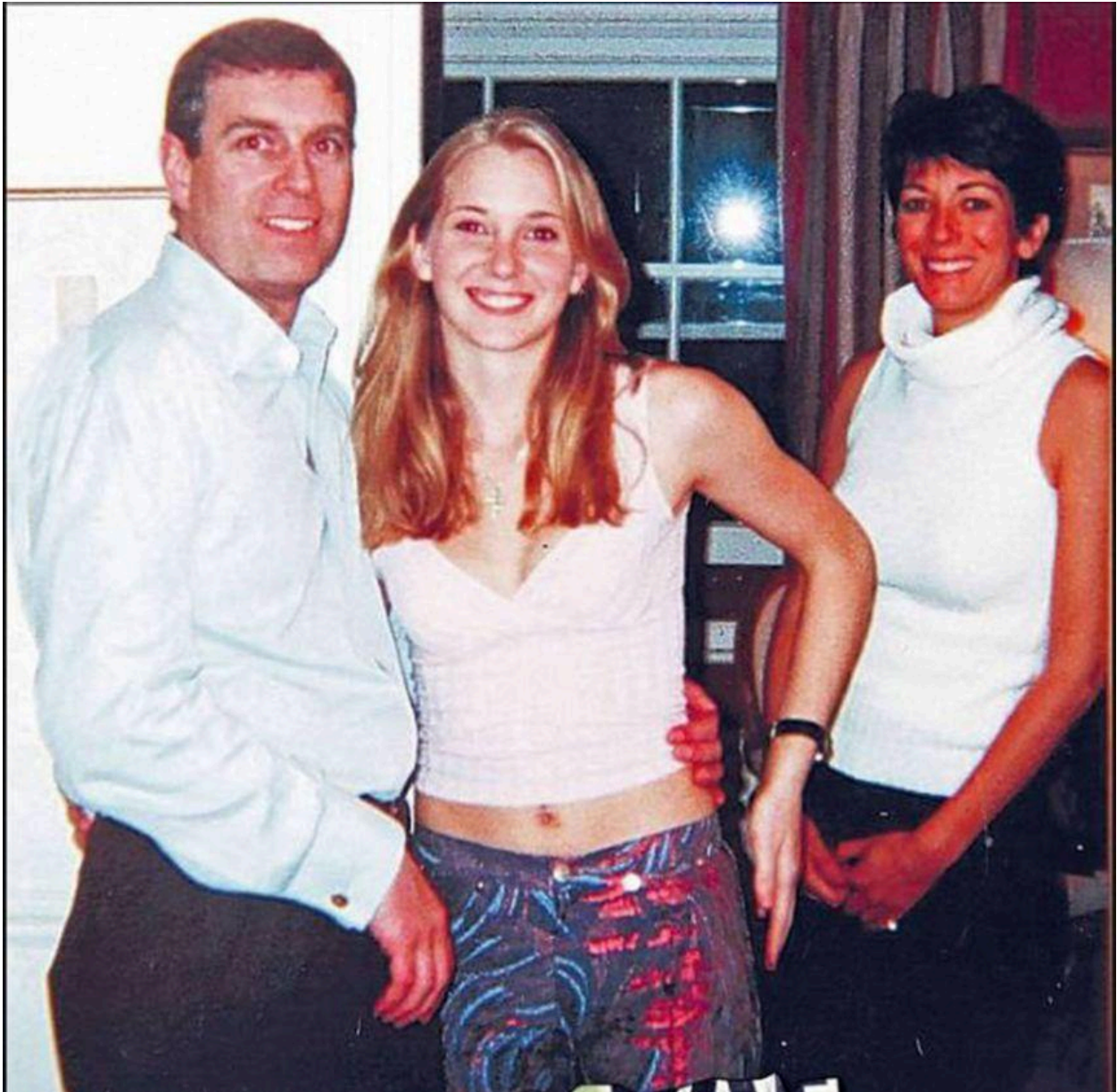

A biography of Andrew, Entitled: The Rise and Fall of the House of York by Andrew Lownie, is released, having been serialised in the Daily Mail. It claimed Andrew and his ex-wife, Sarah Ferguson, had known Epstein for a decade earlier than 1999, when they had said they first met him. The Prince was said to be a "useful idiot" for the financier. According to the book, compromising material on Andrew may allegedly have been passed to Israel's Mossad secret service, Saudi Arabian authorities and Muammar Gaddafi's Libyan intelligence services by Epstein. Compromising material on Andrew may also have ended up in Russian hands, Lownie claims.

Peter Mendelson

Lord Peter Mendelson, 72, was a major figure in the Labour party in the United Kingdom from the 1980s. He played a fundamental and important role in Sir Tony Blair's election victory in 1997. He was most recently appointed as the UK's ambassador to Washington in December of 2024, however, he was fired last September, for his appearance in the released Epstein files.



- Arrested for the same reasons as Prince Andrew, after earlier this month the Metropolitan Police confirmed that it had launched a criminal investigation over allegations of misconduct in office.
- He was previously Labour MP from 1992 to 2004, Secretary of State for Trade and Industry in 1998, European Commissioner for Trade from 2004 to 2008 and Secretary of State for Business and Innovation in 2008 and 2010.
- Met Epstein in the early 2000s.
- In 2002, encouraged Prime Minister Tony Blair to meet Epstein.
- Maintained his relationship with Epstein through the 2008 conviction and beyond.
- Evidence of Mandelson, while serving as Business Secretary, feeding Epstein government intelligence that could be used for financial trading. For example, he emailed Epstein that a 500 billion EU bank bailout was almost complete and should be announced tonight, the night before the announcement.
- In 2009, he updated Epstein on Treasury tax policy changes as they happened.
- Epstein explicitly told Mandelson to give him information “before Jes” (Jes Staley, JPMorgan executive) so that Epstein was the first with insider info. A Cabinet minister was essentially giving a Wall Street-connected sex offender advance notice of major financial policy decisions.
- Directly lobbied on behalf of Epstein’s interests; lobbied the Obama administration in March 2010 to water down US bank trading restrictions on behalf of Epstein and Jes Staley.
