It should not contain any references or displayed equations. The abstract should be no more than 200 words. (one blank single space line, 7 pointfont)

INTRODUCTION

These instructions provide you with a guide to preparing a paper for the JAS Journal guidelines. The manuscript is written in Times Roman font size 12, single spaced, left and right aligned, one page on one side and on A4 paper (210 mm x 297 mm) with a top margin of 1 cm, bottom margin of 1 cm, left and right of 1 and 1 cm.

The manuscript including graphical and tabular content should be between 4 to 10 pages. The manuscript is written in Indonesian. Article titles should be short and informative and should not exceed 12 words. Keywords are written after the abstract. The first letter is written in capital letters and the headings are numbered. Manuscript organization includes Introduction, Research Methods, Results, Discussion, Conclusion and Bibliography. The use of abbreviations is permitted, but abbreviations must be written in full when mentioned for the first time and must be written between brackets. Foreign terms/words or regional words must be written in italics. Notation should be concise and clear and written in accordance with standard writing style. Symbols/signs must be clear and distinguishable, such as the use of the number 1 and the letter 1 (also the number 0 and the letter O). In this manuscript,

Tables are written in the middle or at the end of each text describing research results/acquisitions. If the width of the table is not enough to write on half a page, it can be written on a full page. The table title is written from left to center, all words begin with an uppercase letter, except conjunctions. If more than one line is written in single space (at least 12). For example, you can see table 1.



Why could that happen? Why is the variable trend like that? All these questions must be explained scientifically, not just descriptively, if necessary supported by adequate basic scientific phenomena. Apart from that, it must also explain the comparison with the results of other researchers on almost the same topic. Research results and findings must be able to answer the research hypothesis in the introduction section.

CONCLUSION

Conclusions describe the answer to the hypothesis and/or research objectives or scientific findings obtained. The conclusion does not contain a repetition of the results and discussion, but rather a summary of the findings as expected in the objective or hypothesis. If necessary, at the end of the conclusion you can also write down the things that will be done in relation to further ideas from the research. Next, add limitations and recommendations for further research.

The bibliography must contain reference libraries originating from primary sources (scientific journals and amounting to a minimum of 80% of the entire bibliography) published in the last 10 (ten) years. Citations are arranged and written based on a number system according to the order of citation, following the **Vancouver** citation style. Only references cited in the article are included in the Bibliography. It is highly recommended to use Mendeley Reference Manager by selecting Indonesian as the citation language.
