

## Special Education Teacher Pathway Program Appeal Process Document

---

### SPED Pathway Funding Appeal Process

Participants who receive less funding than originally requested may submit an appeal for reconsideration. Appeals will be reviewed based on program guidelines, available funding, and supporting documentation.

#### Step 1: Submit an Appeal Request

Participants must submit a written appeal within **10 business days** of receiving their funding notification. The appeal should include:

- Participant name and Teacher Prep Provider
- The original funding request amount
- The amount awarded
- A brief explanation of the reason for the appeal
- A letter of support from your building supervisor
- Any additional supporting documentation (updated tuition statement, financial information, course verification, etc.)

Appeals should be submitted to the SPED Pathway Program Success Coach via email.

#### Step 2: Appeal Review

The SPED Pathway grant team will review appeals considering:

- Program eligibility requirements and priority funding group
- Available remaining grant funds
- Documentation provided by the participant
- Equity across program participants

Additional information may be requested if needed during the review process.

#### Step 3: Appeal Determination

Participants will receive a written decision in up to **15 business days** of the appeal submission. Decisions may include:

- Approval of additional funding
- Partial approval if limited funds remain
- Denial if funding is unavailable or the request does not meet program guidelines

#### Important Note

Appeal decisions made by the SPED Pathway grant team are final and subject to available grant funding. Submitting an appeal does not guarantee additional funding. If additional funds become available during the grant cycle, they may be distributed among eligible participants, including those who submitted appeals.
