#### INTRODUCTION (Segoe UI Historic 12, bold)

Articles are written in **Segoe UI Historic font size 12**, **1.15 spacing** and **justify** with **4000-7000 words** in .doc/.docx format. The introduction consists of the background or reasons for the research, supporting theories from several works of literature that become a clear theoretical basis, the formulation of the problem, the purpose of writing and **novelty** of the research. The introduction is written in paragraphs in one chapter without sub-chapters. The article is written in essay form, so no numeric or alphabetical format separates chapters/sections or marks new chapters/sections. For that, if there are parts of the article content that require numbering or bullet lists, make them into flowing paragraphs as follows: (1)..., (2)..., and (3)...

Each citation from the book cited in the text should have the source placed in the bibliography. In-text citations from the book should be written in the format as follows (Author's last name, year). At the same time, citations from online sources should be written in the format (Author's last name/editor/institution, year of posting). Please avoid writing quotes from a second source.

### **RESEARCH METHODS**

The article's research method describes the research type, subject and object of the study, time and location of the research, instrument of the research, sampling method, data collection, and data analysis.

#### **RESULTS AND DISCUSSION**

The study's results describe the main findings, presented systematically, with only the results of data/information related to the research objectives. The discussion in the research article explains the results obtained from the research.

The author compiles, analyzes, evaluates, interprets, and compares the results of the latest findings with current research findings. Therefore, the author must pay attention to the consistency of the article, from the title to the bibliography.

Table and figure **must be mentioned** in the content of the article to refer to the explanation, such as "description of the mapping can be explored in Table 1" or "description of the mapping can be present in Figure 1". Existing tables or figures are presented with sufficient explanations and by including numbers and titles. The number and title of a table are placed above, while the number and title of a figure are placed below. Complete the existing tables and figures by writing the source under each table/figure. The table is created without a vertical border. Figure resolution must high definition so that it looks clear and not blurry.

Avoid using sub-heading in the results and discussion sections. All the results and discussion in the article are written in essay form, so no numeric or alphabetical format separates chapters/sections or marks new chapters/sections.

#### CONCLUSION

The content of the conclusion should be the answer to the question and research objectives. Conclusions are presented in one paragraph, without bullet and alphabetical points. The conclusion chapter should not be expressed in statistical sentences and give suggestion for the future research.

Acknowledgments: In this section, you can acknowledge any support given which is not covered by the author contribution or funding sections. This may include administrative and technical support, or donations.

#### **REFERENCES**

The references are sorted alphabetically, without serial numbers. Merging all sources, including books, online, journal articles, and others. Authors should use **Mendeley, Endnote,** or **Zotero** software to compile the bibliography. The maximum time for reference sources is **ten years (90% of source)**, with the composition of primary referrals (Journals) being more than secondary references (Books).

It has met the minimum number of 20 reference sources, contains at least 50% of English language sources. References should contain at least 80% (16 sources) from journal articles, with minimum 12 sources from international journals.

The references are written using the APA Style, with 12 Segoe UI Historic, and using single space. References are written **without separating the source types**. In addition, see the following examples of technical provisions for writing a bibliography or reference:
