California law requires a 10-day wait between an order and delivery which means, a person only has to wait 10 days after completing a background check.

Waiting period laws have also been shown to reduce gun homicides. One study found that waiting period laws reduce gun homicides by 17%.13 These results suggest that, combined, states with waiting periods avoid roughly 750 gun homicides per year as a result of this policy.14 If all states implemented waiting periods,
