The Israeli military brought 12 charges against Palestinian parliamentarian Khalida Jarrar on 15 April. They will review her eligibility for bail on 29 April but she is also being held under a system allowing indefinite detention without charge which precludes release on remand.

FOUDAMA OUSMANE RECEIVES MEDICAL TREATMENT

Foudama Ousmane, a detainee who was at risk of blindness, was examined by a doctor on the morning of 20 April and prescribed medication for his eyes. This was as a direct result of the mobilization of Amnesty International's members around the world who called and sent emails to authorities in Cameroon, after an Urgent Action was issued on 16 April.

DETAINED HUMAN RIGHTS ACTIVIST RISKS TORTURE
