JSNiedermaier (“we”, “us” or “our”) takes your privacy seriously. This privacy policy (“privacy policy” or “policy”) explains our data protection policy and describes what information we may process, transfer and store when you install “Showroom” on your mobile device (“app”, “application” or “service”). By using this application, you agree to the collection and use of information in accordance with this privacy policy.

Information we collect and why we collect it

1. Bug Reporting

The app is using Firebase Crashlytics (‘Crashlytics’) to monitor the app’s stability.

Information we collect:

- Installation UUID (identifier)
- Crash stack traces

Why we collect it:

Although we strive to ensure a seamless user experience, unforeseen errors may occasionally occur within our app. While it is impossible to anticipate every potential issue across all devices, we utilize Firebase Crashlytics to promptly identify and address any unhandled errors. This enables us to swiftly deploy targeted patches, ensuring optimal performance and minimizing disruptions for our users.

Retention:

Crash stack traces and their associated identifiers are kept for 90 days.

2. Analytics

The app is using Google Analytics ('Analytics') to monitor the app's usage.

Information we collect:

- Number of users
- Session statistics
- Approximate geolocation
- Browser and device information

Why we collect it:

Google Analytics is employed within our app to gather valuable insights into user interactions and app performance. This helps us enhance the user experience by understanding usage patterns, identifying popular and unnoticed features, and pinpointing areas for improvement.

Retention:

Individual user data and associated identifiers are kept for 14 months. Aggregated data such as reports and campaign data are kept without automatic expiration.
