MasonCola Commissions Terms of Service- Digital Portraits

Terms that will be used

- Mason- This is the name of the artist under the names "MasonCola", "sketchymoonlight", and "Duskseeker" [and variation in the last two, such as "sketchy-moonlight" and "Duskseeker_mlp"]
- Client- This refers to the person(s) who wish to commission Mason, who pays Mason in order to get art
- 3. Artwork- This will refer to the work(s) that the Client commissions from Mason
- 4. Commission- This will refer to the act of exchanging currency for goods and services

Reminder: REQUESTS ARE NOT COMMISSIONS; Art that is requested from Mason with no exchange of currency are requests, and will have their own separate terms than Commissions

Before Commissioning (this section has trigger warnings for unsavory words in order to set boundaries)

Please Read Commission Info

Please read the commission information page: All prices on that page are an estimation based upon a median price, prices may vary while discussing commissioning Mason.

What I Will Draw

- a. Anthropomorphic characters, Quadropedic/feral characters, human(oid)s, inhuman characters, animals, furries, monsters, original characters, fan characters, characters from established franchises
- b. Mason can draw in any 2D art style, Must request specific styles if Client wants something different from Mason's Default style(s)
- c. Mason can use different brush styles, Client must Request specific brush styles if they want something different from Mason's default brush usage
- d. Mason can draw sfw [Safe For Work] art, nsfw [Not Safe For Work] art, and suggestive art

Age Rating for NSFW art: Mason will verify Client's age if they ask Mason to draw nsfw art by asking for image(s) of the Client's Identification Card [State Permit, State Driver's License, State ID (and other Cards similar to these), or Birth certificate, with specific additions to the image in order to verify the image's validity. CLIENTS UNDER THE AGE OF 18 WILL NOT BE PERMITTED TO PURCHASE NOT SAFE FOR WORK, TASTEFULLY NUDE, AND KINK ART

- e. Experimental art; If the Client wants something experimental from Mason, or works that are not on Mason's Commission list, prices may be higher than expected.
- f. Kink Art; Mason will draw art of specific kinks if desired

DISCLAIMER: Mason holds the right to decline drawing specific kinks that make Mason uncomfortable

What I Will Not Draw

- a. Racism
- b. Sexism
- c. Pedophilia
- d. Zoophilia
- e. Underage characters in sexual/overly gorey situations
- f. Queerphobia
- g. Animals with no anthropomorphic traits (sentience is an anthropomorphic trait) in sexual/suggestive situations
- h. Proshipping stuff
- i. Ableism
- j. Anything that makes Mason uncomfortable that's not on this list

Revision information

Revision count: Included in base Commission prices are 5 minor revisions (additions and changes to eyes, expression, markings) and 2 major revisions (change in pose, outfit, detailed background, etc); there is some overlap in these categories and will be subject to Mason's discretion what revisions are major or minor. Extra major and minor revisions will be extra based on complexity.

a. Pose changes can be made up to the lineart stage; major pose changes will not be made during lineart stage, but minor pose changes can be made during lineart stage.

- b. Outfit changes can be made up to the lineart stage; the only outfit changes can be made during the lineart stage are socks/gloves, jewelry, and minor details on outfits.
 Shirt/pants/socks/hats/eyewear/headwear/etc, can not be changed after sketch stage.
- c. The only changes that can be made after shading will be changes in shading; NO EXCEPTIONS WILL BE MADE TO THESE RULES

Payment/Refund Information

Mason will start a Client's commission after receiving payment up front. The payment plans that are available are:

- Full payment up Front
- Half payment up front, half payment after flat colors (ALL WORK IN PROGRESS PICTURES IN THIS SECTION WILL BE WATERMARKED)
- One third payment up front, One third payment after lineart, One third payment after artwork is completed (ALL WORK IN PROGRESS PICTURES IN THIS SECTION WILL BE WATERMARKED)

These are the payment types accepted

- 1. [PAYPAL IS CURRENTLY DISABLED AS A PAYMENT METHOD DUE TO PAYPAL'S POOR TREATMENT OF ARTISTS; ONLY USED AS A FINAL RESORT FOR PAYMENT]
- 2. Cashapp
- 3. Venmo
- 4. Virtual Currencies (ie. steam wishlist games, League of legends skins/rp, fortnite content, other game content) [This will only be accepted if no other payment option is available, or if the Client is trusted by Mason]

Refunds can only be done with the main 3 payment types, Here is the amount that can be refunded during the process. When a refund is requested, all work on the Artwork will be stopped and Client will be refunded based on which stage the artwork was stopped on; a png image of the artwork as is will be sent to the Client

- Not started- full refund
- Sketch- 70% refund
- Lineart- 50% refund
- Flat color- 20% refund
- Rendering- no refund available

Refunds will not be given if the reason is the Commission is taking too long; the only exception is if the Client gave Mason a deadline. Deadlines can not be any less than 4 days from commission date.

Mason has the right to decline any commission if the commission or Client are making Mason Uncomfortable
