## **Publicity Standards**

#### **Schedules**

The official website for Section V Athletics - <a href="www.sectionv.org">www.sectionv.org</a> - will always have the latest and most up to date schedules. Each athletic administration office will update their schedules within the rSchoolToday platform and that schedule automatically synchronizes to the Section V website. The home team school is typically responsible for any changes to their schedule. Please contact your athletic director's office with any questions about schedules.

During sectionals schedule data input will be done by:

Team Sports: Higher seeded team.

Individual Sports: Each school is responsible for inputting their own (leave opponent as various schools).

For regionals and beyond it is up to each school to input their own schedule.

#### **Rosters**

All roster submissions can be handled within the rSchoolToday platform. Athletic directors and coaches will have access and can update their school rosters. If your team is a merger of another or many schools not within your own school district, then each school athletic director can update and input their student roster submission from their specific school to form a complete roster. All changes and updates should be taken up with your coach and/or athletic department. What is reflected on the Section V website is from the data they have inputted and can control.

Please note that vendor rSchoolToday Activity Scheduler follows Ed Law 2d and FERPA laws regarding student data. Only data that schools should be inputting online for rosters:

- First Name
- Last Name
- Roster # (if jerseys provided)
- Position (if applicable to activity)
- Grade Level

Anything additional would be specific for a sport or school decision on things like height or weight. Please consult with your athletic director and sport coordinator.

#### Results

All results or scores should be reported immediately following the game by the winning team on the rSchoolToday platform. Coaches will be provided necessary access to do this from their athletic directors. Section V only needs the result of the contest. Any additional reporting of results can be done once rSchoolToday results have been inputted, which should only take a few seconds from Activity Scheduler rSchoolToday Mobile App. Online content managers for each sport will be checking frequently and assisting schools and coaches with getting their input in a timely fashion. This is important to help determine sectional standings as games are inputted.

#### Seedings/Brackets

All team brackets for sectionals will be inputted on Sidearm Sports platform and online content managers will be provided necessary access to update and make changes to each bracket. Seedings and Brackets are declared FINAL at the conclusion of the seeding meeting. (Only exceptions will be if a clerical mistake was made) Brackets will be available as soon as sectional seedings have been finalized. All brackets will then be available on the Section V website as changes are made.

#### Social Media

Please follow the <u>Social Media Policy</u> and all of the official <u>Section V Social Media Accounts</u> that should be utilized to highlight things going on in your specific sport. Another resource is the <u>School-Run Social Media Accounts</u> directory, which is updated as schools provide details.

#### Media

All members of the media can provide their information <u>using this form</u> and Section V will add their information to an online directory for all sports to utilize. Section V encourages all coaches and athletic directors to use this directory to highlight their student athletes. All of our media do a fantastic job of covering high school sports and we must all do our part to help them get the information they need in a timely fashion.

#### **Sport-Specific Publicity Information**

Please notify Pickin' Splinters if you are using GameChanger by emailing <a href="mailto:scores.pickinsplinters@gmail.com">scores.pickinsplinters@gmail.com</a>. The site's staff will use that to build nightly recaps. If your program does not have a GameChanger account, please use the same email to report scores (include details of the game and stat lines).

## **Section V Baseball Seeding**

#### **Click for Seeding Summary Form**

Using the schedules presented to league coordinators by each school:

- 1. Figure your school's positive only seeding points.
- 2. Tabulate the total number of games actually played.
- \*\*3. Divide seeding points by games played. (Divide #1 by #2)

\*\* The minimum divisor of games will be 15 for the 2025 season. If a team does not officially complete 15 games during the regular season their seeding points will be divided by 15. In the event that there are more than two classes within a Classification, the team with the highest index will get the bye. The other 2 teams will play first and the team with the higher index will play the winner on the date indicated. All bracket matchups are final after the seeding meeting is complete, apart from correcting a clerical error. Brackets will not be redrawn after the seeding meeting. If a team drops after the seeding meeting, the match will be treated as a forfeit and the remaining team will advance.

Should ties arise in seeding index, the committee will use the following procedure to break the tie.

- 1. Head to Head to Head (If multiple teams are tied, rank head to head records of teams involved)
- 2. Head to Head
- 3. Overall winning percentage
- 4. League winning percentage
- 5. Coin flip

In a situation where two teams are winless and one has more losses than the other, the team with fewer losses will be considered the higher seed or winner of the tiebreaker.

#### PLUS POINTS FOR WINNING

**6 points** - awarded for winning against a team above your state classification.

**5 points** - awarded for winning against a team in your state classification.

**4 points** - awarded for winning against a team below your state classification.

**Ties** – in the case of a game ending in a tie, and can not be completed at a later date, the points will be split. Every effort should be made to complete the game.

(\*Note that AAA will be treated like AA as far as points are concerned)

## **Required Practices**

Under the NYSPHSAA Sports Standards schools must have 10 team practices before participating in an interscholastic scrimmage, with position players practicing in 10 of the 10 and the battery in 10 of the 10 to be eligible.

## **Scrimmages**

A baseball scrimmage must include free substitutions and lineup cards will not be exchanged. Scrimmages must also include *one or more* of the following:

- 1. Play six (6) outs per half inning (example 3 outs clear the field/3 more outs).
- 2. Batting order must be altered or modified to include more batters than rules permit.
- 3. Start with a runner(s) on base with a predetermined situation for at least two (2) full innings.

## Scheduling

The maximum number of games scheduled and played during the regular season is 20 (excluding sectional games). Individuals may participate in two regulation games per day with at least a 15 minute rest between games. All tournament games - *including southern trips* - count as games towards schedule and final record.

Schedules must be submitted to your league coordinator and be in rSchool by Friday, March 22, 2024. Any games scheduled after Wednesday, April 24 will not count towards sectional seeding.

All contests must be scheduled 7 inning games. Teams scheduling 5 inning games – single or double headers – will result in forfeit for both teams. A league or section may choose whether or not to use the 10 run rule game ending procedure. This does not prohibit an individual school or coach ending a contest prior to its full completion for whatever reason.

Forfeits: Any team that does not accept a make-up date that is reasonable between the 2 teams before the last play date, will be forced to forfeit as determined by the Section V Executive Committee.

This process will be initiated by one school and submitted in writing to the Baseball Coordinator. The Baseball Coordinator will then contact the opposing school/coach. After receiving information from both parties, a decision will be made by the Section V Baseball Executive Committee.

For the purpose of an appeal on any baseball related ruling: The coordinator along with individual(s) from the baseball committee will hear the appeal and make an additional ruling.

The last play date is Tuesday, May 20, 2025. Any games played after May 20 will not count towards sectional seeding.

## Suspended Game During Regular Season Play

- 1) An official game is 5 innings or 4 and one-half if the home team is ahead. If a winner can be determined and no more baseball can be played that day, the game is over and a winner is declared. The game does not have to go 7 innings.

  \*\* This does not apply to the 2nd game of doubleheader.
- 2) If a game is stopped before it becomes an official game, the game is a suspended game. This game will be picked up at that point. Score, inning, count of batter etc. should all be recorded in the scorebook.
- 3) If the game is stopped after having gone long enough to be an official game, however a winner cannot be determined due to a tied score, this game becomes a tied/suspended game at that point. This game will be picked up at that point. Score, inning, count of batter etc. should all be recorded in the scorebook.
  - 4) If a game is stopped after having gone long enough to become an official game and;
- a) The visitors score a run or runs in the top half of the inning. The game reverts back to the last completed inning and either a winner is declared or we have a tied/suspended game. Or,
- b) The visitors score a run or runs in the top half of the inning and the home team does not complete their at bat. The game reverts back to the last completed inning and either a winner is declared or we have a tied/suspended game. If we have a tied/suspended game we pick up from that point (visitor's runs in the top half of the inning and home team runs in bottom half count). This game will be picked up at that point. Score, inning, count of batter etc. should all be recorded in scorebook.
- c) The home team ties the game in the bottom half of the inning but doesn't complete the inning. If we cannot play anymore we have a tied/suspended game at that point. This game will be picked up at that point. Score, inning, count of batter, etc., should all be recorded in scorebook. Or,
- d) The home team takes the lead in the bottom half of the 5th or 6th inning, then game is called. At that point the home team is declared the winner.

#### **Protest Procedure**

Judgment calls by officials cannot be protested. If the head coach would like to protest the misapplication of a sport specific rule, the protest must be made immediately to the game official prior to resuming play. Once play resumes, any protest is null and void. Per NYSPHSAA, in any case, video may not be used to overturn an official's decision.

## **Playing Sites**

In every round before the semi finals - 75 miles will be the maximum one way mileage when there is school for either school the next day. The home team has the financial responsibility if an alternate site is used. In cases where there is no school the next day for either school, and the mileage exceeds 75 miles, the game will be played at the higher seed. (See Section V Mileage Policy) The visiting team may petition the sports committee to play the following day. The final decision will rest with the committee. (As approved by Section V, all sports will use <a href="http://www.mapquest.com/">http://www.mapquest.com/</a> as the official guide for mileage distance.)

All Final and Class Play-off games will be scheduled at neutral sites assigned by Section V Baseball. If pre-determined sites are set for the semi's, finals, or the class play-offs, the site will be changed if the host school is playing. No team will be allowed to host a final or class play-off game in which they are playing. No teams will be allowed to practice on neutral site game sites before the game is to be played.

Playing fields are designated by the Section V Baseball Coordinator and his/her committee. Whenever possible, the fields are chosen with respect to **CONDITION OF FIELD, CENTRAL LOCATION, AND ADDITIONAL FACILITIES AVAILABLE AT FIELD** (fences, bleachers, rest rooms, etc.).

It should be understood that a central location between competing teams may not always be possible.

No game site will be changed unless exceptional circumstances arise. The final decision will be made by the Section V Baseball Coordinator.

<u>Field Requirements for Semifinals and Beyond</u>: MINIMUM PLAYING FIELDS DIMENSIONS must include an outfield fence and must be 290' down the lines, 350' in center, and the backstop will be a minimum of 25' from home plate. Playing field must be in acceptable condition and present no safety risks. Field condition determined by committee.

Pitchers mound must be at reasonable height. ANY game that the higher seed is not playing home for a game before the finals (for whatever reason) it is THEIR RESPONSIBILITY to secure another site. They are also responsible for game management: Supervisors, tickets, etc... Keeping in mind that admission needs to be charged. Section V pays for supervisors, ticket takers and umpires. If a concern arises, the Baseball Executive Committee makes the final decision on whether a playing site is playable or not.

## 2025 Tournament Information

**Tournament Dates** (Rain Date – 1<sup>st</sup> next day.)

All Tournament Games are played under Federation Rules. No deviation from Federation Rules will be allowed (exception - suspended games). All Umpire Associations have been instructed to adhere to the points of emphasis in this year's rulebook. All coaches must be in uniform. Coaches not in uniform must coach from the dugout and can only enter the field of play for injuries and to make substitutions.

The higher seed will be the **home team for all rounds** (excluding the Class Play-offs). At all **neutral site** games the home team will be assigned the 1<sup>st</sup> base dugout. The visiting team will warm-up first and the home team second. Each team will have a <u>ten-minute</u> warm-up period in all rounds except the finals. Each team will supply at least three (3) new baseballs for each contest.

Teams will have a 15 minute warm-up period for the finals. Baseballs will be provided for the finals.

During a Sectional Game, if there is a question about a rule that was possibly misapplied, the team's coach shall inform the umpire at the time of the play and before a pitch to the next batter of either team, or before the umpires leave the field if the play in question was the last play of the game. If a protest is called, the game is to be stopped and Jason Bunting, Section V Coordinator, or his designated alternative, is to be contacted at 585-739-2521 for a rules interpretation.

In the **Class Play-offs** a coin toss will determine the home team. The home team will also be assigned the 1<sup>st</sup> base dugout. The visiting team will warm-up first. The supervisor will allow each team **ONLY** a <u>ten-minute</u> warm-up period on the field.

Unless agreed upon by both schools the earliest weekday afternoon games will be scheduled is 5:00 P.M. and the latest night games will be scheduled is 7:00 P.M. If games have to be scheduled on non-school days, earlier starting times may be used with agreement of both teams.

Teams making it to the final round should bring four (4) copies of their team roster to the game.

## **Postponements**

Games will be postponed ONLY if:

- 1. Participating schools are officially closed
- 2. Because of weather
- 3. An emergency situation arises

In the event of a postponement, the game site supervisor will notify:

- 1. The teams
- 2. The umpires' assignor from local association
- 3. Section V Baseball Coordinator

If the postponement involves a neutral site game in rounds 1 & 2 and results in moving the game to a day in which the traveling team does not have school the next day the game will be played at the higher seed.

## **Suspended Games During Sectional Play**

In the Sectional Tournament all games are played to completion. If a game is stopped before it becomes a completed 7 inning game, the game will be picked up at that point. Score, inning, count of batter etc. should all be recorded in the scorebook.

## **Conflicts in Sectional Playoffs**

If conflicts occur the date of the scheduled game will not be changed. If both schools agree the start time can be adjusted. The Section V Baseball Committee has set the following policy in regard to changing the start time of a Section V Baseball Tournament contest:

- 1. Section V Baseball Coordinator is notified by the school requesting the change in time.
- 2. The school requesting the change shall take the responsibility of calling all parties involved, and making arrangements for the change.
- 3. Both schools' administrators and coaches agree to a change.
- 4. The time is changed with adequate time to notify game officials, media, sites, etc.
- 5. Section V Baseball Committee is agreeable to the change, after all arrangements are made.

## **NYSPHSAA Thunder & Lightning Policy**

(Revised 10/20/08)

#### Applies to regular season through NYSPHSAA Finals:

Thunder and lightning necessitates that contests be suspended. The occurrence of thunder and/or lightning is not subject to interpretation or discussion - thunder is thunder, lightning is lightning.

- a) With your site administrator, set up a plan for shelter prior to the start of any contest.
- When thunder is heard and/or when lightning is seen, the following procedures should be adhered to:
- b) Suspend play and direct participants to go to shelter, a building normally occupied by the public or if a building is unavailable, participants should go inside a vehicle with a solid metal top (e.g. bus, van, car).
- c) Do not permit people to stand under or near a tree; and have all stay away from poles, antennas, towers and underground watering systems.
- d) After thunder and/or lightning have left the area, wait 30 minutes after the last boom is heard or strike is seen before resuming play or competition.

#### **Duties of the Coach**

Submit a completed schedule to your league chairperson by Friday, March 28, 2025. See *Duties of Athletic Director* for more information.

Submit a completed roster into rSchoolToday by Friday, March 28, 2025

When you win a game during the regular season, report the score into rSchool asap. With full cooperation, up to date records, points, and seeding index will be posted on the Section V Website in real time. Use the Seeding Summary Form to keep accurate information throughout the season. At the conclusion of the regular season this form should be given to your league chair prior to the Seeding Meeting on Friday, May 19.

Teams playing schools outside Section V, the coach is responsible to contact that school and get accurate BEDS numbers for the Seeding Summary sheet.

The winning coach must call the class coordinator immediately following the game.

**Automated External Defibrillator (AED)**: It is each school's responsibility to have an AED available at neutral site games. Schools should contact each other, or the host school, to confirm that an AED will be available at the site.

The **coach** is directly responsible for the conduct of his/her team. The coach is the official school representative on the playing field. Please read Section V Sportsmanship Policy.

Apply the NYSPHSAA Thunder and Lightning Policy as listed in this handbook.

All coaches must be in uniform. Coaches not in uniform must coach from the dugout and can only enter the field of play for injuries and to make substitutions.

Teams making it to the final round should bring four (4) copies of their team roster to the game.

Each team will supply at least three (3) new baseballs for each contest.

#### **Duties of the Athletic Director**

Submit a completed schedule to your league chairpersons by **Friday, March 28, 2025**. No new games may be added after Wednesday, April 26 which would count for sectional seeding points. (Except for sectional tournament games, all tournament games - *including southern trips* – count as games towards schedule and final record.) **According to the NYS Baseball Committee all games must be scheduled 7 inning games**. Teams scheduling 5 inning games – single or double headers – will result in forfeit for both teams. A league or section may choose whether or not to use the 10 run rule game ending procedure. This does not prohibit an individual school or coach ending a contest prior to its full completion for whatever reason.

In **sectional play** if circumstances result in which a game may need to be changed follow the policy established by the Section V Baseball Committee.

**Automated External Defibrillator (AED)**: It is each school's responsibility to have an AED available at neutral site games. Schools should contact each other, or the host school, to confirm that an AED will be available at the site.

Inform your coaching staff of the NYSPHSAA Thunder and Lightning Policy as listed in this handbook.

At all neutral sites the **athletic director** of each participating school is to provide at least one supervisor at the game site. A supervisor may be an administrator, athletic director, or teacher. The supervisor should be responsible for his/her school's crowd.

## **Duties of the Section V Baseball League Chairpersons**

Collect completed schedules from each team in your league by **Friday, March 28, 2025**. Send a copy of each schedule to Section V Baseball Coordinator. No new games may be added after this date which would count for sectional seeding points. (All tournament games - <u>including southern trips</u> - count as games towards schedule and final record.) **According to the NYS Baseball Committee all games must be scheduled 7 inning games**. Teams scheduling 5 inning games – single or double headers – <u>will result in forfeit for both teams</u>. The final date for scheduled games to be played and count towards seeding points is Thursday, May 18.

Inform coaches in your league that when they win a game during the regular season, report the score into rSchool asap. Have the coaches use the <u>Seeding Summary Form</u> to keep accurate information throughout the season. At the conclusion of the regular season get a completed Summary Form from each coach in your league and bring it to the Seeding Meeting on Friday, May 19.

#### Attend the Seeding Meeting

Collect a completed Seeding Summary Form for each team in your league. Bring these totals and individual game scores for each team, with their league and overall record. At the conclusion of the meeting inform each team in your league of the time, date, site, and opponent of their first round game.

At the end of the season remind coaches in your league to nominate players on their team worthy of all-state consideration. Completed all-state nomination forms should be turned into the league chair prior to your year end meeting. Nomination forms can be obtained from each league chair.

Notify coaches in your league to be familiar with all information in the Section V Baseball Handbook.

## **Duties of the Section V Baseball Class Coordinators**

#### SECTION V BASEBALL TOURNAMENT:

- Attend the Seeding Meeting. Collect the Seeding Summary Form from the League Chairpersons for each team in your Class. Tabulate the official brackets for your Class, determining the first round games, sites, and times. League chairpersons will notify teams of their first round games. Class coordinators will notify the teams in their Class of all games after the first round.
- 2. At the conclusion of each Sectional Tournament game the winning coach is to call their class coordinator with the results. Each class coordinator is to report this information (winner and score) to the Section V Baseball Coordinator.
- 3. With committee coordinator, determine sites and times for the next round of games.
- 4. Inform teams in your Class of the date, time, site, and opponent for the next round of games.

## **Duties of the Game Site Supervisor**

The game site supervisor will make him/herself accessible and visible to coaches, school administrators, and game officials at all times.

**Automated External Defibrillator (AED)**: It is each school's responsibility to have an AED available at neutral site games. To assure that an AED is available the site supervisor should contact the participating schools to confirm that an AED will be provided by one of the teams, or the hosting site.

The site supervisor will apply the **NYSPHSAA Thunder and Lightning Policy** as listed in this handbook.

He/She will have the playing field in the best possible condition. He/She will go over all ground rules with the coaches and officials before the game begins.

The higher seed will be the **home team for all rounds** (excluding the Class Play-offs). At all **neutral site** games the home team will be assigned the 1<sup>st</sup> base dugout. The visiting team will warm-up first and the home team second. Each team will have a <u>ten-minute</u> warm-up period in all rounds except the finals. Teams will have a 15 minute warm-up period for the finals.

In the **Class Play-offs** a coin toss will determine the home team. The home team will also be assigned the 1<sup>st</sup> base dugout. The visiting team will warm-up first. The supervisor will allow each team **ONLY** a <u>ten-minute</u> warm-up period on the field.

He/She will supervise ball chasers, ticket sellers, and all other personnel necessary for the contest to be completed.

He/She will administer to any unsportsmanlike spectator actions. In the event that the site supervisor is not present, the home team coach will assume responsibilities (per Section V Sportsmanship Guidelines).

The **coach** is directly responsible for the conduct of his/her team. He/she is the official school representative on the playing field. Please read Section V Sportsmanship Policy.

The **athletic director** of each participating school is to provide at least one monitor at the game site. A monitor may be an administrator, athletic director, or teacher. The monitor should be responsible for his/her school's crowd.

## **Section V Baseball Umpire Information**

Umpire assignments will be made by the Section V Baseball Coordinator. He shall delegate the assignment responsibilities to the Chapter Assignor for the site where each game is to be played.

#### PROCEDURES FOR ASSIGNING BASEBALL OFFICIALS FOR POSTSEASON.

- 1. For the first two rounds, if both opponents are serviced by the same officials organization, that organization will provide the necessary officials.
- 2. In the first two rounds, if the opponents are serviced by two different organizations, the official's organization that services the higher seed will provide officials for the contest.
- 3. In the semi's, finals and class play-in games a neutral site will be used. A neutral official's organization will officiate the contest if the opponents are generally serviced by different organizations. If the opponents playing at a neutral site are generally serviced by the same organization, that organization will officiate the contest.

All umpires are to wear official attire as sanctioned by their organization.

Every umpire shall have equipment to work behind the plate with him/her at all tournament games.

In case of inclement weather, assigned umpires should call the game site to check on status of game.

Umpire fees for the tournament shall be according to the Officials/Section V Agreement.

Semi Final, Final, and crossover games will have three (3) person umpire crews assigned by the Section V Baseball Committee.

Western Regional Games will have 3 umpires.

## **Section V Sportsmanship Policy**

The Section V Athletic Association is committed to promoting the proper ideals of sportsmanship, ethical conduct and fair play at all sectional activities. We will oppose instances and activities which run counter to the best values of athletic competition in order to ensure the well being of all individual players. We will expect acceptable standards of good citizenship and propriety with proper regard for the rights of others.

We are further committed to the belief that schools participating in sectional activities should be held responsible for the conduct of their players, coaches, faculty members, and spectators. Conduct which is detrimental to the educational value of athletic activities may be deemed just cause for the school's reprimand, probation, suspension from a particular sport, or suspension from sectional activities.

Eye black has been a staple in the sport of baseball since the 1930s. Originally, the first introduction of eye black was a grease substance made out of beeswax, paraffin and carbon to help players reduce glare from the sun. It has evolved to a less messy version as a plastic sticker placed under the eye socket that does not run when wet from perspiration or soils the uniform. The grease version of eye black is now being used as a face decoration. Images and/or sayings are being drawn on the faces of the players to try to intimidate and/or taunt an opponent. There are existing sportsmanship rules available to mitigate any use of eye black (in any version) in an inappropriate or unfavorable way.

For all schools in Section V; one (1) stripe of eye black under the eye is what will be permitted during the regular season and post season.

## **Spectator Code of Behavior/Ethics**

It is the responsibility of the spectator to:

- 1. Keep cheering positive. There should be no profanity or degrading language/gestures.
- 2. Avoid actions which offend visiting teams or individual players.
- 3. Show appreciation of good play by both teams.
- 4. Learn the rules of the game in order to be a better informed spectator.
- 5. Treat opponents in a manner in which you would expect to be treated.
- 6. Accept the judgment of coaches and officials.
- 7. Encourage other spectators to participate in the spirit of good sportsmanship.
- 8. Avoid the use, abuse and the resulting negative influence of drugs, including alcohol and tobacco.

#### Section V Motto

- 1. Be Loud
- 2. Be Proud
- 3. Be Positive

## **Student Athletes Code of Behavior**

It is the responsibility of the student to:

- 1. Demonstrate self-control and respect for officials, spectators and opponents.
- 2. Remember that participation in athletics is a privilege and not to be abused by unsportsmanlike conduct.
- 3. Shake hands with opponents after the competition and congratulate them on their performance.
- 4. Respect the integrity and judgement of the officials.
- 5. Remember that improper behavior while in uniform reflects poorly upon yourself, your family, your school and your community.
- 6. Understand and abide by the rules and regulations of the game.
- 7. Accept victory with grace and defeat with dignity.
- 8. Remember that the use, abuse and the resulting negative influence of drugs, including alcohol and tobacco, is detrimental to the game and its participants.

## Coach's Code of Behavior

It is the responsibility of the coach to:

- 1. Promote good sportsmanship by setting a positive example while coaching your athletes.
- 2. Respect the integrity and judgment of the sports officials.
- 3. Approach competition as a healthy and constructive exercise, not as a life and death struggle that requires victory at any price.
- 4. Recognize that the participants in individual or team sports are young men and women with human frailties and limitations who are capable of making mistakes.
- 5. Refrain from the use of crude or abusive language with players, opponents, officials or spectators.
- 6. Instruct the players in the elements of good sportsmanship and remove players from competition who demonstrate unsportsmanlike behavior.
- 7. Avoid behavior that will incite players, opponents or spectators.
- 8. Avoid and eliminate negative comments to radio, TV and newspaper reporters.
- 9. Avoid the use, misuse and negative influence of drugs, including alcohol and tobacco.

- 1 If a pitch is thrown on a balk call, the pitch will NOT count for the purposes of this rule
- A pitcher at any level who reaches the pitch count limit in the middle of an at-bat will be allowed to finish that hitter. Thr number of nights rest is determined by the actual number of pitches thrown.
- 3 Schools will have the responsibility to maintain all pitching charts. They will also be required to make any game chart available to any school prior to any game to show availability of pitchers for that given day.
- During games each team will record pitch counts on the official NYSPHSAA pitch count form, this should not include warm-ups or pick off attempts. After each half inning the pitch counts will be confirmed by both teams. Any discrepancy will be resolved based on the records of the home team pitch count chart.
- At game's conclusion, the NYSPHSAA pitch count form will be signed by both head coaches or designated representative.
- Any violation of this rule will be considered in the same light as a school using an ineligible player. The game will be forfeited.
- 7 As per the NYSPHSAA handbook any additional penalties may be imposed at the school or section level.
