



Do You Know This About The New COVID-19 Vaccine?

MODerna vaccine = Modify + RNA. 45 humans made up the phase 2 trial. A high dose produced 100% of people having negative side effects. The low dose group: 80%. Short-term studies with ferrets resulted in the animals having poorer health, increased cancer rates, mutagenesis, autoimmune reactions and inflamed lung tissue + liver problems. The delivery system is microneedles via a bandage. This bandage will deliver the patented “LUCIFERase” enzyme, via a hydrogel, that delivers synthetic RNA/DNA and, once stable, genetically modifies the human genome. Additionally, it deposits a bioluminescent marker - making the recipient detectable for the vaccine. The hydrogel, a DARPA invention, contains AI (Artificial Intelligence) to monitor, store, and track your health information.

Pfizer's AstraZeneca Vaccine is rDNA molecules, or recombinant, meaning molecular cloning/recombining. Pfizer's questionable history includes a notable pay out over the biggest fraud settlement in US history in 2009. During Phase I/II trials in the UK caused more than 50% of participants to experience adverse events. Global Alliance for Vaccine Initiative (GAVI), a public-private partnership founded by the Bill & Melinda Gates Foundation, plans to distribute AstraZeneca globally.

AstraZeneca uses MRC-5. Listed as a vaccine excipient, it is the name given for the human diploid cells derived from the lung tissue of an aborted 14 week gestational baby boy. UK regulators have issued a warning that people who have a history of “significant” allergic reactions should not currently receive the Pfizer/BioNTech Covid-19 vaccine.

With 7.5 billion people globally about to rely on one 160 person Pfizer clinical trial (see TheHighwire.com Episode 192 for trial participant breakdown) not only does it lack statistical power; most would consider it reckless. If the present COVID-19 vaccine clinical trials eventually lead to full licensure, yet do not statistically significantly establish prevention of person-to-person transmission, they should not be used to justify [mandated](#) vaccinations in order to [board a plane](#), [go to work](#), [attend a concert](#) or eat at a restaurant. Do You Know Vaccines... May Not Align With Your Ethics?



Aborted babies are harvested and exploited for biomedical research. One university alone, for vaccine studies, put in over 4,400 requests for fetal tissue.

Dr. Stanley Plotkin admits, under oath, that for one of the many vaccine studies he was a part of, they used 76 aborted babies. Additionally, he admits to using the “undesirables” of the population for experimentation.

Dr. Theresa Deisher - Stanford PHD, holds 23 patents, and was the first to discover adult cardiac stem cells. She explains that in order to collect coveted fetal heart tissue, a baby must be living for the extraction to be viable.

MRC-5 is the name of a *14 week* gestational baby boy and **WI-38** is a *14 week* gestation baby girl - both are commonly listed as ingredients in your vaccines. **WALVAX** is a *3 month* gestational female who was ultimately selected from among 9 aborted BABIES. They further noted how they induced labor using a “water bag” abortion to shorten the delivery time and PREVENT THE DEATH OF THE FETUS to ensure LIVE intact organs which were immediately sent to the labs for cell preparation.

Other baby names used in vaccine package inserts are **IMR-90** and **HEK293**, **WI-26**, **WI-38**, **MRC-5**, **VA4 - RDNA**, **HEK-293**, & **RA273**. Look at the [excipient](#) list for the scientific names of human children used to produce the vaccine.

The US government has known about the dangers of human DNA from aborted fetal cell-lines since, at least, 2005. Set guidelines are supposed to limit the amount of DNA, hypothesizing it will not cause cancer. There is no monitoring of vaccines to ensure those limits are adhered to. Vaccines (MMR, Varicella, and Hepatitis A) were sent for independent analysis and have consistently shown levels of human fetal DNA that are far beyond the “established safety limits.”

Vaccines are not tested against a true placebo. Another vaccine or a solution containing aluminum is often used so the side effects of the two groups are similar; thus, swaying the numbers.
