We may collect the data including but not limited to:

behavioral usage of the App.

device identifiers (such as IDFA, IDFV for Android, GAID for IOS).

email address.

the type and operator of network (such as Mac address).

the type, version, brand, language and operating system of device.

Article 3 **How we use personal data**

We may use the data for the following purposes:

To provide and maintain the Service; to improve the Service; to develop new features, apps, or services.

To communicate with you, including via email, about your use of the Service, to send Service updates; to respond to your inquiries; to keep you informed information we think may interest you.

To monitor and analyze usage and activity trends; and for other research, analytical, and statistical purposes.

To protect the safety, rights, property, or security of us, the App, any third party, or the general public.

To comply with applicable legal or regulatory obligations; to respond to a subpoena, warrant, court order, or other legal process.

Article 4 **Who will we disclose your data to**

We do not share or disclose your personal data to third parties except as set forth below:

Our business partners for the purposes of providing you with Service.

Governmental entity if legally required to do so.

Article 5 How long do we store your data

We endeavor to retain personal data in accordance with applicable law. We will keep your data for the minimum period necessary for the purposes set out in this Statement, namely (1) for as long as you are a user of our App; or (2) for as long as your data is necessary in connection with the lawful purposes set out in this Statement; (3) for as long as is reasonably necessary for business purposes related to provision of the Services; or (4) for as long as is reasonable necessary to resolve disputes, establish legal defenses or conduct audits.

Article 6 How we protect your data

We provide reasonable technical, administrative, and physical controls to secure the confidentiality, integrity, and availability of personal data. We train our employees who handle personal data to respect the confidentiality and sensitivity of your personal data. We may not be accessed, disclosed, altered, or destroyed by breach of any of our industry- standard physical, technical, or managerial safeguards.
