Usage and Collection of Information

We know you care about how your data is utilized and we consider your security important. Please read the following to learn more about how we use your information, what type of information and for which purposes. We will only collect information personal and non-personal where it is reasonably necessary to do so for the conduct of our business. We may collect information regarding your use of our software, applications and/or services, including information about the duration of your use, the features you use and your interactions with other users of the software, applications and/or services.

Game Data Collection:
