RULE 1: IRRESPONSIBLE CONDUCT

- 1F ISSUANCE OF RESTRAINING ORDER
- 1G ENGAGING IN CRIMINAL ACTIVITY
- 1H POSSESSION OF WEAPON(S)/ CONTRABAND

RULE 2: FAILURE TO NOTIFY PO WITHIN 24 HOURS OF NEW ARREST

RULE 3: FAILURE TO FIND AND MAINTAIN LEGITIMATE EMPLOYMENT

RULE 4: ASSOC. W/PERSONS W/CRIMINAL RECORD
