This award is for companies that fulfil the criteria for small and medium enterprises as defined by the MSMED Act, 2006 will be considered under this segment

- Manufacturing Enterprises and Services Enterprises across varied sectors
- Preference would be given to companies with Social Responsibility and Innovation
- The enterprise must be a for-profit business
- The enterprise must be in existence in India for a minimum period of 2 years at the time of application and maximum of 5 years
- The enterprise must disclose audited financial statements for the past 2 years for the purpose of screening and follow-up application
