

TERMS OF SERVICE

Effective Date: 01.01.2026

Welcome to ANDA. These Terms of Service ("Terms") govern your access to and use of the ANDA mobile application ("App"). By downloading, accessing, or using the App, you agree to be bound by these Terms.

If you do not agree to these Terms, please do not use the App.

1. DESCRIPTION OF THE SERVICE

ANDA is a yoga and meditation application that provides:

- Guided meditations based on mood and time
- Silent meditations with background sounds and timers
- Guided yoga sequences
- A yoga pose library and sequence builder
- Information about yoga poses
- Monthly yoga and meditation goal tracking

ANDA is intended for personal, non-commercial use only.

- Subscriptions are managed through the App Store
- You can cancel anytime via your App Store account settings
