

Travel Planning with Lauren

Terms and Conditions

This TRAVEL AGENCY AGREEMENT ("Agreement") is made effective as of the date of the last signature below ("Effective Date") between Lauren Williams, doing business as Travel Planning with Lauren, and the Traveler ("you" or "Traveler"). By engaging Travel Planning with Lauren ("Company"), you agree to the terms outlined below.

Use of Travel Planning with Lauren Services, Access, and Information for Travel Bookings

- 1. Legal Authority**

You warrant that you are at least 18 years of age and possess the legal authority to enter into this Agreement and make travel bookings with Travel Planning with Lauren. You agree to be financially responsible for all travel bookings made on behalf of yourself and any member of your traveling party and warrant that all information supplied by you is true and accurate.

- 2. Booking Integrity**

You agree to make only legitimate reservations or purchases with Travel Planning with Lauren and its Suppliers. Speculative, false, or fraudulent reservations are prohibited.

- 3. Supplier Terms and Conditions**

All bookings are accepted by Travel Planning with Lauren as an agent for the travel Suppliers on your itinerary. Separate Supplier terms and conditions will apply to your reservations, and you agree to abide by them.

- 4. Independent Contractor Status**

Travel Planning with Lauren is an Independent Contractor of Carry on the Magic, *Fla. Sellers of Travel Ref. No. ST43254 | Wash. Sellers of Travel UBI: 604885916 001 0001 | CA Sellers of Travel Ref. No.: 2158540-50*. Registration as a seller of travel does not constitute approval by the State of California.

Payments and Cancellations

- 1. Payment Responsibility**

You are responsible for all charges, fees, duties, taxes, and assessments arising from your travel bookings through Travel Planning with Lauren. By submitting a credit card authorization, you allow the Company to use your payment method to purchase travel products on your behalf.

- 2. No Chargebacks**

Except in cases of fraud, you agree not to file disputes with your bank or credit card

company to avoid Supplier terms and conditions, including cancellations or changes beyond the control of Travel Planning with Lauren or its Suppliers.

3. Cancellation Penalties

All payments for travel are due before departure according to Supplier terms.

Cancellation requests must be sent to lauren@carryonthemagic.com. Cancellation penalties, including fees charged by Suppliers, will apply and may be deducted from refunds or charged directly to your payment method.

Travel Documents, Including TSA and DHS Acceptable Identification Requirements

1. Responsibility for Documentation

It is your responsibility to obtain and carry valid passports, visas, and any other required documents. Identification must match the information on your booking records exactly.

Failure to comply may result in denied boarding or delays.

2. Review of Travel Documents

Upon receipt of travel documents, you are responsible for verifying all information for accuracy and contacting Travel Planning with Lauren immediately if corrections are required.

3. Passport and Visa Requirements

Certain destinations require passports to be valid for six months beyond your return date. Non-U.S. citizens may need additional documentation. Travel Planning with Lauren is not responsible for denied entries or lost payments due to documentation issues.

Health, Immunizations, and Travel Safety

1. Health Precautions

You must obtain necessary immunizations and health screenings before travel and carry valid documentation. Travel Planning with Lauren is not responsible for verifying health or vaccination requirements.

2. Destination Risks

Travel to certain destinations may involve greater risks. The Company recommends reviewing travel advisories and safety information through resources like the U.S. State Department and CDC.

Air Travel, Schedule Reconfirmation, and Check-in

Limitations of Responsibility and Disclosure

1. **Supplier Relationships**

Travel Planning with Lauren acts solely as a booking agent for Suppliers and is not the source of any travel service. You consent to the use of Suppliers for the services booked.

2. **No Liability for Suppliers**

The Company is not liable for actions, errors, or omissions by Suppliers, including delays, cancellations, injuries, or losses resulting from their services.

3. **Limitations of Liability**

Any liability is limited to the commissions and fees received by Travel Planning with Lauren for the booking.

Risks and Safety

1. **Advisories**

Travel Planning with Lauren encourages Travelers to stay informed about safety and health conditions at their destinations through official government websites and advisories.

2. **Assumption of Risk**

Participation in travel activities constitutes acceptance of potential risks associated with those activities.
