## Unofficial (Grassroots) Draft Core Founding Documentation of Your Party UK

## 1. Political Statement (The Vision)

Your Party UK rises now to reclaim the public's inalienable right to govern its future. Our political culture has long privileged party bosses, narrow elites, and electoral choreography; local communities are unheard, Members have no real input, and Westminster politics has lost both legitimacy and knowledge.

We are changing that by making **Deliberative Democracy Assemblies (DDAs)** the highest decision-making power in our movement—and, through winning seats in local councils and Parliament, the avenue by which citizens' considered judgments directly shape law and policy.

We will contest local council seats in the next election cycle, pledging that every councillor we elect acts purely as a **DDA Delegate**. At our **second national conference in April 2026**, preceding the UK Local Elections, we will finalise and ratify this new institutional architecture.

Transparency is non-negotiable: every deliberation, every mandate, every expert briefing will be openly published. Only when the full process is visible can trust be built, corruption avoided, and citizen agency guaranteed. Your Party UK is not about personalities, it is about you, deliberating, choosing, and acting together.

## 2. Constitution (The Structure)

#### **Article I: Supremacy of Deliberative Democracy Assemblies (DDAs)**

All strategic, policy, and mandate decisions of Your Party UK are made by properly constituted DDAs. Elected officials (councillors or MPs) and Executive Stewards are bound by these mandates and must publicly report compliance or explain deviations.

#### Article II: Sortition, Tiered Assemblies, and Local Government Strategy

- a. Local Ward DDAs hyperlocal policy & council mandates.
- b. **Regional/Constituency DDAs** multi-ward issues and devolved powers.
- c. **National DDA ("Grand Assembly")** UK-wide, setting policy for national/sovereign powers (e.g. foreign, defence, taxation).

Selections are by stratified random sortition to ensure age, gender, ethnicity, region, and socio-economic representation.

#### **Article III: Executive Stewards and Elected Delegates**

- **Executive Stewards**: 12-month term; manage legal compliance, finances, and logistics; no policy power; recallable by 70% of the relevant DDA.
- **Elected Delegates**: councillors and MPs must sign the **Delegate Covenant**, committing to follow DDA mandates, with defined emergency deviation rights.

#### Article IV: Legal Fit with Elected Office Requirements

- MPs and councillors are personally responsible for votes under UK law.
- Delegates must seek the DDA mandate before voting, unless prevented by urgent statutory/procedural circumstances.
- Any deviation must be logged **immediately** in a **Deviation Log**, with explanation.

#### **Article V: Transparency and Accountability**

 All Information Packs, deliberation transcripts, attendance, votes, justification logs, finances, and Steward actions are published by default, subject only to lawful confidentiality.

#### Article VI: International Deliberative Assembly (Int'l DDA)

- Formed by National DDA alumni.
- Mandated to research, deliberate, and hold cross-border online assemblies on violent conflict, peacebuilding, and human rights.
- Produces monthly reports, including findings, recommendations, and key deliberation outcomes, distributed to NGOs, states, and relevant actors without infringing domestic sovereignty.
- Digital tools ensure inclusivity across time zones, languages, and regions.

## 3. Rules (The Mechanics)

#### **Rule 1: Information Packs**

 Distributed weeks prior, containing transparently sources expert testimony, legal context, and multiple policy options with pros/cons.

#### **Rule 2: Participant Diversity**

- Sortition ensures demographic/geographic representation; corrective stratification applied if necessary.
- Members must be a British Citizens

#### **Rule 3: Deliberative Stages**

- Learning & Expert Questioning Artificial Intelligence is facilitated at all times. Small Group Dialogue Plenary Synthesis Final Vote.
- Neutral facilitators manage Regional/National Assemblies; they cannot vote or propose policy.

#### Rule 4: Binding Mandates & 70% Threshold

Mandates require ≥70% supermajority; binding on Stewards and Delegates.

#### Rule 5: Justification & Deviation Logs

- Mandates accompanied by Justification Logs.
- Deviations must be logged with full reasoning and timing.

#### Rule 6: Assembly Reports within 2 Weeks

- Every Assembly (Local, Regional, National, Ministry Oversight) must produce a report within 2 weeks, including:
  - 1. Final mandates.
  - 2. Agreed dissenting or minority positions.
  - 3. Attendance, deliberation stages, and vote counts.

#### Rule 7: Right to Strike & Minority Reports

- Assembly members may **strike** if process integrity is compromised.
- Striking members may produce an **Alternative Reports**, with:
  - Equal publication alongside the official report with there percentage of the original assembly published. Numerous different reports from numerous striking groups would qualify
  - 2. Access to the same Assembly facilities preportionate in time tonther percentage of the total number participating thies includes those on digital platforms.
  - 3. Protection from retaliation.
- Such reports trigger review by the next Assembly on the same subject.
- Your Party Elected politicians can Lobby the membership for how soon and why. They
  can go against Assembly decisions but risks recall and removal from Your Party with
  Assembly decided penalties such as time before readmission assessment if requested
  by those expelled.

### 4. Organisational Strategy (The Roadmap)

#### A. Internal Transition & Ratification

Nov 2025 Conference: provisional adoption of all foundational documents.

- **Pilot DDAs** (ward & regional) until March 2026, testing and reports of deliberative mechanics, dissent-report procedures, and member training.
- April 2026 Conference: final ratification of institutional structures, DDA procedures, and electoral strategies, just ahead of UK Local Elections.

#### **B. Electoral Strategy**

- Stand councillor candidates in strong DDA-supporting wards; all act solely as Delegates.
- Select Prospective Parliamentary Candidates (PPCs) bound by Delegate Covenant without ignoring legal claims constraints.
- Demonstrate credibility by executing DDA mandates locally.

#### C. International Engagement

- International DDA operates continuously, producing monthly reports.
- Findings inform conflict resolution, peacebuilding, and foreign policy decisions and recommendations.
- Ensures inclusivity across languages, time zones, and international partners.

## 5. Legal & Practical Context

- MPs/councillors are legally accountable for votes; Delegate Covenant creates political/ethical binding, not legal transfer.
- Emergency deviation strictly limited, logged, and reviewed.
- Dissenting reports and strike rights guarantee process integrity and member empowerment.

## 6. Why Maximum Transparency?

Transparency allows inspection of:

- Deliberation quality
- Evidence considered
- Reasons for decisions

All disagreements, deviations, and minority reports are preserved and published. Trust, legitimacy, and citizen agency require **full visibility and accountability**.
