# **Privacy Policy**

# (For All Android apps and websites of PGR Pebs)

Please read this Privacy Policy very carefully. This contains important information about your rights and obligations. This Privacy Policy sets out the manner in which PGR Pebs collects, uses, maintains and discloses information collected from the users of our mobile and websites. This Privacy Policy applies to the PGR Pebs mobile and websites (hereinafter referred as "App", "Websites") which is owned by PGR Pebs. By downloading, installing or using or by registering Your profile with the App or website, You are consenting to the use, collection, transfer, storage, disclosure and other uses of Your information in the manner set out in this Privacy policy.

This Privacy Policy does not apply to the practices of third parties that PGR Pebs does not own, control, or manage including but not limited to any third party websites, services, applications, or businesses ("Third Party Services"). PGR Pebs not take responsibility for the content or privacy policies of those Third Party Services. PGR Pebs encourages you to carefully review the privacy policies of all Third Party Services You access.

If you do not agree to any of the provisions of this Privacy Policy, You should not download, install and use the App or website. PGR Pebs may revise, alter, add, amend or modify this Privacy Policy at any time by updating this page. By downloading, installing and/or using this App, You agree to be bound by any such alteration, amendment, addition or modification.

### 1. INFORMATION WE MAY COLLECT THROUGH OUR APP:

### 1.1. Personally Identifiable Information

PGR Pebs may collect personal information that identifies you in a variety of ways, including, but not limited to the information submitted during download and installation of the App or in connection with registration for other activities or features offered through the App or website. Personally identifiable Information collected may include name, mailing address, email address, phone number and demographic information such as gender, nationality, postcode and other personal information. PGR Pebs collect Personally Identifiable Information only if you voluntarily submit such information to us or provide access to such information by connecting to social networking sites through the App or website for example when you use the facilities available on the App or engage in certain App related activities including but not limited to becoming a member or signing up for an account or linking an account through a social network including, but not limited to Facebook, Twitter, Google Plus, and LinkedIn or when corresponding with us by e-mail or phone to use any other interactive features of the App or website. You can always refuse to supply personally identifiable information, except that it may prevent you from using the App or website, or certain features of the App or website.

## 1.2. Non-personally Identifiable Information

PGR Pebs may collect non-personal information about you whenever you access or interact with our App or any of the related services. PGR Pebs may collect non-personal identification information about installed applications, application usage information and device information. The information you give us, for

example, when you give us your opinions to our application and services via our feedback channel, such as your email address, and names.

This may also include but not limited to browser name, version, server location, device specific information such as the type of device used, users' operating system and version, your mobile devices unique device ID, third party apps or websites or App or website service that referred users to our App or website, language preference, means of connection to our App and services location information, internet service providers, IP address, technical information and other similar information about you.

#### 2. How PGR Pebs uses the Collected Information?

#### 2.1. PGR Pebs may collect and use Your Personal Information for the following purposes:

PGR Pebs may use this information to control your access to the App or website as well as use of the App or website, to communicate with the you, customize your experience of using the App or website and and/or the content of any email newsletter or other material that PGR Pebs may send from time to time and provide information that may be useful or interesting based on the content and personally identifiable information relating to you.

Your email address will be used to send user information, administrative information, changes in account settings and any changes to the App or website or updating user on new policies of PGR Pebs. Apart from this if you choose to opt-in to our mailing list, you will receive periodic emails that may relate to company news, related product or service information, etc. Email address may also be used for responding to any of the inquiries, questions, and/or any other requests made by You. If at any time you want to unsubscribe from receiving future emails, PGR Pebs has included detailed unsubscribe instructions at the bottom of each email or you may contact PGR Pebs via the App or website.

PGR Pebs may further use the collected information to analyze the use of the App or website, and the people visiting and using the App or website, for the purpose of improving the features of the App or website. Information provided by you help PGR Pebs in responding to your customer service requests and support needs more efficiently. PGR Pebs may use information in the aggregate to understand how users, as a group are using the App or website.

PGR Pebs may use the personal information provided by the User to prevent or take action against activities that are, or may be, in breach of the "PGR Pebs User Agreement", "Terms and Conditions" and any applicable laws.

### 3. How PGR Pebs Protects User's Information

PGR Pebs adopts appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of Your personal information, username, password, and data stored on the App. Sensitive and private data exchange between the Application and its users happens over a SSL (Secure Socket Layer) secured communication channel. However, PGR Pebs cannot guarantee the security of any information obtained through unauthorized entry or use, hardware or software failure, and other factors that may compromise the security of user information at any time. It is important for the User to prevent unauthorized access to his/her account and personal information by limiting access to his/her device.

# 4. Sharing User's Personal Information

- 4.1. PGR Pebs does not sell, trade, or rent your personally identifiable information collected by PGR Pebs to others except as described in this Policy. PGR Pebs may share information with PGR Pebs's business partners, trusted affiliates and advertisers for the purposes outlined above.
- 4.2. At times PGR Pebs may be required by law or litigation to disclose personal information about the users. PGR Pebs may also disclose information about the user if PGR Pebs determines that for national security, law enforcement, or other issues of public importance that disclosure of information is necessary.
- 4.3. PGR Pebs reserves the right to transfer Personal Information of users to another party as a result of merger, acquisition, or sale of all or a portion of PGR Pebs's assets to another party.

#### 5. Cookies

- **5.1.** Whenever you access the App or website we may place "cookies" on your hard drive for record-keeping purposes to enhance your experience or sometimes to personalize your experience. Cookies are small text files that are placed on your computers or mobile's hard drive by the App you visit. Cookies help us to identify information relating your activities and to retain information relating to your preferences and history on the App.
- **5.2.** Ad targeting cookies: PGR Pebs and/or our service providers may use advertising cookies to deliver ads that are more relevant to you and your interests.
- **5.3.** You may choose to disable cookies by turning off cookie feature on the web browser. However, by disabling this feature, some parts of the App may not function properly. This may prevent you from taking full advantage of the App.

# 6. Third- Party Sites

In general, the Applications, the Services and the Site access third party information (such as your Facebook/Google account information) through application interfaces. We may provide links to third-party Web sites, as a service to our Users. The Site may also carry advertisements from other companies. When you click on links of third parties in an Application, the Services or the Site, you may leave the Application, the Services or the Site. Some of these third party sites may be co-branded with our name/logo or our affiliated entity's name/logo, even though they are not operated or maintained by us. This Policy does not address, and we are not responsible for, the privacy practices of Web sites operated by third parties, whether they are linked to or otherwise accessible from an Application, the Services or the Site. The inclusion of a link or accessibility of third party Websites does not imply endorsement of such third party Website by us

### 7. Users with Whom You Share Your Information

We cannot control the actions of other Users with whom you share your information. We cannot, and do not, control the information you share with other Users using an Application, the Services or the Site (including via Forums) or how such other Users will use or share such information. We are not responsible for third party circumvention of our security measures.

# 8. What Choices User Has Regarding the Use of His/Her Information
