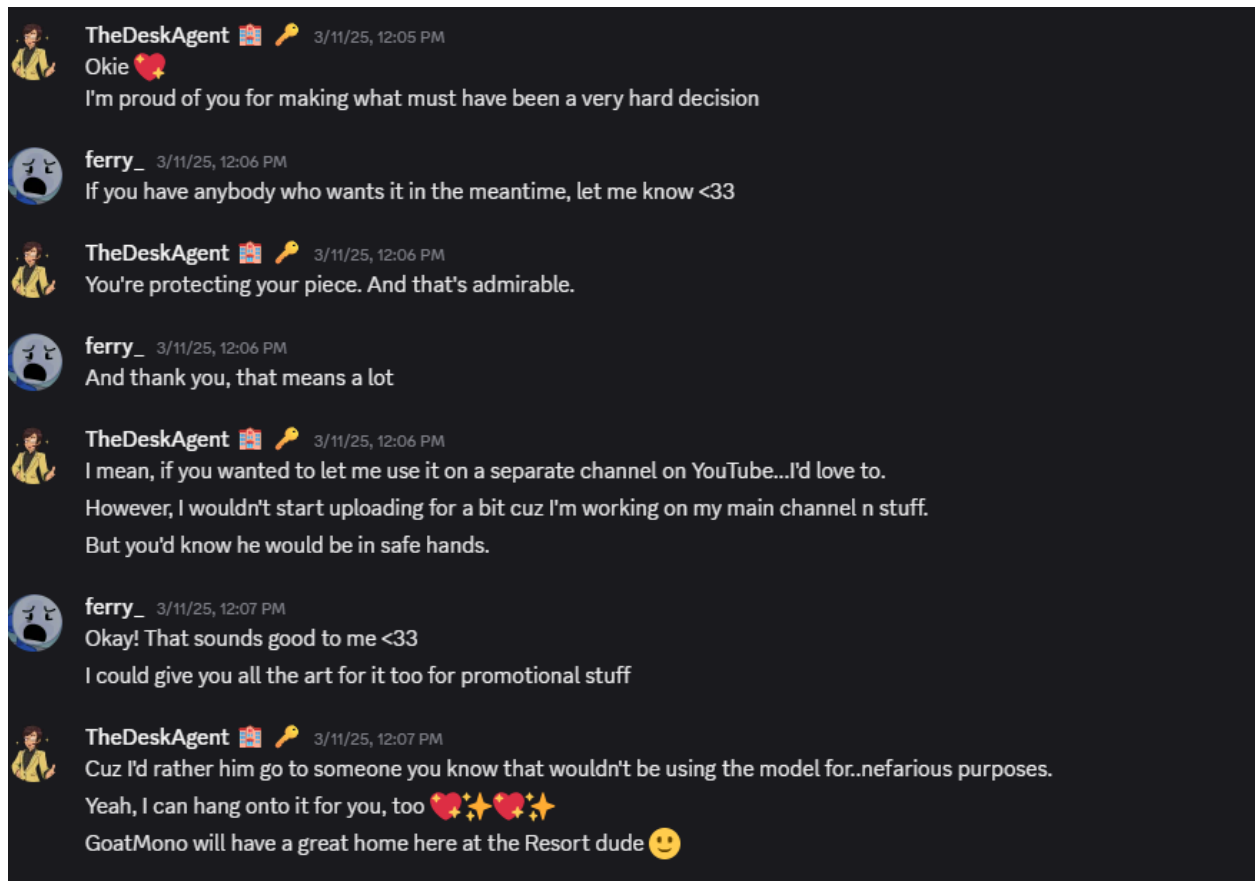

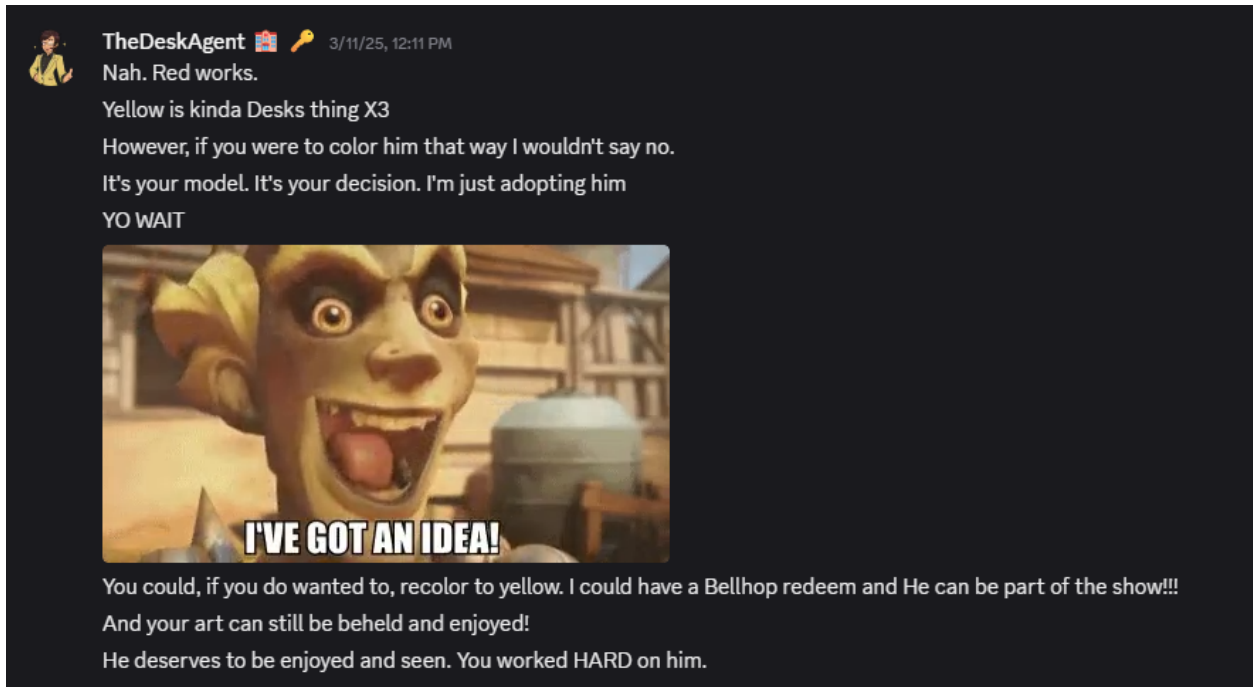
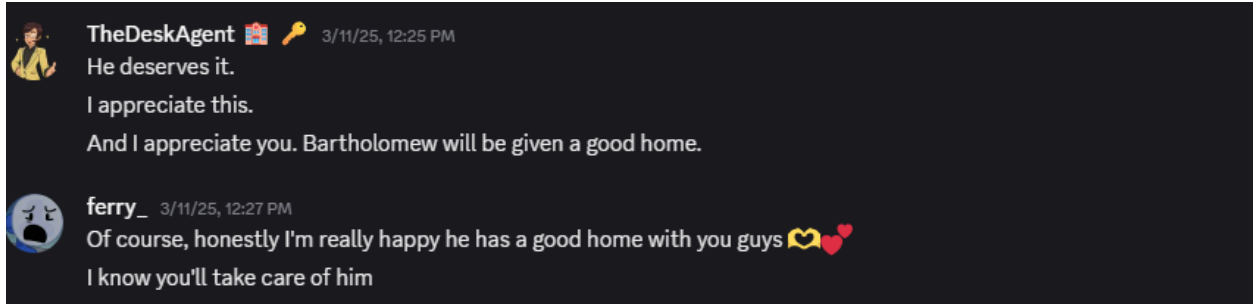
For the sake of this document, we will short it to “Desk”.

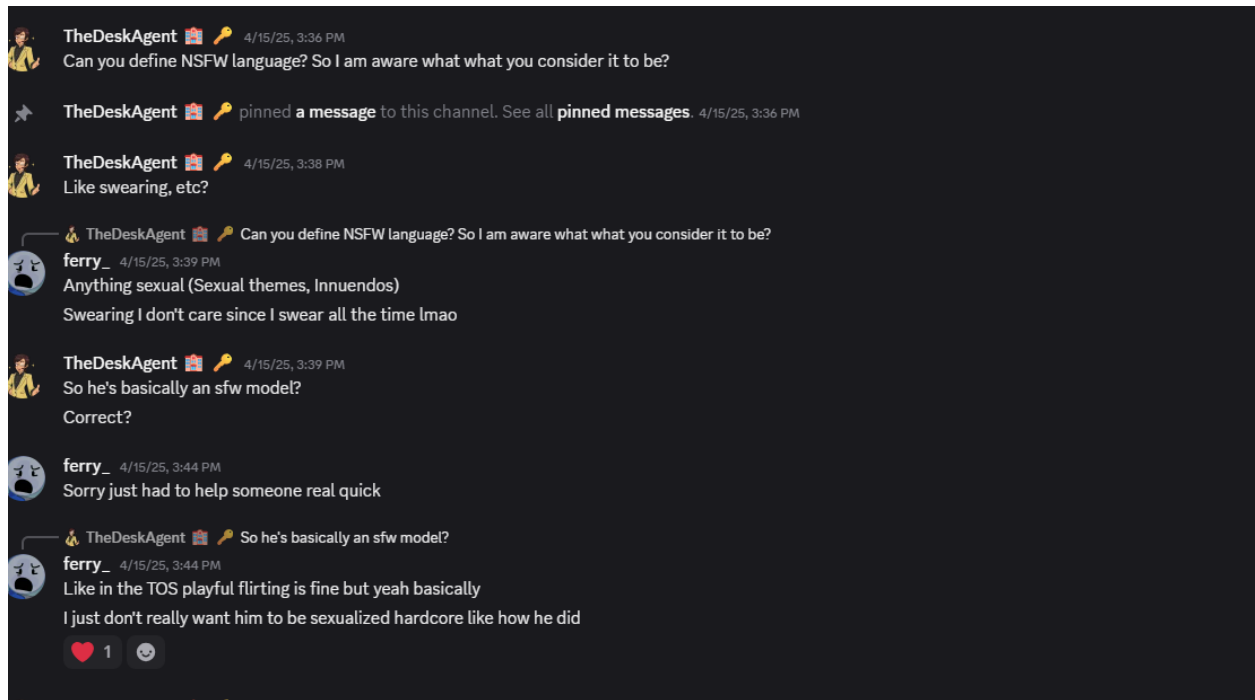


How ironic this would end out to be.

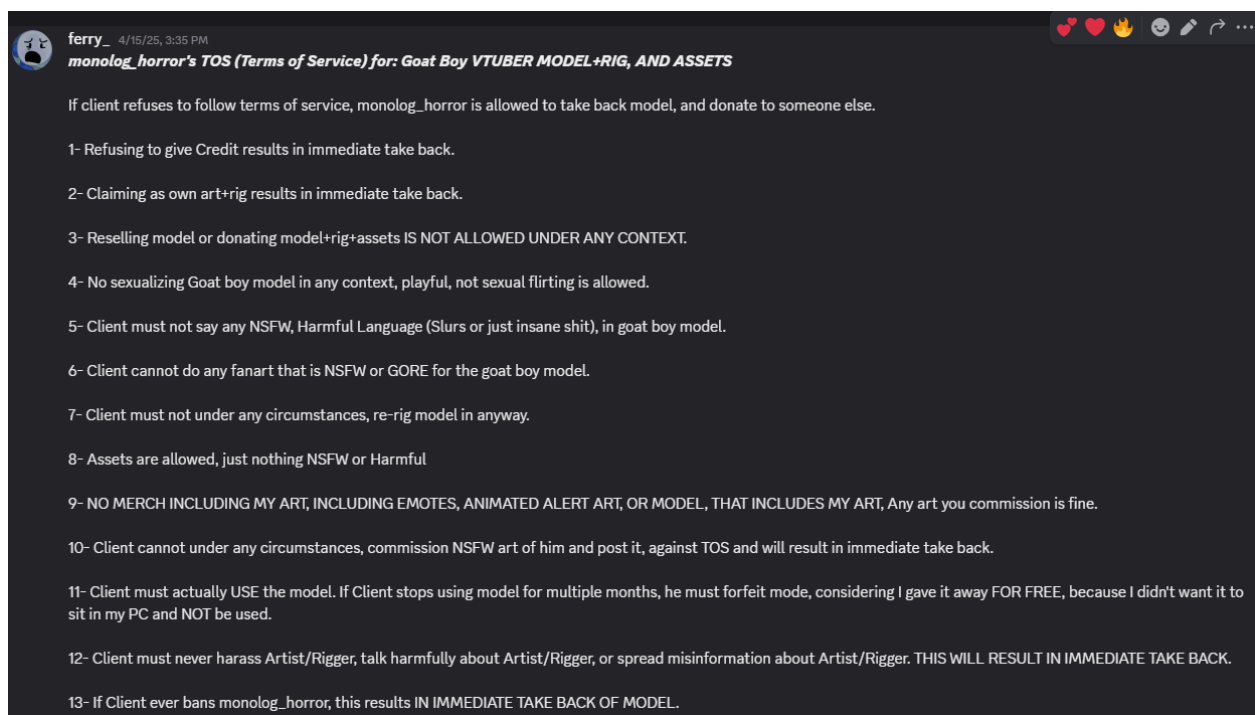
I, of course, as we were good friends at the time, said yes. I was more than happy since he constantly reassured me he would follow my rules I had set for him. When I had first announced his giveaway, I HAD MADE IT CRYSTAL CLEAR, what rules he came with, and he had agreed, knowing everything beforehand.



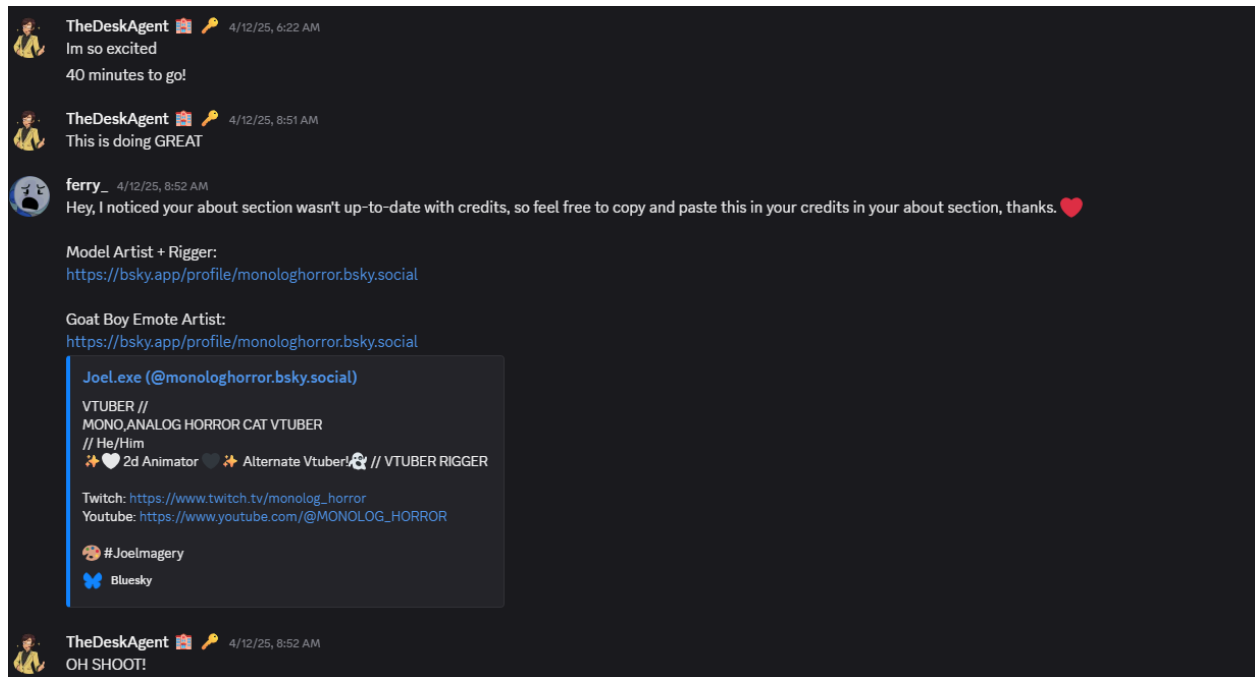
As shown in these two screenshots above, he would reassure me multiple times that he would follow my rules that the design came with.



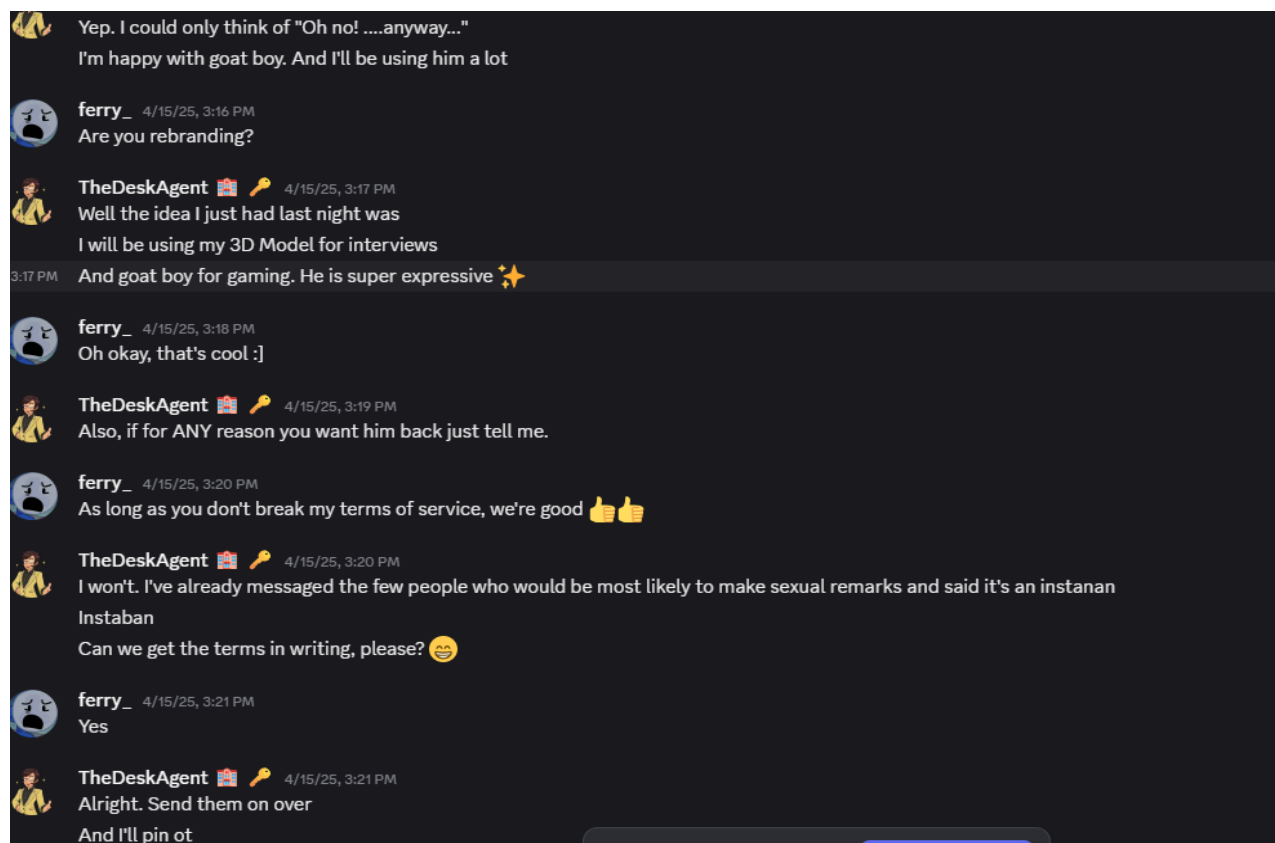
He had also double checked with me several times, about what rules to follow so I knew damn well, he knew my TOS, which was customized to this design specifically.



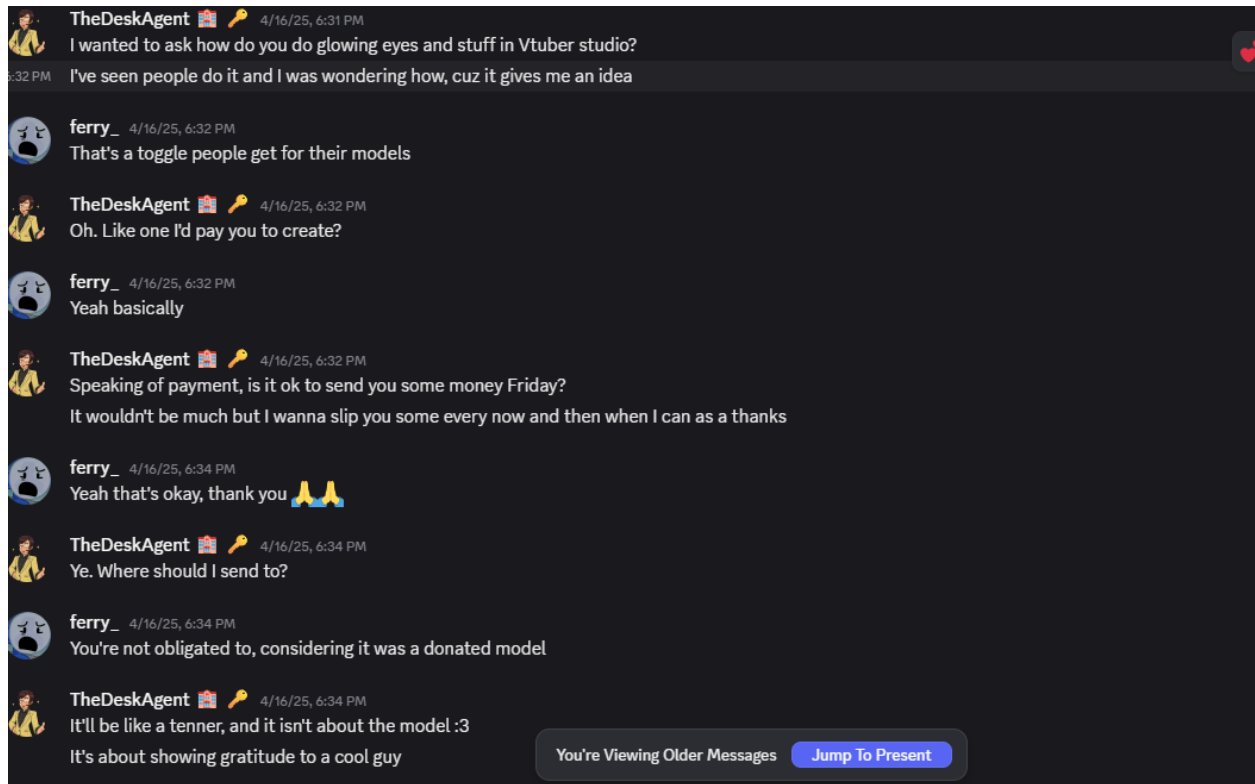
The TOS in question, which shows exactly what rules to follow and how and what he was doing.



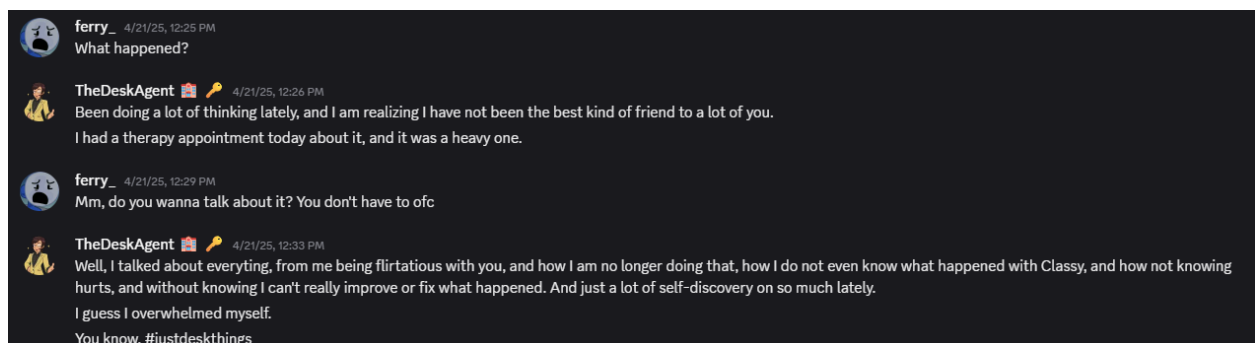
And of course, during his debut, the only thing I wanted in return for work over \$1200 compiles, including a rigged and drawn Vtuber, custom animated alerts, over +20 emotes (including animated ones), and promo art, all drawn by me, however, despite all this he had not credited me. Even when he specified this would be done on multiple occasions.



We had agreed and made a deal, and it was clear between both of us, what he was agreeing to, rules and all.

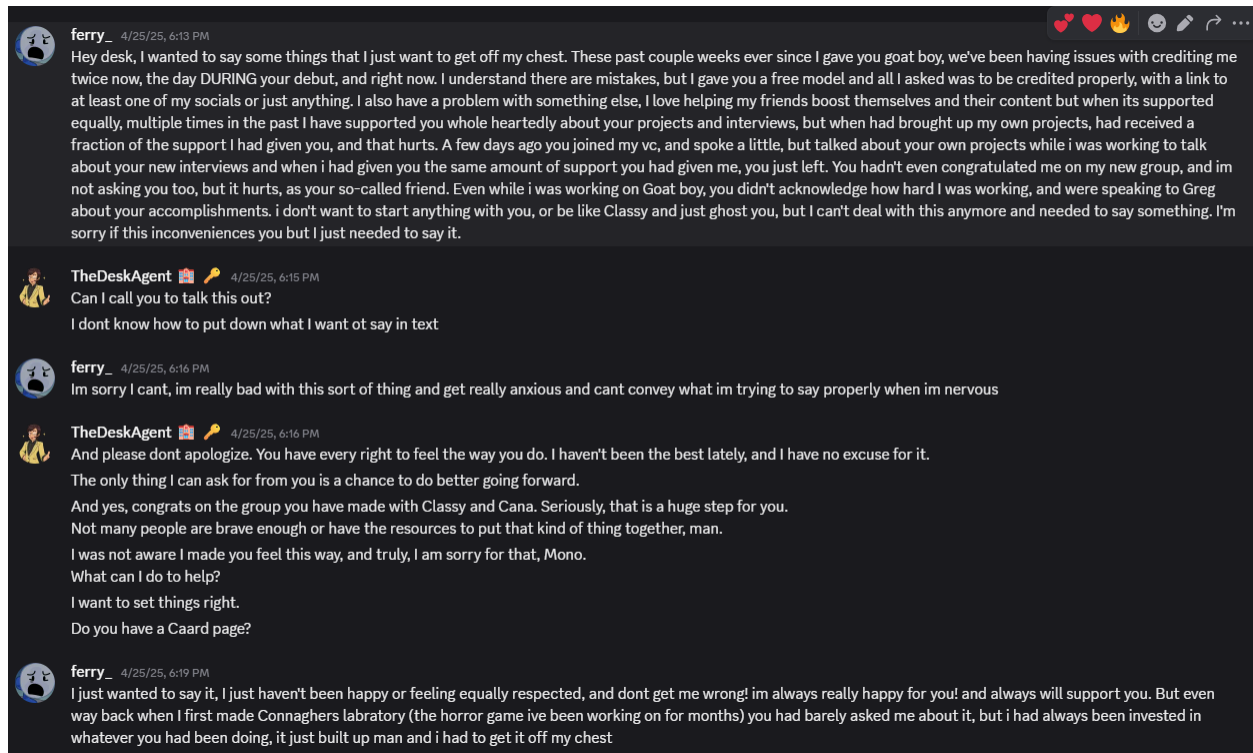


Even after everything was free, with the amount of work I had done, he had asked me for even more work to be done. Which was honestly a bit insensitive, but I could understand how he would misconstrued it to be not intended that way. And to add more, he wanted to give me 10 dollars as a tip for my work, which honestly I understand how he was trying to be nice but for all the free recoloring and re-rigging, which I didn't even want to do in the first place, it felt more like a slap in the face.



During this time, he had also been treating me horribly as a friend, it was building on me for such a long time, but I would rather not doxx his venting and just show

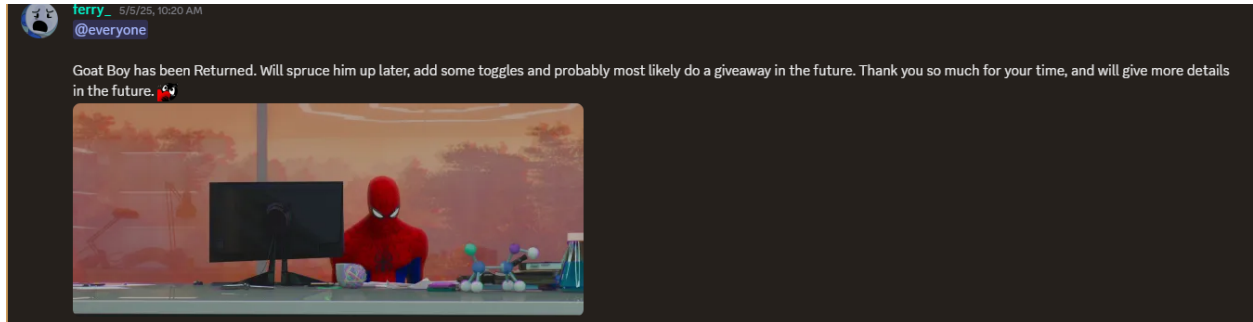
him stating he knew how unfairly and disrespectful he was being to me at the time.



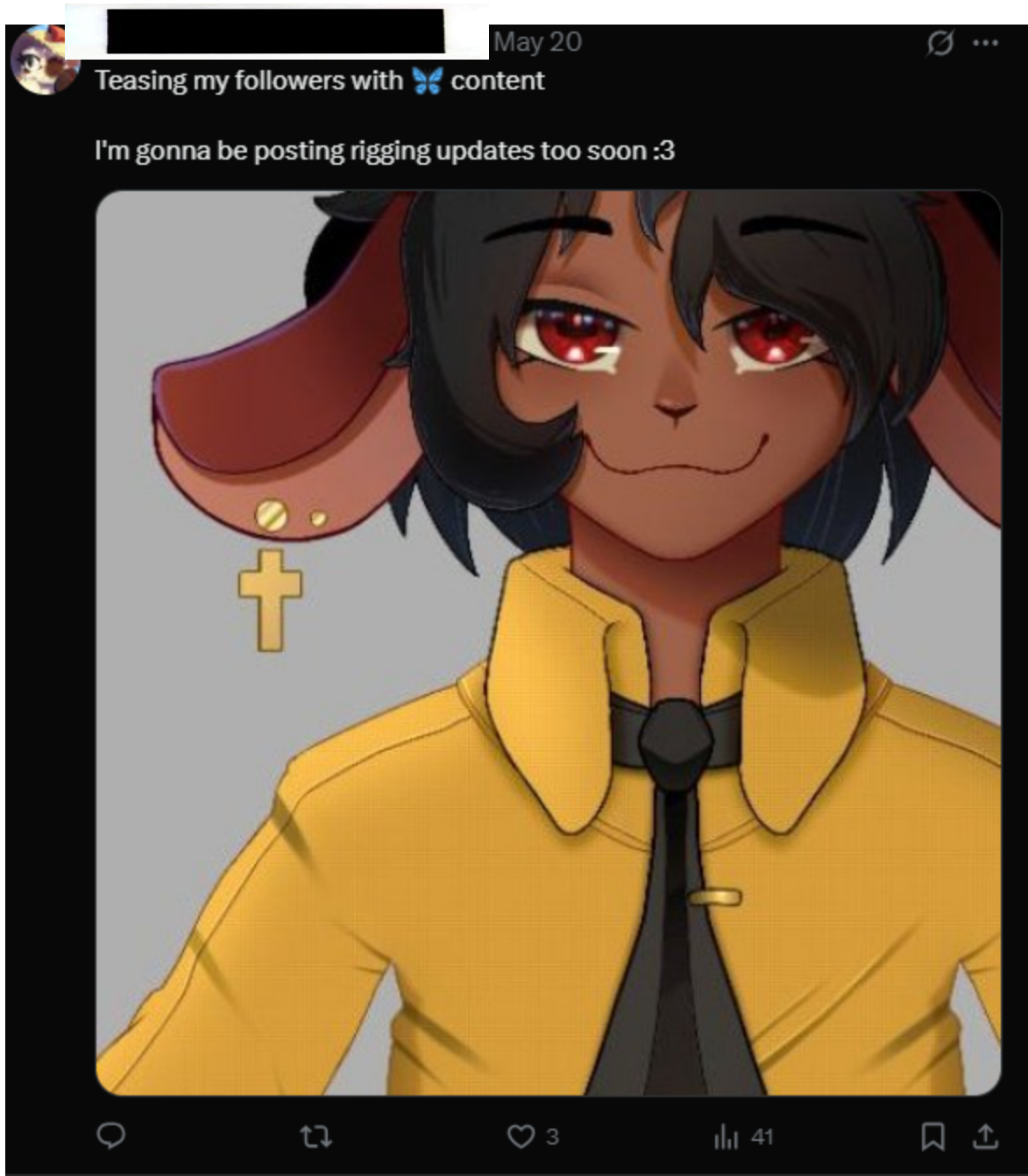
During this moment I had finally stated everything he had been doing wrong, and how hurt I felt at the time with everything he had hurt me with, which led to me finally cutting ties with him and blocking him permanently for the foreseeable future. It had been about 2 and a half months since I had spoken to him so I was unaware what he was doing.



A week after I had cut him off, he had given up and stated Goat Boy was no longer a part of his brand, and in my TOS and what I had told him was if he had ever given him up, I had revoked him by the rules of my TOS. I had even stated it in my own community server.



It had been quiet for a while until I came across a post on twitter from the current model artist and rigger he had commissioned.



I was absolutely mortified, as I immediately recognized it from my design and it broke me. Goat Boy had meant so much to me, being the first male model I used after I came out as Trans masculine. It was disgusting seeing Desk try and use it, like my opinion had meant nothing at all, as it was MY DESIGN.

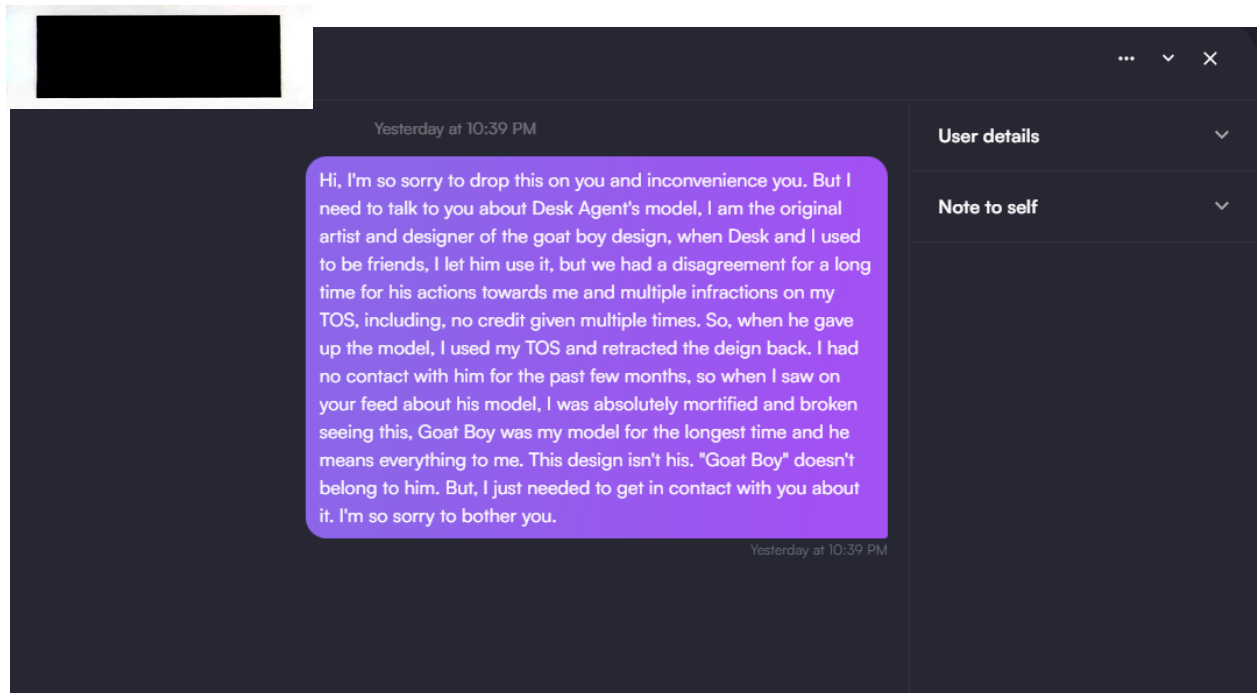
