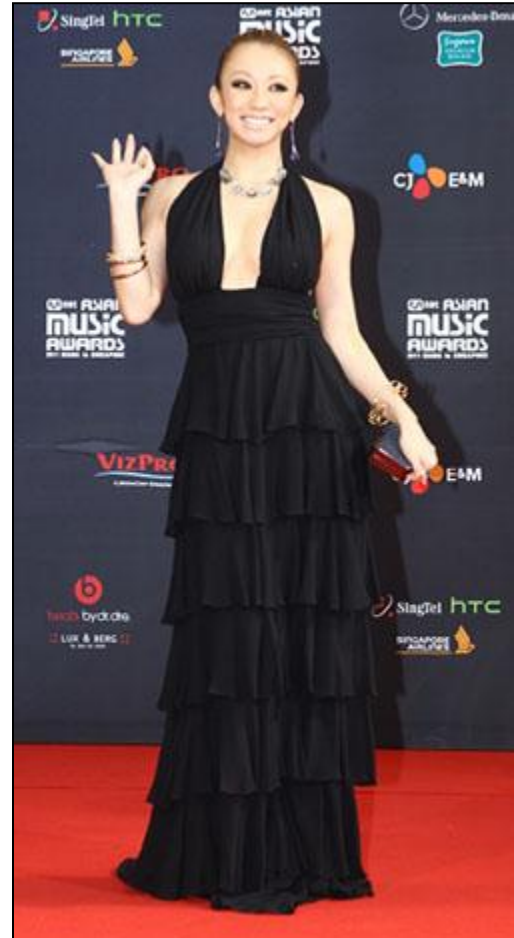

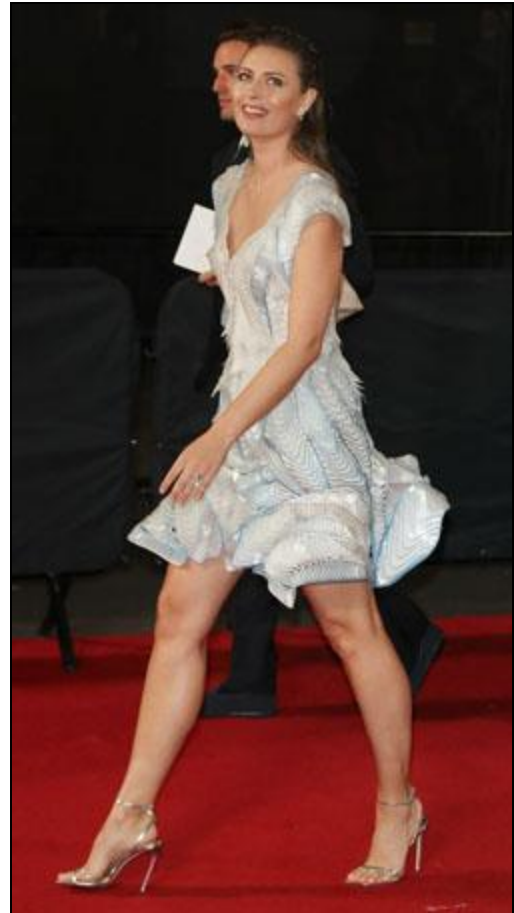

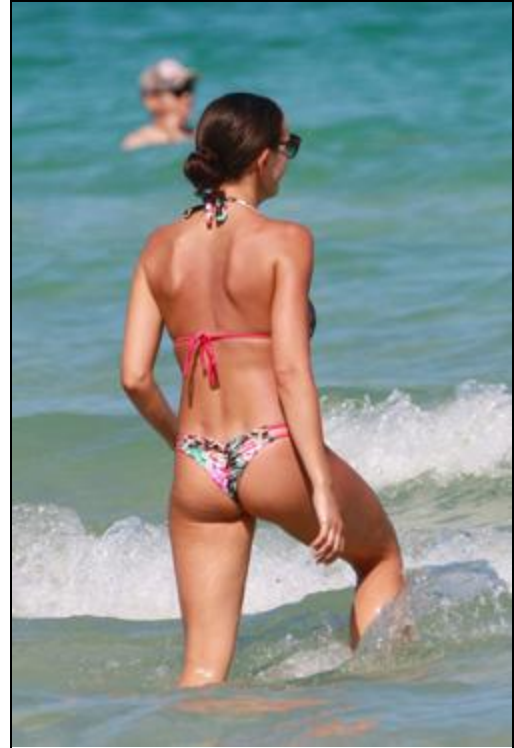
From my vantage position I can clearly see Jaclyn Swedberg make her way into the water. She acts so naturally.

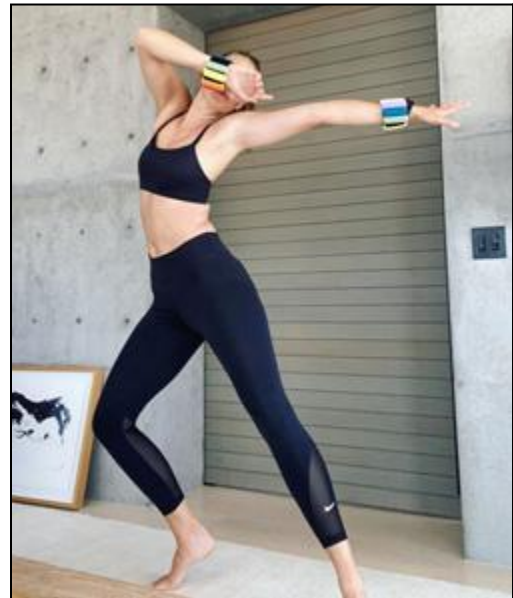

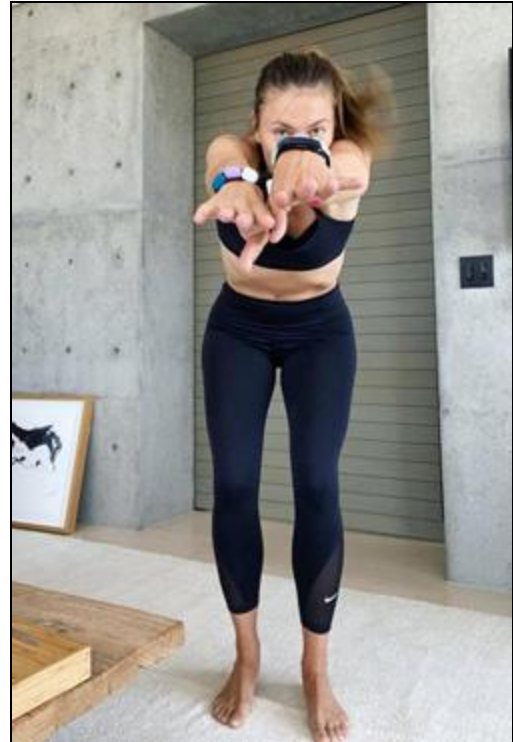
Could this level of yoga skills be the reason for Refaeli's success in her tournament?

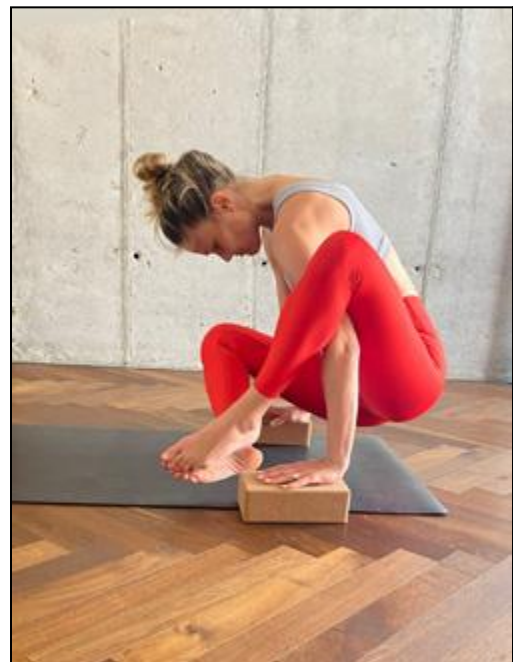
Refaeli is tying herself in knots. I am beginning to suspect that she is much more than a MMA fighter. She may be a circus performer or escape artist.

Time: 0805 hrs

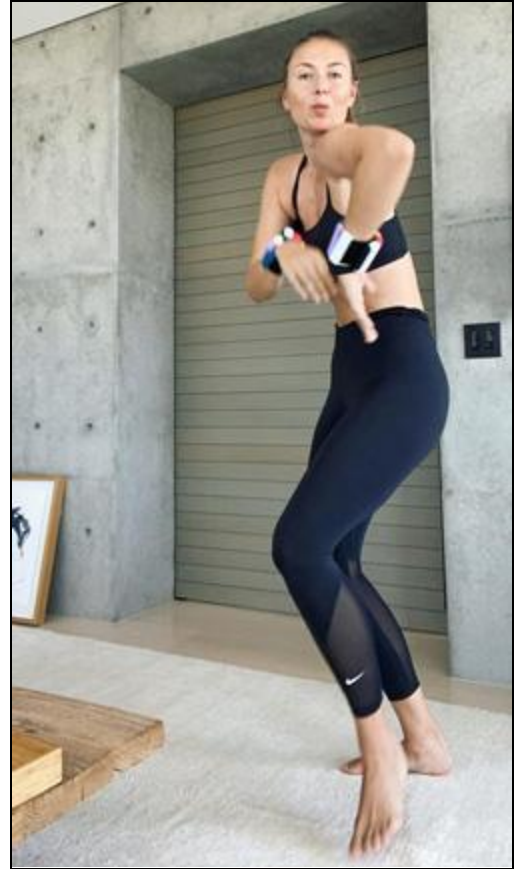
I am enjoying this yoga! In another life, Bar Refaeli and I could have been yoga buddies.
