Dear Interim Forest Grove Police Chief Henry Reimann:

As members of the Forest Grove chapter of Showing Up for Racial Justice (SURJ), we have questions and concerns about the racial harassment incident on Sunday, February 9, outside the Jesse Quinn Apartments in our downtown business district. We saw the video that Alondra Rojo-Perez captured*, and we heard from her about how the man grabbed her sister. It's our understanding that four or five police officers responded to this situation and were able to locate the man and speak to him directly that evening, but found no cause for arrest or further investigation.

According to Alondra Rojo-Perez and the video she recorded, she and her sisters – Evelin Rojo-Perez and Alejandra Rojo-Perez – felt very intimidated and harassed by this white man. He publicly insulted all three with abusive, racially charged words and grabbed Evelin. We do not understand how this man could get up into the personal space of three Latina women, block their path and subject one to offensive physical contact, while shouting racially degrading words, yet not be arrested or charged with any crime. With all due respect to Constitutionally protected freedom of speech, it seems like this incident should still fit the criteria for menacing or harassment or intimidation or some kind of hate crime. For that reason, we are requesting a meeting with you – and, if possible, the key officers involved – to better understand how this incident was interpreted and handled by police.

As SURJ members, we are committed to helping our town address systemic racism in order to ensure that Forest Grove is a welcoming place for *everyone* regardless of skin color or ethnicity. We recognize that the Forest Grove Police Department is in the midst of significant staff changes right now, so please let us know what times/dates would work best for you. It is deeply troubling to us that this kind of behavior is happening in Forest Grove

without consequence, and we look forward to talking with you as soon as possible about solutions.
