

Privacy Policy for Driving Instructor Lessons

This Privacy Policy governs the manner in which Driving Instructor Lessons collects, uses, maintains, and discloses information collected from users (each, a "User") of the Driving Instructor Lessons mobile application ("App").

1. Personal Identification Information

We may collect personal identification information from Users in various ways, including, but not limited to, when Users log in to the App or register within the App. We collect the following personal identification information for the following purposes:

- a. Email: We collect the user's email address for the purpose of authentication and to serve as a username for logging into the App securely.
- b. Contacts (Optional): We provide an optional feature within the App that allows Users to back up their contacts data. If the User chooses to enable this feature, the App will collect and store the User's contacts data in a secure manner for the sole purpose of data backup. This allows Users to retrieve their contacts data in case of device loss, device switch, or operating system migration.

2. Non-Personal Identification Information

Optionally, the Driving Instructor Lessons App may store non-personal identification information about Contacts to track contact data associated with their learning progress and scheduled lessons. This information may include skills progress and scheduled lessons. This data is used solely for the purpose of providing enhanced learning and scheduling features within the App. Users have the choice to opt in or opt out of this feature at their discretion. Please note that the storage and usage of this optional data is subject to the terms and conditions outlined in this Privacy Policy, and Users can unsubscribe or request the deletion of this data as described in Section 6 and Section 8 of this Privacy Policy.

3. How We Use Collected Information

We may collect and use Users' personal identification information for the following purposes:
- To manage and track student progress and view statistics to enhance teaching of students

4. How We Protect Your Information

We adopt appropriate data collection, storage, and processing practices and security measures to protect against unauthorized access, alteration, disclosure, or destruction of your personal information stored on our servers. Our data is persisted using Firebase, a comprehensive mobile and web app development platform. Firebase offers several security benefits, including:

- Encryption: Firebase encrypts data both at rest and in transit using industry-standard encryption algorithms.

- Secure Authentication: Firebase provides secure authentication methods, including email-based authentication, to ensure that only authorized users can access their accounts.

- Access Controls: Firebase allows us to implement access controls to restrict access to user data, ensuring that only authorized individuals have access to the data.

Please note that while we take reasonable precautions to protect your personal information, no method of transmission over the internet or electronic storage is 100% secure and reliable. Therefore, we cannot guarantee its absolute security.

5. Sharing Your Personal Information

We do not sell, trade, or rent Users' personal identification information to others.

6. User's Right to Unsubscribe and Data Deletion

The user of the Driving Instructor Lessons App has the option to unsubscribe at any time of their choosing. Upon unsubscribing, all data associated with the user held via Firebase will be deleted, including their email address and any contacts data stored as part of the backup feature.
