

SPRINGFIELD, Lincoln - As civil society prepares to gather in August to vote for the state assembly persons and Governor, I joined with a friend, “hopefully we all don’t get robbed or killed by illegal immigrants.” It was funny, but not really.

After all, it was only a month ago when federal law enforcement on immigration and borders ceased working and that it was just weeks ago that criminals were released from state prisons and county jails. Even though the Democratic party claims to [“be on our side” and “together”](#), it does not really seem so.

With a party that advocates [and a Governor who wants to “destroy American society”](#), many oppressive laws have been enacted which severely disadvantage and handicap the citizen. With the fall of the GOP, it’s not unimaginable that these laws would be repealed any time soon. It would not be farfetched to imagine how these laws could also be used increasingly to achieve their goal of a destroyed American society. Yet, in Lincoln, hope rises up with the CPP and GOP forming a coalition to tackle the Dem-goliath.

Proposed Reforms Thus Far

The CPP-GOP coalition’s presumptive candidate for Governor, former Lincoln AG nmmts- today announced that his bipartisan cabinet will herald a golden opportunity for reform, planning to release his manifesto and platform by this Sunday. The nmmts team promised to work on repealing or amending several laws and executive orders, such as:

- B.279 - Ending Police Violence Act
- B.255 - An Act Banning the Practice of Child Marriage in the State of Lincoln
- B.252 - The Selective Public Assistance Bill or the [“Ban on Federal Private Prisons in Lincoln Act”](#)
- EO.56 - Rescinding of AG Directive 008
- EO.54 - Construction of a New Mount Rushmore, or [“EO. 54 Honoring Lincoln Heroes”](#)
- EO.55 - Affirming Abortion Rights, or [“EO. 55 Affirming the Murder of Babies”](#)
- FI.005 - Phasing Out PPPs/Public-Private Models From Lincoln Infrastructure Projects
- FI.006 - Combating Systemic Racism And Income Inequality Through Lincoln's Infrastructure Operations

B.279 is expected to be the first to go, being a clear violation of the federal Law Enforcement Officers Safety Act, with the Lincoln Supreme Court denying review on Saturday. B.279 essentially disarms the police in Lincoln, yet, the federal Law Enforcement Safety Act affirms that law enforcement officers have a right to carry concealed firearms.

Next to go is B.255, which nmmts personally petitioned before the Lincoln Supreme Court before being denied review due to an unpersuasive reading of the plain text, despite litigants, and being submitted in fact, having their marriage annulled. The state Supreme Court reinforced that despite the petitioners having their marriage annulled, they found the interpretation of the Act's plain text as unpersuasive.

B.252 is currently being challenged before the Supreme Court of the United States. If they don't strike it down, the nmmts- administration will surely repeal it, as alike B.279, is a clear violation of the supremacy clause of the United States Constitution.

EO.56, which was Governor Cuba's rescinding of nmmts' AG.008 is fourth on the list. Having caused mass confusion within Lincoln's state-side law enforcement services, EO.56 has essentially caused a mass walkout of criminal illegal immigrants from state prisons and county jails. As it is an executive action, rescinding it can easily be done, thus making it and the following directives fall short of the nmmts' administration's "Top 3 Must Repeal".

EO.54, which essentially makes a State monument for prominent persons and leaders of the Democratic party will be next to go. Having been seen as a waste of taxpayer money, there is no need to honour former Governor LeavenSilva and his posse of Democrat yes-men.

Consultations between legal officials and the nmmts administration are already drafting plans about what should replace these bills, but with better and more sound provisions. Plans were also in place to introduce special elections.

Reforms must go on

Now that the Democratic party is being openly challenged, the future of Lincoln hangs in the balance. What will happen to these planned reforms?

No matter who the next Governor is, or who controls the assembly, a lack of reform leads to real consequences for people on the ground. When leaders are free to enrich themselves and defraud the public, enabled by oppressive laws and unaccountable actions, the state suffers.

Income remains low, the cost of living skyrockets, unemployment rises, money, health and education are diverted and resources to deal with climate change, food security and water will be scarce. An Oakland University law professor has shown in a simulation, how the lack of poor governance and an information blackout in China had led to a massive disease spread.

The people of Lincoln must vote, overwhelmingly, for a stabler government. Those of us who voted for the current Democratic government may vary greatly in our politics, beliefs and values. But we all know a common-sense truth. If you are American, and I am American, and when the government wants death to America - what does he want for us?

Using our voice

In the upcoming election, we must ensure that the Democratic party loses their two-third majority in the Assembly and vacate the Governor's mansion. Perhaps we should acknowledge what we are capable of accomplishing together, united, we are powerful and those who attempt to thwart the people's will shall do well to remember that.

We must also remind ourselves that given the results of the last four state elections, we have a lot more in common than we think. We must constantly keep in sight our common goals for Lincoln, especially when politicians fan death to American society and absurd laws and executive orders for their own gains.

I hope that in the coming days, Lincolnites from all walks of life will continue to call for the continuation of reform. I hope that we will continue to demand a more democratic, accountable and active government. One that truly represents the will of the people, and not their party members.
