

Introduction

Overview:

My name is Brandon Green in the streets and my call sign is Loki. I moved to Iowa a couple years ago into The Village Apartments at 355 E 12th st. Apt #12.

When Alan Martin's daughter was taken to Oklahoma and not brought back on time, I was asked by Al if I could help. After the Chief of Police and the DA came to his apartment personally and said they still had nothing about his daughter, he became very worried. This was 3 weeks after she was supposed to be home. He knew I recently was an undergrad at the University of Phoenix in Advanced Cyber Security and he knew I was a hacktivist. He said the State wasn't doing much to help and so I decided to get involved. Within days I had their location and had a crew in place to extract her from Oklahoma and bring her back to Iowa. This is when Jon Hjelle had recruited me and told me he is an Agent that is actively working undercover for the North Iowa Drug Task Force. My response was I refused to work for anybody but agreed to operate as an "Independent Contractor". My reasoning I gave is I do not like the idea of being controlled and forced into actions that go against my personal principles. Cierra and Patience Kruehl, who have a history in prostitution and drug trafficking were the two females who had Neveah, 11 years old. I have confirmation of the two people involved in the transaction. At the time I didn't know, but both of these girls were "Workers" for Jon Hjelle who is the Cousin of Frank Houdek the head of the task force. Houdeks wife and sister are the top two DHS bosses to top it off.

During this time, I was told that I would be getting paid for my work and he also stated that the Task Force is interested in recruiting me. Jon Hjelle had said all my tickets from working with him would be taken care of by the Task Force, and I would even be getting released from probation. All of the current raids & arrests that have

taken place were staged by CI 21-1 Jon Hjelle, who was having dope fiends or people that were easily intimidated plant and stage drugs at peoples houses. April also stated that this was "Franks last time being able to cover for Jon Hjelle.")

I was a witness to many crimes that Hjelle and Houdek created or covered up in my period with them. I witnessed Hjelle plant an AR-15 on a crime scene, and feed lies to the Task Force that led to houses being raided. As I got closer to Hjelle and the girls that were working for him, I found that he would tell these girls they have federal indictments hanging over their heads and if they didnt do what He said that they would go to prison. He would beat the living shit out of these girls. One of my closer friends I have in Iowa was physically and mentally abused if she didn't listen. She has had her neck broken twice by Hjelle in the past and she was tied up and left in a trunk for 18 hours and worse. She got it the worst but there are probably hundred if not more out there with a similar story and their crossings with Jon Hjelle. April McPhearson, Jon's Wife, was constantly black and blue. I had to step in between Hjelle and his step Son Ty one time to keep Hjelle from hitting the kid. He was in a full steroid rage and just shot up meth and had TY in the corner head butting him and threatening to bury him and his mom April . I tried going to the local police when Jon Hjelle was still here. I slid a note into the Chiefs box but instead of him coming to me directly, he went and told Jon Hjelle that I reached out. This was the first time Jon threatened me if I ever went to the cops, claiming I would screw up his cases and he would put me 6 feet deep I was supposed to be put in the dirt many times but many of the girls knew what I was doing and wanted me to succeed and they helped me stay alive and 5 steps ahead of the entire North Iowa Narcotics Task Force, FBI and DEA who at the time believed I was the biggest pusher in the Midwest because the lies of Frank Houdek and Jon Hjelle.

Hjelle is still trying to convince Alan Martin to move to South Dakota with his daughter. Jon told me that Patience took Neveah to Oklahoma and was going to trade Neveah in exchange for a debt she owed to a pimp . Now I have more evidence pointing that she was being sexually trafficked by your own snitch and head of task force Houdek, maybe

clueless, was helping to cover Hjelles trails. I have witnesses who have stated that the murder in Dows was premeditated and certain members of the task force, including Houdek, are helping to cover up the truth to the murder in Dows, Iowa. I have obtained a lot of intel which leads to Hjelle being tied directly to many crimes that no charges have been filed. Two eye witness testimonies and no arrests on a murder. Dan was shot 12 times in his own house. I believe with all of my heart that when this all gets exposed, you will find every form of trafficking there is and all of it is being controlled by Hjelle and Frank Houdek covering the tracks.
