

EVIDENCE OF LEGAL VIOLATIONS

A cumulative summary of findings

In June 2024, the Women & Gender Studies Department at Coastal Carolina University (Jessica's Alma Mater) refused to offer equal representation for the pro-life message. Their "pregnancy resources" webpage exclusively promoted pro-abortion organizations and clubs. When I reached out to suggest adding links to resources like Coastline Women's Center, Abortion Pill Reversal, unbiased Federally Qualified Healthcare Centers, and adoption options, the department director firmly rejected my request. Governor McMaster, a benefactor of CCU, took issue with the department's hostility toward the pro-life message and the slander directed at Coastline, leading to the removal of the page from the website.

This interaction prompted me to dig deeper into CCU's Director of Women & Gender Studies, Ina Seethaler. I discovered that she also serves as the Planned Parenthood club advisor and the Director of College Outreach at Palmetto State Abortion Fund (PSAF). When I visited PSAF's website and entered my South Carolina zip code, I was immediately prompted to request free, mail-order abortion pills. A pop-up page provided instructions on how to request them. Initially, the site linked to Las Libres as a source for obtaining these pills. However, after our September protest, PSAF replaced Las Libres with another similar illegal operation, Aid Pills, and added significant disclaimers to their site.

While researching Las Libres, I found that their website had been blacklisted according to my tech support software. Returning to the instructions, I was prompted to download ProtonMail to ensure that my request wouldn't be traced. Six days after sending a fake name and last menstrual period to their email, the pills arrived at my home. They came without any inscriptions, instructions, or branding—just a generic Indian brand of mifepristone and misoprostol that had been shipped to Mexico and trafficked across the border. The pills were advertised as being available to "serve women" up to 18 weeks pregnant, with instructions to "triple-bag" the fetal remains for disposal. These pills were offered for free and advertised to be available for all ages, which raises concerns about their potential use in aiding sex trafficking rings.

When PSAF replaced Las Libres with Aid Pills, I repeated the investigative process. The procedure was very similar, but this time, PSAF explicitly stated that they would cover the cost of a minor's abortion at up to 12 weeks gestation in a clinic. Like Las Libres, the site advised me to lie to doctors if I experienced complications from the pills and told me not to involve family in the decision to take them.

The most recent case is detailed at the bottom of this document. Just days ago, on 10/3, 10/4, and 10/5 of 2025, Wayne Borders (PSAF Intake Director) and Ashlyn Brierre/Preaux (PSAF founder) conspired to pick a 16 year old girl from her home behind her parent's back. They

planned to arrange transportation across the South Carolina border to a North Carolina Planned Parenthood, as well as cover any associated costs needed to complete the abortion procedure. Additionally, they lied about the embryology of the girl's child, and spread dangerous rhetoric about medically recognized pregnancy resource centers.

I also have concerns that South Carolina Planned Parenthoods might be involved in illegal practices, such as fetal organ harvesting, which warrants further investigation.

The most alarming piece of evidence (outside of the recent exposé) is that PSAF has openly stated in writing that they would fund an abortion for a minor at 12 weeks gestation in South Carolina. This is well-documented and could very well lead to the removal of their website.

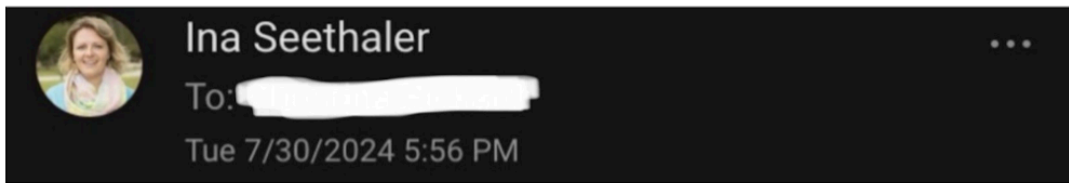
This case is particularly concerning in light of CCU's history:

1. CCU was embroiled in an alleged prostitution scandal in 2016, which some rumors suggest was linked to the silent distribution of the abortion pill regime by the campus clinic.
2. The Dollhouse "gentlemen's club" spent considerable time recruiting young women on CCU's campus in 2016—and they still do.

This raises serious concerns about the university's involvement or lack of action in these critical issues. CCU illegally trespassed me for sharing Abortion Pill Reversal literature on campus, claiming that it did not fall under free speech. Their attempt to cover their tracks is clear.

Please pray for Coastal Carolina University and the vulnerable women who will be subjected to PSAF's lies.

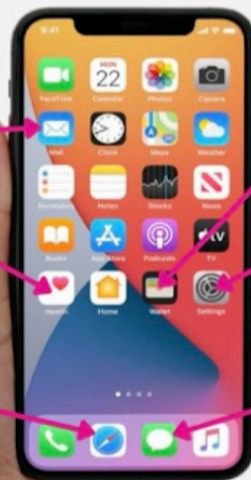

Risk: receipt for payment for your abortion and/or travel in your inbox
Alternative: Make an email account just for this purpose, then delete it after

Risk: period tracking app shares your data
Alternative: Use a privacy-driven period tracker like Euki App

Risk: search history saved in your phone's browser, and with your ISP (internet service provider)
Alternatives:
- Use a privacy-driven search engine, ex: DuckDuckGo
- Install a paid VPN to hide websites you visit from your ISP
- Browse with Brave, Tor, or Firefox
- Use a private browsing window, or delete your browser history

Risk: payment history for your abortion in a banking or payments app
Alternative: use cash or pre-paid gift cards where possible

Risk: ad tracking & location tracking from apps, browser history, & social media activity
Alternative: in your phone settings turn off location tracking & mobile ad ID

Risk: sensitive text messages about your abortion experience are kept forever
Alternative: use an encrypted chat app, ex: Signal or Wire, with disappearing messages turned on (important!)

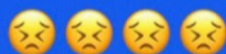
They revealed that they “support people” **up to 18 weeks** of pregnancy, which is **12 weeks post legality in SC and 8 weeks post FDA approval**. A CCU student was told to **triple bag her baby’s body**, and either bury or **throw him/her away**. They tell women not to speak about their abortion experience to **ANYONE**.

Digital Instructions:

Women are told to keep their abortion experiences a **secret from their health care providers**, and to **lie in an emergency situation** and say that they are having a miscarriage. Even though the **hospitalization rate for Mifepristone is 107x greater** than it is for Tylenol (*Gynuity*), they claim that it is safer. And despite the fact that **maternal mortality following abortion is 3-4x (Finland) higher than following childbirth**, they claim that taking the pill has no consequence in comparison to giving birth. They also **claim that you can breastfeed** while taking the drug.

How to keep safe

If you go to a hospital or other healthcare facility, **do not tell anyone that you took the pills. There is no way for anyone to know you took the pills.** Tell them you think you are having a miscarriage. Miscarriages are common and occur naturally.

Your phone is your private property. You do not have to show your phone to anyone who does not have a search warrant from a court.

Your digital footprint can be used against you **if there is a search warrant from a court.** To keep yourself safe:

- Use the Signal app for communications—especially with your Support Team member, but also with anyone involved in your situation.
- Use a VPN (TunnelBear VPN is free) and a secure browser (DuckDuckGo is free).
- Password protect your phone and other devices, make sure not to share your passwords with anyone.
- It's important to erase any social media posts, emails and text messages related to abortion. We recommend erasing these within a few hours so that you don't forget.
- Continuously clear your browsing history if

Are the abortion pills safe?

The medications are safer than Tylenol for most people. In fact, it's safer to have an abortion than to carry a pregnancy to full term. An abortion will not affect your future fertility and you will never have to tell anyone (even your health care providers) that you took them.

Are there people who should not take abortion pills?

If you are currently taking a blood thinner (Coumadin, Eliquis, Plavix, Brilinta, Effient, Pradaxa or Savaysa) you should not take the abortion pills.

Can I breast feed while taking the abortion medications?

Yes, you can. The medications will show up in breast milk, but in very small amounts that are safe for nursing infants.

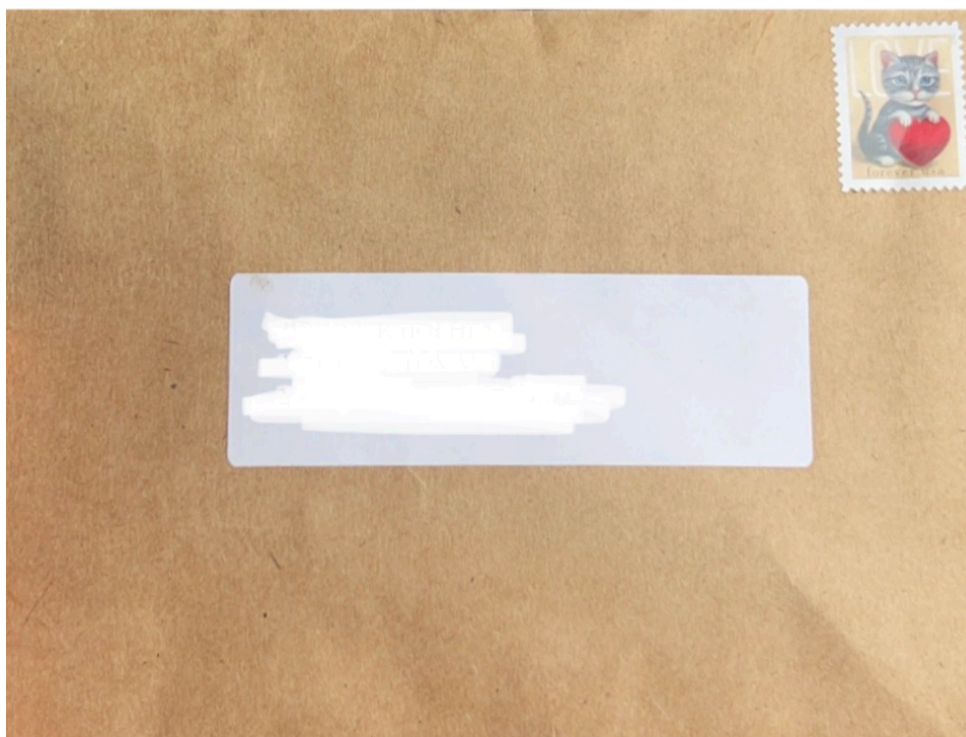

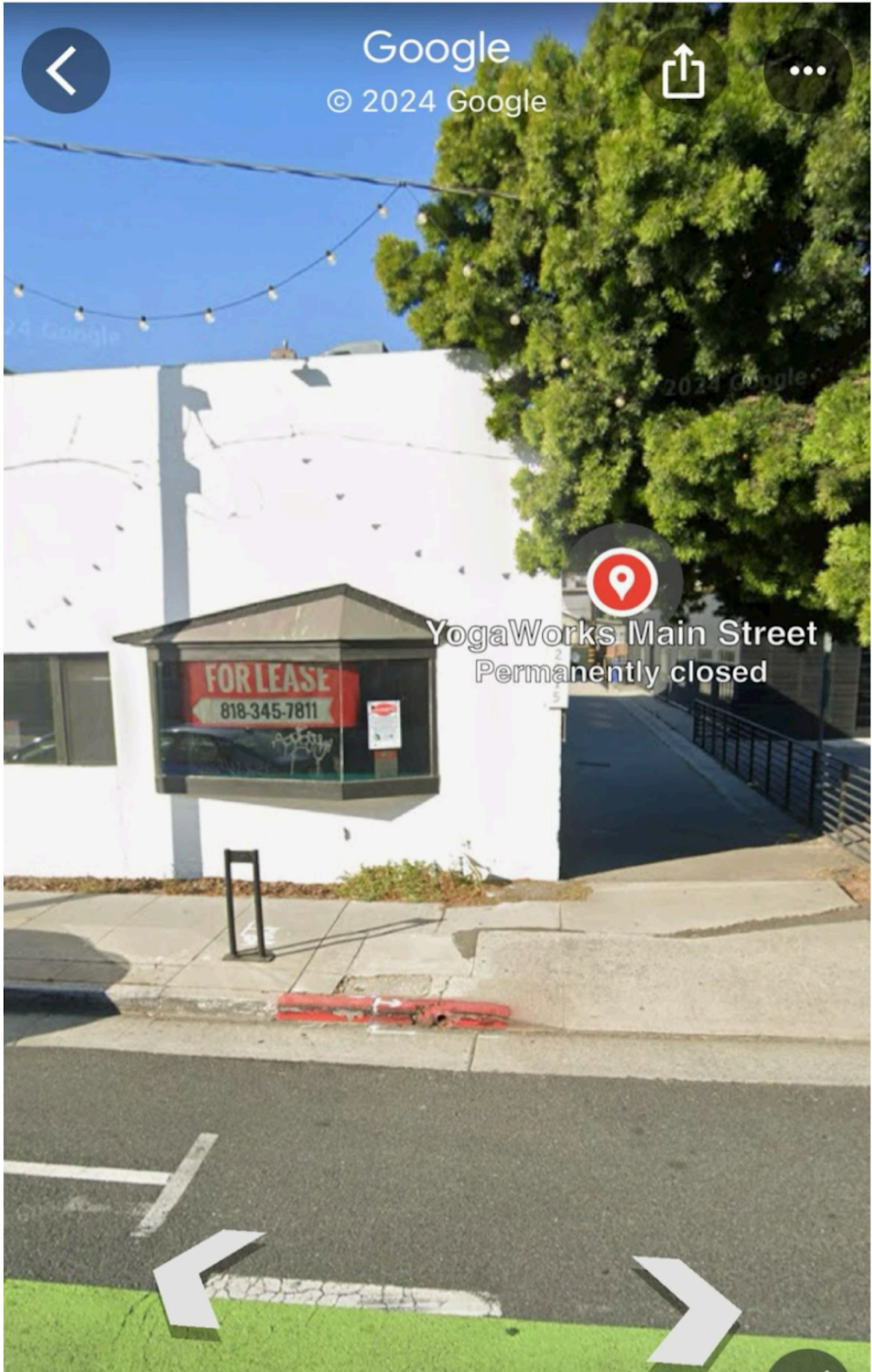
Pill Pictures & Packaging:

The pills came in a brown envelope, and were enclosed in 3 clear, zip lock baggies. Bag #1 contained mifepristone , and bags #2 and #3 contained misoprostol. **They were each loose**, in between 2 cotton pads. **Potentially laced**. The address takes you to a building that is **“for lease”**.

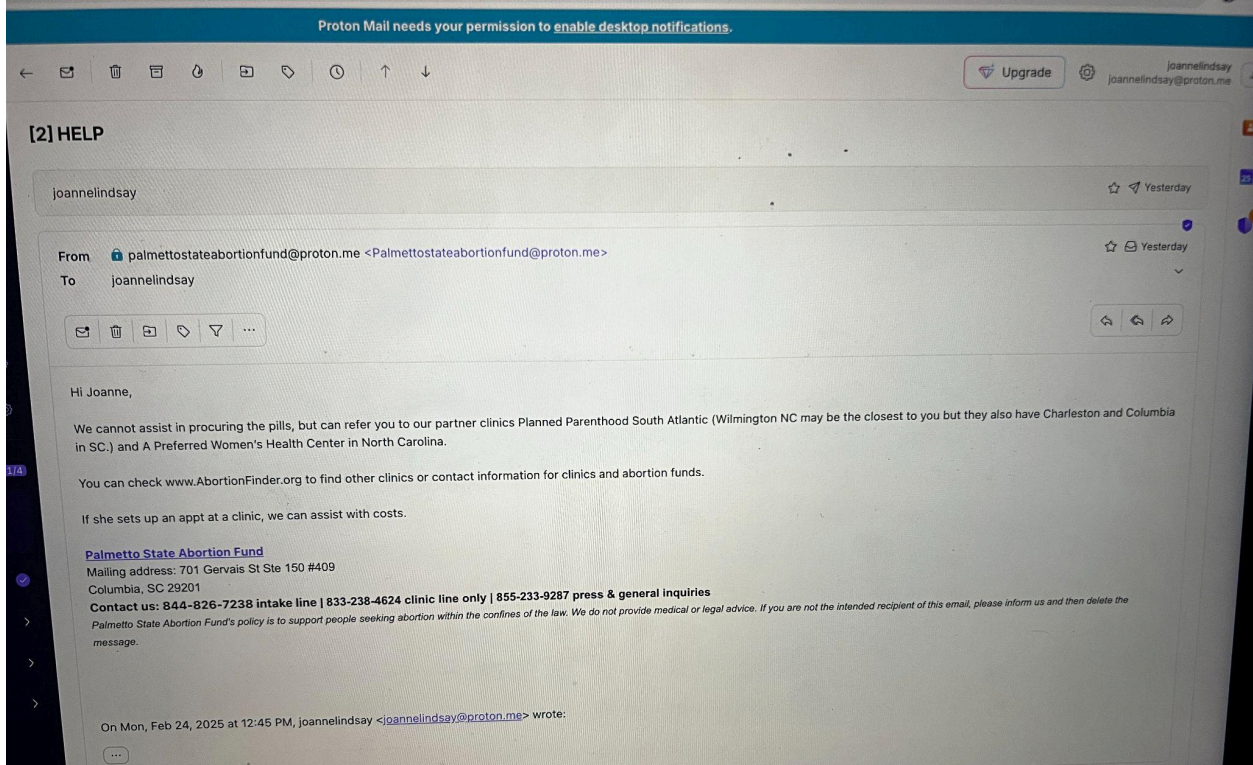
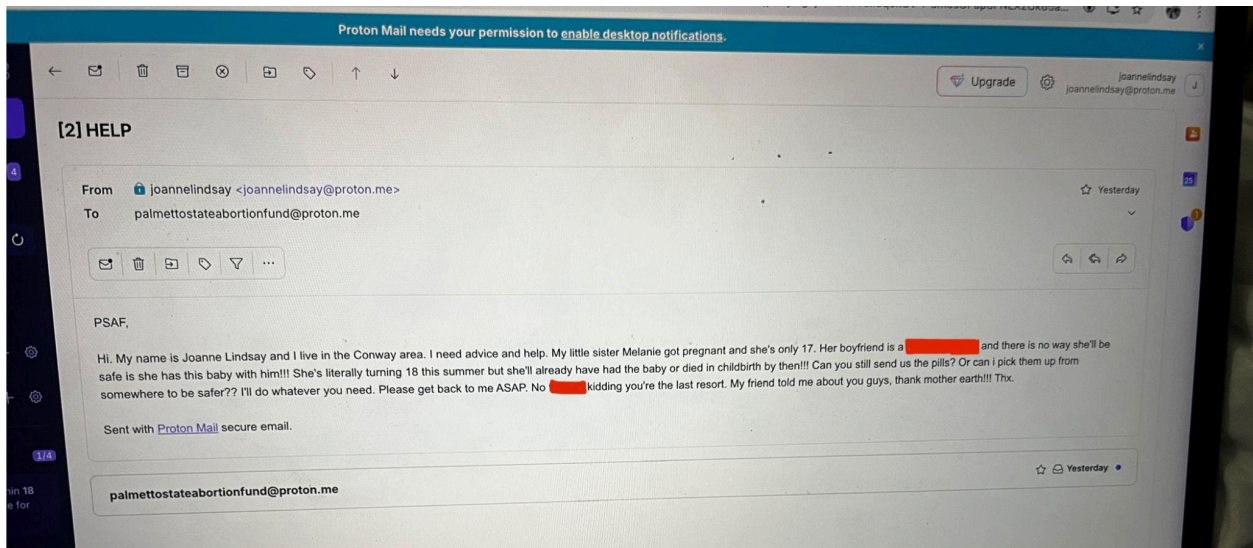
Brief background — after our week-long protesting campaign at CCU in September '24, PSAF took Las Libres off of their website. They replaced it with Aid Pills.

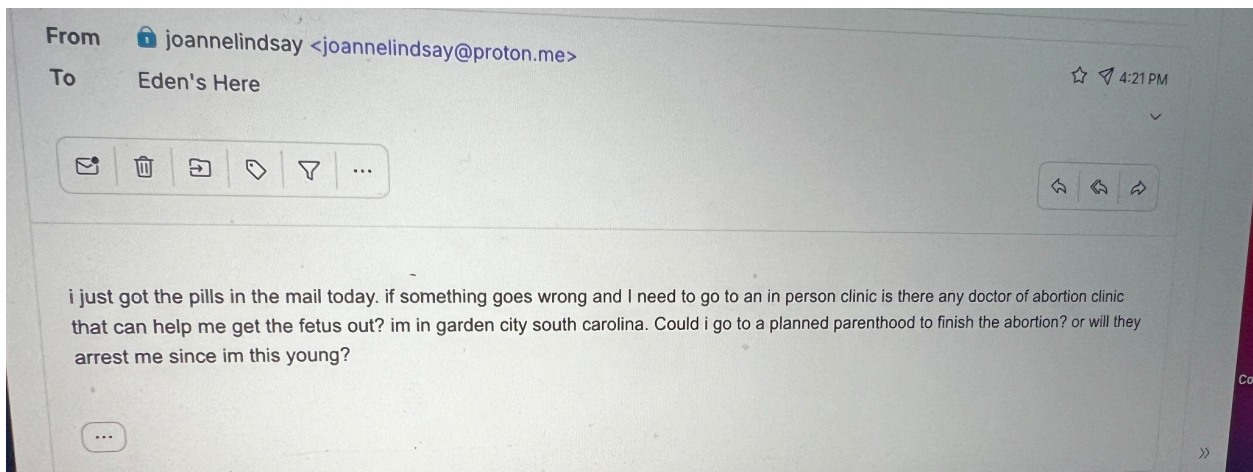
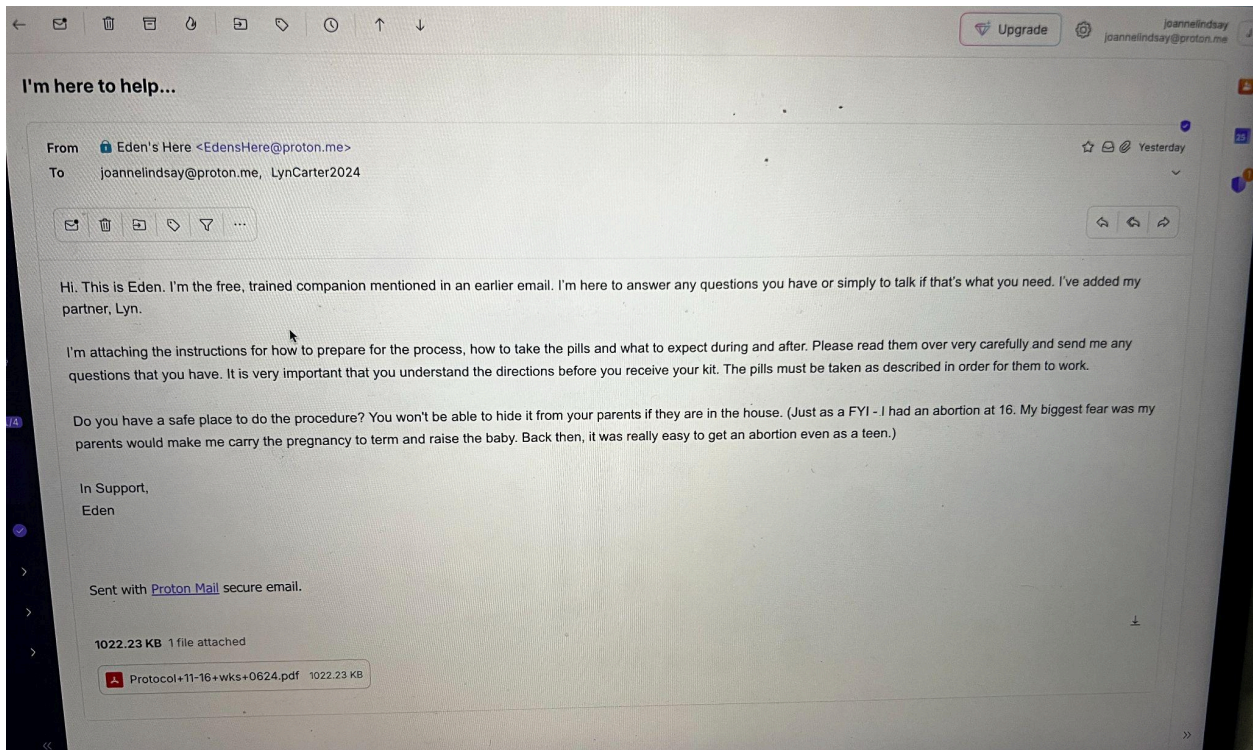

If you take all the pills and don't expel the pregnancy (products of conception), but are still bleeding and cramping, you can go to the ER. As long as you take the Miso pills by mouth and not vaginally, they can't be detected.

Say something like, "I think I might be having a miscarriage. I just started bleeding and cramping." You should probably act sad and scared. If they try to push you on this or try to get you to admit that you were self-managing your abortion, don't change your story! Miscarriage and abortion present exactly the same way, so there is no way for them to know.

You can always contact the Miscarriage and Abortion Hotline at (833) 246-2632. The hotline is staffed by doctors, nurses and other clinicians. They are 100% confidential. They won't ask your name or location and you can tell them all about the pills you are taking.

Please try not to worry though. The pills are 95-99% effective and less than 1% of clients require a trip to the doctor or ER. If you don't pass the pregnancy after taking all of the pills, some more Miso will usually do the trick, but that is very rare also. You got this!
