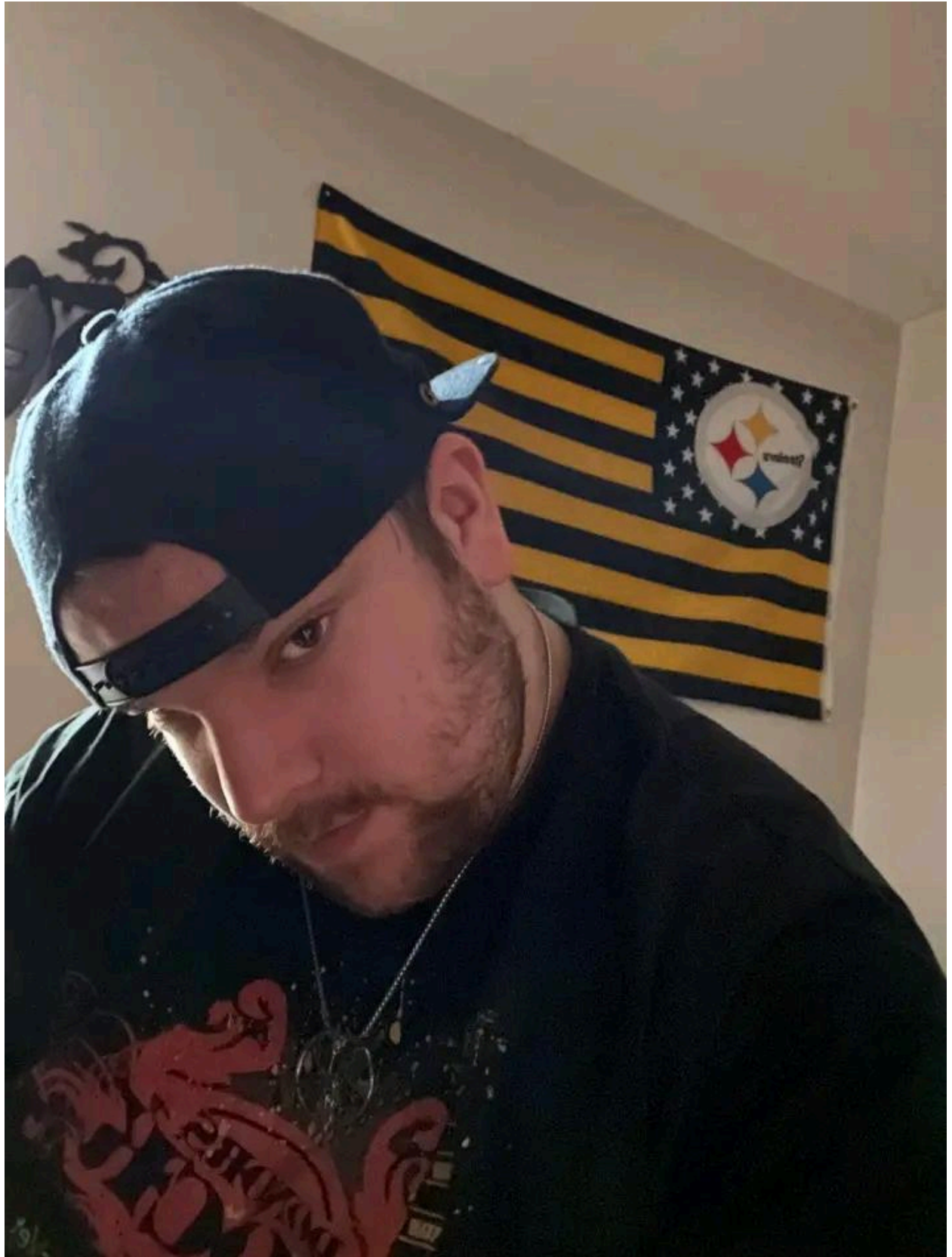

This is what his fursona looks like which these two pictures were also obtained from Facebook.





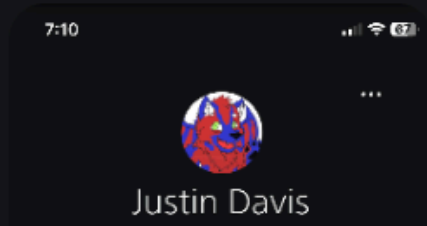
As of right now he's faking his address to get rid of people calling him out which leads to chapter 2
