## **Privacy Policy**

FREXDEV and its subsidiaries ("we" or "us") value your privacy. This Privacy Policy ("Policy") describes how we collect, store, use, and disclose your personal data when you use the PDF Maker - Lite PDF Reader

("Service" or "App"). "Personal data" means any information relating to an identified or identifiable individual.

A.What data do we collect about you and why?

We may collect the following categories of personal data about you:

- (1)Device information includes device types and settings, device identifiers, browser types, mobile, wireless, operating system versions, and other network information (such as internet service provider name, carrier name and signal strength), and application version numbers. (2)Usage data includes your IP address, the pages of our App you visit, the time and date of your visit, the time spent on those pages, unique device identifiers (such as IDFA, IDFV for Android, GAID for IOS) and other diagnostic data.
- (3)Identifiers includes your name, your contact details (such as email addresses, phone number).

We use the information collected about you as appropriate and relevant for the following commercial purposes:

- (1)to provide services to you.
- (2)to allow you to make requests.
- (3) for marketing and promotional purposes.
- (4)to assist us in advertising our Services on third-party websites.
- (5)to better understand how users access and use the App.
- (6)to comply with legal process.
- (7)to enforce our contracts.
- (8)to defend against or pursue legal claims.

### B.To whom do we disclose your information

We may disclose personal data collected about you as follows:

- (1)Our affiliates or subsidiaries.
- (2)Third party vendors, service providers, contractors or agents who perform functions on our behalf.
- (3)Other recipients for any purpose with your consent.
- (4)In connection with the establishment, exercise or defense of legal claims.
- (5) Comply with laws or to respond to lawful requests or legal process.

#### C.Links to other websites

The App may contain links to third party websites for your convenience. Any access to and use of such linked websites will cause you to leave the App. Third party websites are not governed

by this Policy, but instead are governed by their own privacy notices. We recommend that you check the privacy notices of every third party website you visit before providing any personal data. We do not control those third party websites and are not responsible for their content or their privacy practices. Thus, we do not endorse or make any legal representations about them. If you decide to access any of the third party websites linked from the App, you do so entirely at your own risk.

## D.How do we secure your personal information
