- (1.) Communication will proceed via one of the following:

- (2.) Payment will be made through Paypal in United States of America dollars
- (2b.) Payment must be made first before work begins on the commission.
- (3.) Clients will have the opportunity to request alterations of their commission in the thumbnail

sketch stage. Complete revisions may be entertained, however, for the sake of expediency, any

preferences regarding pose or subject matter needs to be communicated early.

(4.) The Artist reserves the right to reject critique and redline pertaining to artistic skill or style

preference (i.e. anatomy, coloring style, etc.) if said critique reduces the artistic quality of the

piece.

- (5.) If the Artist doesn't receive communication back from a client for over a year, their commission and funds are forfeited and no commission will be delivered
- (5a.) If the Client wishes to cancel their commission prior to the sketch stage they will be refunded 75% of what they paid
- (5b.) If the Client wishes to cancel their commission during the sketch stage they will be refunded 50% of what they paid.

(5c.) If the Client wishes to cancel their commission during or after the coloring stage they

will not be issued a refund.

(6.) The Artist reserves the right to issue a refund and cancel a commission due to rude or

inappropriate behavior, poor communication, and inability to communicate in effective English.

(7.) The Artist ensures the Client will receive email updates on commission when necessary.

Clients are encouraged to check in when they feel it's necessary for updates, assurance or

reminders.

- (8.) The Artist reserves the right to reject any commission for any reason.
- (9.) The Artist retains the right to display all commissioned work on any personal or public

website, gallery, or journal. If the commissioned work is a time-sensitive gift the Artist may delay

public showcase at the request of the Client.

(10.) The Artist retains ALL the rights to the commissioned artwork, including the right to make

prints and merchandise.

- (10b) No part or whole of any stage of the artwork process/image/final art may be allowed use in NFTs/cryptocurrency, published material, or licensed commercial products.
- (10c) No part or whole of any stage of the artwork process/image/final art, may be used, or scraped, for use with any Ai generative software, or related Ai programs.
- (11.) The Client retains all rights to their respective characters. This does not allow them rights

to the commissioned image (see articles 12 and 13).

(12.) The Client may not profit from the artwork including the sale of the digital files, or rights to

the image.

(13.) The Client cannot alter the artwork itself. The Client may also upload the artwork to their

personal website or gallery, but credit is required, and it must not be any high-resolution or unwatermarked version of the artwork.

- (14.) The Artist may recycle sketches and preparatory works that were rejected by the Commissioner for other commissions or personal works.
- (15.) The Client must read, understand, and agree to all the above terms before entering into an agreement with the Artist. By selecting "YES", the Client agrees to the above terms.
