

## Terms and Conditions

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE USING ANY PART OF THE APP. These Terms and Conditions (the “Terms”) are a legal agreement between you and [Saged Samir](“we”, “us”, or “our” ) and it sets out how you are permitted to use the [Piggy Tycoon Slots](“App” or “Service”).

### Amendment of Terms

We may at any time amend any or all provisions contained herein and users will be considered as having received notice and bound by the changes when the revised Terms posted on the App.

### General use
