1st Major Reform Amendment

Written by RB33 Writer of the constitution Head Mod and Chief Justice

This amendment will improve various lacking parts of the constitution, which were omitted when it was originally written. Such as automatically recalling biased legislators, strengthening the accountability of national governments to the constitution, lowering amendment voting days to 2 (from 3) as well as improving some citizen rights and giving the moderation more formal tools to deal with very disruptive players.

Red text are is text removed from the current constitution, blue text is text added through this amendment.

Article 1: Moderation

Section 1: Establishment of Moderation

- (a) There shall be one Head Moderator and three Deputy moderators who form the moderative council, referred to as "Moderation" from now on.
- (b) The three Deputy Moderators will form a Triumvirate.
- (c) Any member of Moderation will be given the rights of a citizen when he/she resigns or steps down.

- (d) The Head Moderator or a % vote by Deputy Moderators may appoint any member of the moderation team as Acting Head Moderator when the Head Moderator is on leave of absence or has been inactive for a certain period (determined by the Moderation team). This position has all of the responsibilities of the Head Moderator, but is exempt from dual mandate.
- (e) The Moderation team has the responsibility to keep the community civil. The Head Moderator AND Deputy Moderators have the jurisdiction to decide what is considered uncivil (slander, hate speech) and has the power to delete the offending comment and punish the sender. If a punished party feels that they have been treated unfairly, they can appeal their punishment to the Supreme Court.
- (f) Moderation may not give any party, nation, or group any sort of preference while in their job. If a moderator is caught doing this, it is an immediate recall and ban from the community for one month.
- (g) The Head Moderator may create positions called "Assistant Moderators" that are inferior and subordinate to Deputy Moderators and the Head Moderator. The Assistant Moderators have the same duties as the Deputy Moderators and may be delegated tasks from the Head Moderator and/or Deputy Moderators.

Section 2: The Head Moderator

- (a) The Head Moderator is the chief Moderation position and can override the Triumvirate. The Triumvirate can override this override with a 3/3 vote, in which the Head Moderator must abide by the will of the Triumvirate.
- (b) The Head Moderator is affected by dual mandate, and therefore cannot be involved in any other office.
- (c) The Head Moderator is an indefinite role; there are no term lengths/limits.
- (d) The Head Moderator's main responsibilities are as follows:
 - (i) Appointing Deputy Moderators.

- (ii) Making sure that elections are properly conducted for the community. They may give the responsibility to hold the elections themselves to other moderators, primarily the Election Chief.
- (iii) Maintaining the community registry.
- (iv) The Head Moderator has all of the powers of the lower moderative offices EXCEPT the power to petition and remove the Head Moderator.
- (e) The Head Moderator may set an membership requirement to start a political party, this requirement shall not be higher than 5.

Section 3: Deputy Moderators

- (a) The Deputy Moderators will be appointed by the Head Moderator and are indefinite roles (no term length/limit). They may do the work of the Head Moderator, should they delegate it to them, excluding appointing new moderators.
- (b) The Deputy Moderators can have other offices, but if the community feels like this affects their credibility or fairness in their role as moderator. They must resign as either moderator or the other roles. If they refuse, this is grounds for a recall.
 - (i) This rule can be overruled by the legislature with a 65%-majority vote and reimplemented with a 50%-vote.
- (c) They possess the following powers:
 - (i) Ban people from all DemoHOI4 official subreddits, discords, and streams for a maximum time of a month.
 - (ii) Mute/Ban from official Discord servers within their jurisdiction. The accused can appeal his ban to the Supreme Court if he/she disagrees with it.
- (iii) Delete posts/comments that break the rules of Reddit or the sub.

Section 4: Election Chief

1. One of the Moderators (Head, Deputy or Assistant) will be appointed to the position of "Election Chief",

whose primary responsibility it is to carry out elections in the DemoHOI4 community.

- a. The Election Chief may be appointed directly by the Head Moderator or by a %-vote by the deputy moderators.
- b. The elections that the Election Chief is responsible for includes: Legislature, supreme court and national elections.
 - i. A nation can choose to conduct its elections internally instead.
- c. If the Election Chief fails to carry out their responsibility, they may be immediately replaced by another Moderator.
- d. In the event that the Election Chief is a candidate for an election, a new Election Chief must be chosen for that election and that election only.

Section 5: Elections and Removal of Moderation

- 1. In case of a resignation or recall of the Head Moderator, a point-based system will be used to elect a new Head Moderator. Voters can give each candidate between 1 and 3 points. The candidate with the highest score is elected. The deputy moderators may then be replaced by new ones or kept. The runner-up candidate should be appointed as a deputy moderator as a sign of good faith.
 - a. A moderator election townhall reddit post will have to be posted within 72 hours of the Head Moderator announcing his resignation or being recalled.
 - b. In the case that the Head Moderator resigns or is fully recalled before the vote is publicly available, the Triumvirate will take over until the election is concluded.
 - c. All Head Moderator candidates shall be treated as citizens while the vote is being taken, any Deputy Moderators, Assistant Moderators, or

Acting Head Moderators who are also candidates should refrain from viewing the results of the election before the results are publicly announced.

- 2. A recall of the Head Moderator will start with a petition from either % of the Triumvirate or 10 percent of all citizens signing it.
 - a. Once this recall has been initiated, the Supreme Court must approve the petition by half its members.
 - b. Legitimate reasons to approve it include inactivity, misconduct, or any general offense against DemoHOI4. The Judiciary has the final decision on the validity of the reason.
 - c. If the reason is ruled as legitimate, a general referendum for the recall will be held by the Triumvirate for three two days. If the majority (60% + 1) of voters vote to recall the Head Moderator, the Head Moderator is recalled.
- 3. A Deputy Moderator can be removed at will by the Head Moderator and one (1) other Deputy Moderator. He/she can also be recalled using the steps above, however there is no election to replace him/her. The Head Moderator will replace the recalled Deputy Moderator.

Article 2: Community Registry

Section 1: Citizens

- A. The term "citizen" is hereby defined to be a member of the community who has voted in one of two of the most recent voting sessions in their chosen nation.
- B. The Moderation shall create a simple registration form for new members to the community to register as a citizen in one of the played nations in-game. The registrations shall be added to the community registry.

- C. The Moderation must then upkeep (marking inactive voters as such, fixing any errors and any other relevant tasks) a "community registry" of all eligible citizens at minimum every four days.
- D. To vote in any elections you must be on this community registry.
- E. If a citizen is marked as inactive, if the citizen votes again, the inactive mark is removed.
- F. The registry shall contain a list for each nation, listing its citizens.
 - a. These lists is to hold the following information:
 - i. Reddit Username
 - ii. The Nation in which the citizen is part of
 - iii. Most Recent Election the citizen voted in
 - 1. Exceptions to this rule can be made if there are less than 5 days between elections.
 - iv. If the citizen is inactive or not
- G. If a citizen has not voted in two elections in their nation in a row. The citizen will be marked as inactive and will no longer be counted as a "citizen" as some rules requires in this document.
- H. A citizen can change in which nation they have citizenship in, to do this they must apply for citizenship change at a moderator, then wait 4 days to be able to vote in a nation-specific election.
- I. The use of the term "all citizens" only counts active citizens, excluding those marked as inactive.

Article 3: Supreme Legislature

Section 1: Legislative Powers

- 1. The Supreme Legislature is the legislature for DemoHOI4, their objective is to make metagame laws.
- 2. It can create laws by passing bills voted upon the members of the legislature, called legislators. A bill require a 50% + 1 vote to be passed. Laws can also be repealed with a 50% + 1 vote.

- a. The legislature is strictly forbidden to take sides in politics or force decisions by certain nations when making laws.
- b. Any amendments to previous laws, should be considered a normal law and go through the standard process.
- 3. The laws passed by the legislature can't contradict the constitution, if they do, the constitution will always take priority.
- 4. In the event of a tie in decision making within the legislature, the Speaker will cast the deciding vote.
 - a. If there is no speaker, the vote will be postponed until there is one.

Section 2: Legislature Specifics

- 1. The Legislature will operate on a two-week election cycle. There are no term limits, as to keep trained Legislators in.
- 2. Legislators can be recalled from office for inactivity or misconduct by first making a petition with 10% of all citizens signing it. Then the Supreme Court must approve the petition by half its members. After that, the recall will be put up to a public referendum, where 60% of voters must approve it. Their seat in the legislature is thereafter up for reelection within 3 days.
- 3. Legislators are elected via a point-based system. Voters can give each candidate between 1 and 3 points. The candidates with the highest scores are elected as long as there are empty seats.
- 4. Legislators are automatically recalled should they miss three sessions in a week or two sessions in a row within their term.
- 5. The number of legislator seats will be 10 if the number of citizens is above 70. If the number of citizens is below 70, legislator seats will be 5. Unless changed with laws, in which case those laws override this rule.
- 6. If the legislature has fewer than 3 legislators, the legislature is declared as non-working and can't pass bills.

- 7. If a Legislator has broken Rule 2a of Section 1 of this article. They will be automatically recalled and their seat be reelected.
- 8. The seats of resigning Legislators shall also be up for reelection.

Section 3: Speaker

- 1. The Legislature shall elect a Speaker via simple majority vote. This Speaker is responsible to:
 - a. Organize debate and voting sessions
 - b. Create an agenda for voting on these sessions
 - c. Setup voting in the subreddit
 - d. Announce sessions and the agenda.
 - e. Announce results of a session after it is finished.
 - f. Retain a record of all laws and their status (passed, failed or repealed).
- 2. The Speaker can be recalled by legislature with a 65%-vote, they will retain their legislator seat.
- 3. The Speaker may also create positions such as Vice Speaker or Secretary to assist them in their responsibilities. These positions are inferior to the Speaker and can be overridden by him/her.

Section 4: Sessions

- 1. The Speaker must announce when a session is beginning, this session is recommended to be 2-day long. This session must start with one-day debate period, in which bills are proposed and debated upon.
 - a. For a bill to be voted upon, it must receive 1 sponsor other than the bill creator. Sponsors must be legislators. The bill must receive a sponsor before the debate sessions ends. The bill creator is counted automatically as a sponsor, in total there are 2 sponsors.

- 2. Once the debate session ends, the Speaker must create a list of bills to be voted on (the agenda) and post it on the subreddit of the Legislature and announce it. Then the legislature votes for 24 hours, and after the voting is done, the Speaker check which bills passed, failed, or were repealed.
- 3. Using this system, there shall be a break between sessions lasting at least 1 day.

Article 4: Elections

Section 1: Election Types

- A. To vote, one must be a citizen and one can only vote in an election held in their nation. The only exceptions are metagame referendums and recalls for metagame positions.
- B. All elections shall have a town hall posted on the main subreddit for 1 day minimum (recommended 2) and a voting time of 24 hours. Whoever is in charge of the election must then release the results in a Reddit post within one day. A national constitution may override this rule.
- C. Participation in nation-specific town halls and voting threads are limited to citizens of that nation. Offending posters may have their comments/posts removed.
- D. Any person elected to fill the role of a person who was recalled, resigned or otherwise left office prior to their term ending will occupy that office for the term of the previous holder, unless the remainder of the term is less than 25% of the total length. In that case, the person is elected for the next term as well.
- E. Referendums will use simple majority voting. In this, something will pass if it receives 50% + 1 of citizens voting on it.
- F. Justices are elected via a point-based system. Voters can give each candidate between 1 and 3 points. The candidates with the highest scores are elected as long as there are empty seats.

G. The exact timing of the FIRST election is up to the Head Moderator's discretion. After this, however, the term lengths will decide the election dates.

Section 2: Election for offices

- A. The Election Chief or another moderator, at LEAST 2 days before the election, must make a candidacy announcement thread for candidates to announce on.
- B. There shall be a town hall thread 24 hours before the ballot in which voters may ask candidates questions.
 - a. If there are 5 or more candidates for a specific office (example: German Government Official). A candidate must answer one question at least to be qualified for the election. If no questions are asked, then no questions need to be answered.
- C. The voting period after the debates shall last 24 hours exactly. After this a moderator shall post the results to the main subreddit.

Section 3: Dual Mandate

- A. No person shall hold offices within more than one nation.
- B. If a position is non-nation specific (metagame position), you can hold that position together with a position within a national government.
- C. A justice cannot also be a government official nor a supreme legislator.
- D. A moderator cannot be a justice in the supreme court.

Article 5: Judiciary

Section 1: The Supreme Court

- A. A Supreme Court for the DemoHOI4 community is established, consisting of 3 elected justices, when below 50 citizens.

 Up to 5 justices, when above 50 citizens.
- B. The court's purpose is to keep the power of the Moderators in check, interpreting the constitution, ruling on recalls and appeals. The court is also the general way of solving disputes with a legal basis, rather than bringing it to the moderation and can hear cases not specified in this document.
- C. Another possible purpose of the court is making sure the national governments adhere to this document or their national constitution. This purpose can be overridden and removed by a government vote or a national constitution.
 - a. This purpose can be overridden and removed by a government vote or a national constitution. This purpose can be reinstated with another government vote, if it doesn't conflict with the national constitution.
 - b. The Head Moderator and a majority of the justices can reinstate this purpose, if it's deemed vital to the game experience. The national government can't overrule this decision. The court may voluntarily remove the purpose again though with a majority vote.
- D. Any citizen can file a case for the things mentioned in B and C.
- E. The court can overturn any Moderation decisions with a 75% vote, as well as remove any member of the moderation with a 100% vote.
- F. The justices are elected for life. If they resign, their seat will be reelected.
- G. To recall a justice, 10% of all citizens must sign a petition to be remove a justice, which will then be put to a 65%-majority public referendum.
- H. If a justice fails to vote in 3 cases in a row within a week, they are automatically recalled for inactivity.
- I. Should a justice be recalled or have resigned, the Moderation will begin an immediate reelection to fill the seat.

- J. If the court is below 3 justices, the court is declared as non-working and can't rule on cases. They still have the right to rule on recalls if there are 2 justices.
- K. The Legislature can write laws to change or add types of punishments the court can issue.
- L. In the event that the court finds an individual or set of individuals guilty of violating the law or constitution it may issue the following punishments depending on severity. The legislature can write law to specify the situations/actions that need to be undertaken to merit the below punishments.
 - a. Private warning to the individuals that further illegal/unconstitutional actions will have greater consequences in the future.
 - b. Public denouncement of the individuals for their actions.
 - c. Recall for their role.
 - d. Ban from holding government office for any number of elections.
- M. A justice must recuse themselves if they are the topic of a vote or case.

Section 2: The International Court

- A. A court will be set up dealing with in-game disputes. This will be the International Court.
- B. It will consist of all the supreme court justices and the chief diplomats of all nations. If a chief diplomat is unavailable, the nation may send another government official as a proxy.
- C. Any decision made must be approved by a 65%-majority in the court.
- D. The Supreme Court justices in this court must be extra careful to not have bias towards any party and must remain neutral and factual.
- E. Punishments issued by the court are non-binding and can be avoided by the nations.

Section 3: Constitutional Oversight

A. /u/RB33z (RB33) as the writer of the majority of this constitution will be appointed as a justice to the supreme court at the start of the game. To ensure the constitution is obeyed in the ways intended and being able to clarify his intent in writing it. He is able to resign and be recalled in this role. He has an exception to the dual mandate rules, so that he can serve in the moderation and as a justice at the same time.

Article 6: Executive

Section 1: National Governments

- A. Every player-controlled country in-game shall have a national government. This government consists of at minimum 3 officials. These officials must be citizens of that nation.
- B. Two required roles for this government are the "Head of State" and the "Chief Diplomat". These positions should be filled by members of the government. If these positions are elected by the public or agreed upon by the government is left up to the governments to decide.
- C. The Head of State is the symbolic face of the nation. This doesn't require any formal responsibilities but this official should act with leadership guiding their government and citizens.
- D. The Chief Diplomat is the face of his country's diplomatic efforts, they don't have to personally talk with their counterparts or make deals. But it's expected that they oversee this process.
- E. One government official shall control their nation in-game and may have additional officials to support them in-game in doing this.

- F. A government has the right to adopt a national constitution. The national constitution does not override this document unless specified.
- G. Once a national constitution is adopted, the government officials can amend it with a 75% vote. This rule is in-effect unless explicitly revoked in the national constitution.
- H. Amendments to the national constitution can also be put to a 60%-majority public referendum. This can be done by the government with a 50% vote or by a citizen's petition with 15% of the citizens signing it. This rule is in-effect unless explicitly revoked in the national constitution.
- I. Governments have the right to appoint a citizen as a governor of a puppet in-game or parts of the former government of a player-controlled nation as a puppet government.
- J. A country can revert its constitution back to the national government framework outlined in the constitution. This will be put to a 66%-majority public referendum. This can be done by the government with a 75% vote or by a citizen's petition with 15% of the citizens signing it. This rule cannot be revoked in the national constitution.

Section 2: National Government Framework

- A. This section is used for governing nations unless a national constitution overrides the entirety or parts of it. This is the only section able to be overridden by a national constitution in this document, unless specified otherwise.
- B. Government officials are elected by a nation's citizens using a point-based system. Voters can give each candidate between 1 and 3 points. The candidates with the highest scores are elected as long as there are empty seats.
- C. A nation can at max have 5 government officials.
- D. In a nation's first election, the Head of State is elected by the citizens. The elected Head of State will then appoint one of the other officials to be the Chief

- Diplomat. The government shall then decide how future appointments of the Head of State and Chief Diplomat be done. This decision can be overridden by future governments.
- E. The government will face election every 2 weeks. There are no term limits.
- F. A new national constitution must be approved in a simple majority (50%) referendum by the nation's citizens.
- G. The national government answer to the Supreme Court if it fails to adhere to this document or the national constitution. Unless the officials override this rule with a 75% vote, if overridden, this rule can be reinstated with a 60% vote.
- H. To recall a government or specific officials, 10% of all citizens must sign a petition to remove them, which will then be put to a 65%-majority public referendum.
- I. The government can enact a coup with a 75% vote by the officials. Which means that elections are suspended until a referendum is set up to approve the coup-government, if the citizens fail to disapprove the government with 60% of the votes. The coup-government will remain in-power, all future elections are suspended and they can set up a national constitution without further public approval. Should the citizens disapprove the coup-government with 60+% of the vote, they are disposed and new elections are held to replace them. Coups are limited to one for each term (2 weeks).

Article 7: The Community

Section 1: The Establishment of the DemoHOI4 Hub

- A. r/DemoHOI4 is to serve as the hub for all affiliated subreddits. r/DemoHOI4 can also be referred to as "The Hub".
- B. The Hub shall host content pertinent to all nations, ie a. Play session reports (summary of what has happened)

- b. Elections and referendums taking place
- c. Important announcements to the community
- C. There shall be several core subreddits/servers.
 - a./r/demohoi4 for general discussion, voting, etc. This
 is the main subreddit.
 - b./r/demohoi4legislature for the legislature to post bills and vote.
 - c./r/demohoi4judicial for the judicial branch to post rulings and decisions.
 - d. The official Discord server (link here) for the governmental working and discussion.

Section 2: Rights of the People

- A. Every person is equal in front of the law.
 - a. This means there shall be no law nor article in the constitution discriminating for one group, nor discrimination of any kind is allowed.
- B. Every person is guaranteed the right to speak their opinion in reasonable discussions on Discord and on Reddit without punishment. This includes any type of roleplaying propaganda.
 - a. This excludes hate speech, spam, slander, posting in the wrong channel or national channel/thread. It is up to Moderation to determine what counts as an offense here. Moderation may ban or mute the offending person for at maximum a month. More severe punishments will have to be approved by the supreme court on a case-by-case basis with a 65%-vote. If a punished party feels that they have been treated unfairly, they can appeal their punishment to the Supreme Court.
- C. False reporting of legal speech/press is illegal and punishable by Moderation.
- D. The Press will have the right to publish any article, bias or not.
- E. However, the Head Moderator can stop the publication or take an article down if he/she deems it hate speech.

- F. Every person has the right to join whatever parties they want, unless forbidden by a national constitution. Being a member of multiple national parties and multiple international parties is forbidden however being member of one national and one international party is allowed.
- G. Everything in this section applies to opposing the constitution and every entity in it.
- H. A punished citizen/party/group have the right to appeal their punishment to the Supreme Court, if they feel that they have been treated unfairly.
- I. A citizen is entitled to a Discord 'Tag' to denote the Political Party to which they are a member within their Nation's National Discord.
 - a. The Server Admins (Defined as those who can distribute tags) should be notified in a reasonable manner as to the party an individual belongs to.
 - b. This is true for both National and International Political Parties.
- J. To dismantle a Political Party, there must be a simple majoritarian vote on the issue. This vote must meet the requirements defined below.
 - a. Only members of the political party at the time of the vote's creation are eligible to vote.
 - b. The vote has to be open for a minimum of 1 day (recommended 2).
 - c. The vote has to be brought to the attention of the individual party members (An Announcement post within the primary DemoHOI4 Discord will suffice)
 - d. The winner of the vote is the outcome that receives +50% of the votes will win.
 - e. A second requirement of 30% of the total active members of the party most have voted for the dismantlement in the election.
- K. As a core right as a member of the community, a citizen of any country may not have their citizenship revoked. Only a ban from the entire community may effectively do this, which will be lifted, when the ban expires.

- L. A national court does not have the authority to give metagame punishments (such as community-wide bans), only a metagame court can have this right.
- M. Moderation may ban or mute as punishment if there are valid causes for at maximum a month. More severe punishments will have to be approved by the supreme court on a case-by-case basis with a 65%-vote. If a punished party feels that they have been treated unfairly, they can appeal their punishment to the Supreme Court. If you're unable to appeal yourself, a proxy may appeal for you with your permission.
- N. You are forbidden from registering an alternate account (separate from your main account) as a citizen in the DemoHOI4 community and actively participate in elections and government as such.
 - a. If you're determined guilty by the Moderation, you shall be banned at minimum 1 day as a warning and up to a permanent ban if approved by the Supreme Court, if you have caused enough major disruption to the community.
- O. Intentionally causing disruption and chaos on a major scale to the community, for which the state of the community suffer large damage can result in temporary and permanent bans from the community. This ability should be used with caution and reserved for only very serious cases. This is appealable to the Supreme Court as with everything else.

Article 8: Amendments

Section 1: Amending the Constitution

- A. This Constitution may be amended by the people if they so wish. However, they should only do so if the desired changes are impossible to do with laws. The legislature does not have the power to amend this Constitution.
- B. To start an amendment, 10 percent of all citizens (rounded up) must sign a petition to do so. Once that happens, Moderation must immediately hold a referendum on the

- amendment that lasts $\frac{\text{three}}{\text{two}}$ two days. A supermajority (% or 66%) of voters must vote yea to the amendment for it to pass.
- C. Alternatively, a lower-priority referendum which only requires 5 percent of all citizens (rounded up) signing a petition is used if the 10 percent is not reached. Once that happens, if the next public election is within 7 days, the Moderation can wait to hold a referendum on the amendment until then.
- D. Different versions of the same amendment can be in one petition, all of these will be voted upon, the version with largest percentage of approval will be passed, while the other versions will be disregarded. If the percentage is equal, another referendum will be arranged between the versions with equal percentages.

Section 2: Protectors

- A. This Constitution hereby creates the office of Protector. A Protector keeps their own separate copies of this Constitution.
 - B. The four Protectors shall be /u/RB33z (RB33), /u/Leldy22 (Leldy), /u/Asgore_Dreemurr (OboDerf), and /u/LightGalaxy (Alex).

Section 3: Emergency Amendments

- A. The Protectors may make an emergency change to this Constitution if a constitutional crisis and such happens. However, it is STRONGLY advised that anything NOT URGENT be done through the means in Article 8, Section 1.
 - a. Each Protector makes the change to his/her copy. Then the Moderation team must make an announcement in the Discord AND main subreddit.
 - b. After that is done, the amendment comes into effect for THREE DAYS. Before these three days finish, Moderation must hold a referendum for at least 24 hours. Voters must vote on whether to keep this

emergency amendment or not. It requires a 60%-majority vote to stay.

Section 4: Simple Constitutional Fixes

- A. If this Constitution is found to have awkward wording or a spelling error after it is ratified, the Moderation team can request a simple constitutional fix to fix the small error. The Protectors vote on the fix (its legality) with a 65%-vote and then change the current Constitution Draft (not the official version) It is reviewed again and then must be put into the official Constitution within 24 hours. The Moderation team does not have to tell the public, but it is strongly advised to do so.
 - a. A simple constitutional fix MUST ONLY change the wording or spelling. It CANNOT change the interpretation, AT ALL. This is grounds for a recall if so.

<u>Section 5: Early Ratification Amendments</u>

A. If a change is found to be needed within the first two weeks of this Constitution being ratified, % of the Protectors can agree to a change being made and the change will be made in each Protector's copy. After the 14th day of this Constitution being ratified, this type of amendment no longer applies and is null.

Section 6: Amendment/Constitution Contradictions

A. If an amendment contradicts the constitution in any way, the amendment will overrule the constitution.

Article 9: The Game

Section 1: Basics

- A. Before the game starts, the community will debate and make a decision about which countries are to be played and which mods are to be used. As well as other necessary topics that might arise. This process include making the agreed-upon changes to Section 2.
- B. Once started, the game can be prematurely cancelled, if the active community vote to do so in a 70%-majority referendum.
 - a. This referendum is called by first making a petition with 10% of all citizens signing it. Alternatively, it can be called by the Head Moderator or with a 50%-vote by the legislature. The referendum can be held max once every two weeks.
- C. If a game is won, lost or cancelled, the community shall again repeat the steps listed in A.
- D. The things listed in Section 2 are specific to a particular playthrough and its contents may be changed with a 60%-majority referendum.
 - a. But only if there is no active game ongoing, unless there is a critical need for an urgent change. In which case, a referendum can take place. The validity of this need will have to be approved by the Supreme Court, if it has at least 3 justices. Otherwise the decision is up to the Head Moderator.
- E. The goal is to play the game (HOI4) once a week, playing at maximum one (1) year in-game at a time.

Section 2: Specifics

- A. The game will have the following nations played: Soviet Union, Germany, United Kingdom and Ireland
- B. All non-player major nations will have their custom difficulty bonus set to the medium difficulty (25%+ entrenchment speed, etc), while all player nations will have no custom difficulty bonus set. The general difficulty setting will be set to regular.
- C. The game shall be played on the Gathering Storm Scenario (1936 start).

- D. The game will be played with the following mods: Player-led Peace Conferences and Road to 56
- E. The game will be played with historical AI focuses disabled and hotjoin and cooperative settings enabled.
 - F. The game will be played with the following DLCs: Together for Victory, Poland United and Ready DLC and the Death or Dishonor DLC.
- G. Rule F will be expanded after ratification with appropriate DLCs once those DLCs have been released. This can be done with a 50%-majority legislature vote or a 100%-supreme court vote.

Article 10: Ratification

Section 1: Ratification

- A. This Constitution in its entirety will be enacted and ratified if a majority of the active DemoHOI4 community vote to do so.
- B. At the same time as this constitution is ratified, a Head Moderator will be elected.
- C. Once this Constitution is ratified, all DemoHOI4 subreddits and servers will be changed to adhere to this constitution and the new Head Moderator is put in charge. Immediately after, the new Head Moderator must appoint his Deputy Moderators and start planning elections for all elected positions.
 - D. This constitution was ratified on Monday the 12th of June 2017 at Midnight.
