#### Overview

In 2024, there was no formal participation of Cagayan State University – Sanchez Mira Campus (CSU-SM) in any policy-making activity specifically addressing poverty. The campus' focus during the year was on the continued implementation of its community-centered extension initiatives — SAGUT para iti Kaniyogan and SARANAY — which laid the groundwork for multi-sectoral collaboration and evidence generation for future policy alignment.

However, this preparatory work culminated in **October 2025**, when CSU–Sanchez Mira Campus spearheaded a stakeholder consultation aimed at integrating sustainable livelihood, agricultural innovation, and poverty reduction strategies into the municipal development framework of Sanchez Mira, Cagayan.

The consultation served as the formal platform for CSU-SM's entry into policy-related activities, particularly in developing localized frameworks to support the United Nations Sustainable Development Goals (SDGs) — notably SDG 1 (No Poverty), SDG 2 (Zero Hunger), SDG 8 (Decent Work and Economic Growth), and SDG 13 (Climate Action).

# **Consultation Impact and Policy Linkage**

The October 2025 consultation resulted in the following policy-linked outcomes:

- Drafting of a proposed municipal ordinance for sustainable coconut replanting and intercropping.
- LGU commitment to institutionalize agricultural innovation hubs in partnership with CSU-Sanchez Mira.
- Integration of CSU's SAGUT and SARANAY programs into LGU livelihood and poverty reduction plans.

• Establishment of a multi-sectoral technical working group to oversee policy recommendations and program implementation.

These actions demonstrate CSU-Sanchez Mira's growing influence as a policy partner and technical authority for inclusive and sustainable rural development in Northwestern Cagayan.

# **Narrative Summary**

In 2024, Cagayan State University – Sanchez Mira Campus concentrated on strengthening its grassroots engagement through the SAGUT para iti Kaniyogan and SARANAY programs, which established a strong foundation for future policy participation.

The university's formal involvement in poverty-related policymaking began in October 2025, through a landmark stakeholder consultation that brought together local government, the academe, cooperatives, and financial institutions. The consultation facilitated dialogue on agricultural innovation, livelihood diversification, and climate resilience, leading to concrete policy proposals such as the drafting of a municipal ordinance on sustainable coconut farming and the institutionalization of community-based agricultural hubs.

While CSU–Sanchez Mira earned no points for 2024 under Indicator 1.4.4 due to the absence of policy participation that year, the succeeding year's achievements affirm the campus's growing leadership role in policy-driven, evidence-based community development and in advancing the goals of SDG 1: No Poverty within the local context.
