Abstract

Articles must follow the author guidelines. The **Article title** must be written in English, consist of a maximum of 15 words, and be able to concisely and clearly reflect the main theme and scope of the article. Avoid using initial words like "Study," "Research," "Analysis," or "Development," unless they are truly necessary for clarity of meaning. The **Abstract** is written in 2 languages (English and Indonesian/Arabic). The abstract should provide an overview of the article's content and should be approximately **130 words** long. It is recommended that the abstract be written following a narrative flow: starting with a surprising or thought-provoking contextual statement, followed by a formulation of the research objectives, a brief explanation of the methods used, and concluding with the main findings or significant contributions of the study. **Keywords** must consist of five words, reflecting the core theme, essential concepts, or methodological approach used.

Authors are advised to compose the introduction as four to six, coherent, and logically structured paragraph, following this narrative flow: begin with a crucial issue or phenomenon relevant to the field of study, preferably presented as a social fact or shocking statement to capture the reader's attention. Next, the author must provide a strong literature review, citing at least seven previous studies, preferably from Scopus-indexed journals, to establish the study's position within a credible academic framework. This review should aim to build the scientific context, highlight the research gap, and avoid redundancy. After this, the main objective of the study should be clearly stated. The paragraph should conclude by presenting the theoretical assumptions, central argument, or research hypothesis that will be examined or elaborated upon in the article. The writing must maintain argumentative coherence, avoid superficial or disjointed citations, and clearly demonstrate the connection between the background problem, the literature context, and the study's contribution.¹

Method

BIBLIOGRAPHY

The bibliography section of this journal must include a minimum of **30 scholarly sources** used in the writing, with at least 70% coming from peer-reviewed journals or reputable academic books. Authors are required to use Mendeley for citation management, following the **Chicago Manual of Style 17th edition (full note)** format. Citation usage should be proportional and relevant, avoiding excessive self-citation and unnecessary regionally focused references to maintain the quality and objectivity of the sources in the scholarly work. The bibliography should be organized neatly and consistently according to the specified format to facilitate verification and ease of reading by both readers and reviewers.
