#DefendDueProcess Toolkit

Update: The stop work order on LOP, ICH, FGLOP, and CCI has been lifted due to ongoing litigation. On February 3rd we have resumed full operations on all DOJ programs! As such, we ask that you pause using this toolkit for now.

Background

On January 22, 2025, the Department of Justice instructed Acacia Center for Justice to abruptly halt work on several legal access programs that serve children, adults, and families at risk of deportation. The impacted programs include the Legal Orientation Program for detained adults (LOP), Immigration Court Helpdesk (ICH), Counsel for Children Initiative (CCI) and Family Group Legal Orientation Program (FGLOP).

This decision comes amidst a flurry of policies intended to ramp up raids, deportation, and detention. Together, we can mobilize a grassroots response to defend our programs.


Opportunities for Collaboration
