Attendance, Liability & Media Waiver

In consideration for being allowed to attend and participate in the JNM Football and Select Generation Budapest Showcase 2026 (the "Event"), taking place on 30–31 May 2026 in Budapest, Hungary, I, the undersigned, acknowledge and agree to all of the following terms. I have read this document in full, fully understand its terms, understand that I am giving up substantial rights by signing it, and sign it freely and voluntarily without inducement.

1. ATTENDANCE COMMITMENT

I confirm that I intend to attend the Event on the dates stated above. I understand that my confirmed place has been reserved specifically for me and that my absence directly affects the quality and organisation of the Event for other participants.

2. NO-SHOW POLICY

I acknowledge and agree to the following:

- If I confirm attendance and subsequently fail to attend the Event without providing at least 120 hours' (5 days') written notice, JNM Football reserves the right to charge a no-show penalty fee of £100.
- This fee will be charged to the payment method provided at registration.
- Notice of non-attendance must be submitted in writing by email to contact@jnmfootball.com. Verbal notice is not accepted.
- This policy exists to protect the integrity of the Event, ensure fairness to all participants, and recover costs associated with places that cannot be reallocated at short notice.

3. PHYSICAL FITNESS & MEDICAL DECLARATION

I confirm that I am in proper physical condition to participate in football activities and the physical demands of the Event, and that I have no illness, disease, existing injury, or physical defect that would be aggravated by my participation. I will disclose any relevant medical conditions to the Event organisers prior to participating if I believe they may affect the safety of myself or others. I accept full responsibility for ensuring I am medically fit to participate.

4. RELEASE OF LIABILITY & ASSUMPTION OF RISK

I understand and acknowledge that football and physical activity carry inherent risks of injury. I voluntarily assume all such risks associated with my participation in the Event.

I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS:

- JNM Football, its directors, officers, staff, agents, volunteers, and representatives;
- Select Generation, its directors, officers, staff, agents, volunteers, and representatives;
- Any venue, facility, or third-party supplier engaged in connection with the Event;

(together, the "Released Parties") from any and all claims, demands, losses, damages, and liabilities arising out of or related to any INJURY, ILLNESS, DISABILITY, DEATH, OR PROPERTY DAMAGE that I or any third party may suffer as a result of my participation in the Event, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE, to the fullest extent permitted by applicable law.

5. PAYMENT & REFUND POLICY

I acknowledge that Event fees are non-refundable once payment has been made, except where the Event is cancelled by the organisers, in which case a full refund will be issued within 14 days. In exceptional circumstances such as a medical emergency supported by documentation, a partial or full refund may be considered at the sole discretion of JNM Football.

6. MEDIA & IMAGE CONSENT

I authorise JNM Football and Select Generation and/or their agents to record, photograph, and use footage or images of me captured during the Event for promotional, commercial, editorial, and social media purposes without compensation. I understand that I may request the removal of specific images or footage by contacting contact@jnmfootball.com, and such requests will be considered in accordance with applicable data protection legislation including UK GDPR and EU GDPR.

7. DATA PROTECTION

I consent to JNM Football and Select Generation collecting, storing, and processing my personal data (including name, email address, phone number, and payment details) for the purposes of organising and administering the Event, in accordance with applicable data protection legislation. My personal data will not be shared with third parties outside of those directly involved in delivering the Event without my prior consent, except where required by law.

8. GOVERNING LAW

This Agreement is governed by the laws of England and Wales. Any disputes arising from or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of England and Wales.
