2025-07-01. Welcome

Clerk Gloria Thompson (Manhattan) welcomed Friends to our 331st Summer Sessions. Gloria raised up our theme: Dare to Hope! Dare to Heal! Dare to Witness! We then entered into a period of worship, during which Gloria read a quote from Francis of Sales: "Prayer opens the understanding to the brightness of Divine Light, and the will to the warmth of Heavenly Love----nothing can so effectually purify the mind from its ignorances, or the will from its perverse affections. It is as a healing water which causes the roots of our good desires to send forth fresh shoots, which washes away the soul's imperfections, and allays the thirst of passion."

2025-07-02. Reading

2025-07-03. Introduction and Agenda

Gloria introduced the Clerk's Table and reviewed the agenda.

2025-07-04. Land Acknowledgement

Brendan Glynn (Brooklyn), from Indigenous Affairs Committee, read the <u>Land Acknowledgement</u>.

2025-07-05. Roll Call

Marvea Thompson (Brooklyn) read the roll call.

2025-07-06. Visitors

The clerk invited visitors to introduce themselves. Tom Rothschild, of Strawberry Creek Meeting, Pacific Yearly Meeting, and Kathleen Wooten, from New England Yearly Meeting, introduced themselves.

2025-07-07. Continuing Quaker Education

General Secretary Steve Mohlke (Ithaca) brought Continuing Quaker Education on the topic, "Why Can't I Stand In The Way?" Steve shared his understanding that Quaker decisions are

decisions of the group, noting that "Individuals have a responsibility to share their truth and raise concerns after a proposal is made. After speaking, the individual releases it to the whole group. The group needs to discern whether what has been said prevents it from moving forward on the matter under consideration." Friends shared concerns and ministry.

2025-07-08. Epistle from Bhopal Yearly Meeting

Carol Clarke (Ithaca), from the Epistle Committee, read the epistle from **Bhopal Yearly Meeting**.

2025-07-09 Annual Meeting of the Corporation

This section of our Meeting for Business opened the Annual Meeting of the Corporation. Clerk of Trustees Mary Harpster (Rahway and Plainfield) summarized the <u>Annual Report of the Corporation</u>. The Trustees' full report was included in the Supporting Documents.

2025-07-10. Nominations to Trustees

Jill McLellan (Buffalo) brought two nominations of Friends for service on the NYYM Board of Trustees.

Friends approved these appointments.

With this approval, the Annual Meeting of the Corporation was closed, as required by our By-Laws.

2025-07-11. Task Group on Racism

Anne Pomeroy (New Paltz and Brooklyn 9am meetings), from Ministry Coordinating Committee, introduced John Choe (Flushing) and Rebekah Rice (Saratoga), who brought an update on the structure of the Task Group on Racism.

Rebekah Rice read a minute prepared by the Task Group.

The Task Group on Racism, under the care of the Ministry Coordinating Committee in collaboration with Witness Coordinating Committee, met as a group of representatives from NYYM committees who share a concern for racial healing and justice and for addressing racism within the Yearly Meeting in all its forms: interpersonal, structural, and identity. Members are from MCC, WCC, GSCC, Racial Justice Center, Indigenous Affairs, Euro-American Quakers Working to End Racism (EAQWER), Good Trouble, Prisons, Another World is Possible, Black Concerns, Barrington-Dunbar, and NYYM staff. Others are welcome: contact Rebekah Rice < rebekahrrice@gmail.com>. Does NYYM affirm the new formation of the Task Group on Racism or have any ministry, questions, concerns or blessing to share now?

In response to a question, Rebekah and John summarized the current and forthcoming work of the Task Group. The Task Group welcomes participation from interested Friends, and encourages more participation from Friends of Color. They are still looking for a representative from General Services Coordinating Committee, and hope that will be confirmed soon. Friends shared suggestions for the direction of the Task Group. Friends affirmed the report of the Task Group.

2025-07-12. Introduction of Treasurer

Robin Gowin (New Brunswick), Clerk of General Services Committee, introduced the Treasurer.

2025-07-13. Treasurer's Report

NYYM Treasurer Laura Cisar (New Brunswick) brought the <u>June 2025 Treasurer's Report</u>. With half of the fiscal year completed, we are running a deficit of \$77,828, compared to June 2024 when the deficit was \$18,581. At the end of June, NYYM had received 30.9% of monthly meeting contributions. The percent of budgeted monthly meeting contributions has increased to 45% through additional contributions received so far in July. The available operating reserve is \$299,243.48. The current balance of the Sharing Fund is \$71,312.49, and the current balance of the Designated Use Funds is \$57,058.86. The value of NYYM Invested Funds at the end of June 2025 was \$6,993,034. The Lindley Murray Trust, which is now under the Trusteeship of Friends Fiduciary Corporation, will no longer be reported by NYYM. In response to a question, Laura noted that Trustees are looking at the yearly meeting's structural deficit and are considering remedies.

2025-07-14. Minutes approved

Lu Harper (Rochester) read the minutes. Friends approved the minutes.

2025-07-15. Jim Atwell announcement

Buffy Curtis announced recently-received news of the passing of Jim Atwell (Butternuts).

2025-07-16. Closing worship

As Friends entered into closing worship, Gloria read a passage from Noel Palmer's book, *Daily Notes to God*.

2025-07-17. Closing and Online Meetinghouse

Meeting for Business closed as Friends transitioned into the first session of a new experiment, the Online Meetinghouse, a space for Friends to connect online after our times of worship and business.

2025-07-17. Welcome and Readings

The meeting began with a period of worship. Out of the silence, Clerk Fred Dettmer read this passage:

In such a world as ours today, no light glib word of hope dare be spoken.... Only if we look long and deeply into the abyss of despair do we dare to speak of hope.... We dare not tell people to hope in God... unless we know what it means to have absolutely no other hope but in God. But as we know something of such a profound and amazing assurance, clear at the depths of our beings, then we dare to proclaim it boldly in the midst of a world aflame.

He read from Faith and Practice:

We look with tender hearts, especially during meetings for worship with a concern for business, for one another's spiritual vision. Truths of the Spirit may come from any of us. - Faith & Practice, 2020 Edition. New York Yearly Meeting. Page 26.

And shared a personal reflection:

As many of you know, Purchase Meeting sits adjacent to an airport, and sometimes planes take off overhead while Friends are worshipping. On those occasions, I find myself wondering if there is that of God in the jet's roar. After all, they are made of the same substance as we are, material that came from the unfathomable miracle of Creation.

In The Givenness of Things, Marilynne Robinson offers one answer (pages 200-201): "Creation must have a quality at its center and in its substance to which we as human beings belong. . . . To worship God in the Creation is to celebrate as well the fact that we ourselves are created, and strangely and wonderfully made. Our honor and glory are not our own doing, and are only more precious, more to be enjoyed and explored, for this reason."

2025-07-18. Introductions

Fred then introduced the clerks' table and invited visitors to introduce themselves. Windy Cooler (Baltimore YM), Beth Collea (Quaker Religious Education Collaborative, Dover Friends Meeting, NEYM), Megan Thomas (FCNL), Traci Hjelt Sullivan (General Secretary of Right Sharing of World Resources), Greta Kirk Mickey (Baltimore YM, formerly of NYYM), Marian Baker (United Society of Friends Women International, Northeast Region). First-time attenders were Eric Roost (Morningside MM), and Mattie Johnson, her spouse Jason Perlman, and their baby daughter Alithia Johnson (Morningside MM).

The clerk reviewed the agenda.

2025-07-19. Epistle from Lake Erie Yearly Meeting

Matt Sunderland (Scarsdale Meeting), from the Epistle Committee, read selections from the epistle from Lake Erie Yearly Meeting. It urges mending of the net of our interpersonal relationships and of the wider society.

2025-07-20. Witness Section

Lu Harper introduced the Witness Coordinating Committee.

2025-07-21. Quaker Walk to Washington DC

Ross Brubeck (attender Brooklyn Meeting, member Sandy Springs Meeting, Baltimore YM) reported on the recent Quaker Walk To Washington D. C., which was inspired by the Flushing Remonstrance of 1657. The report began with <u>a video</u> of the walk. The group completed a new Flushing Remonstrance 2025, which was delivered to the offices of several members of Congress. Ross also read parts of the <u>report to the yearly meeting</u>, noting that the group had walked 295 miles on foot and paddled 5 miles by canoe across the Susquehanna River. The video and remonstrance are posted on the website <u>www.quakerwalk2025.org</u>.

2025-07-22. Presentation on Quaker Involvement with Slavery

Nadine Hoover introduced Josh Randall, who attended the public hearing in Buffalo on reparations to formerly enslaved people. He has researched information on how Quakers were involved in slavery, both as slave holders and as abolitionists. He presented <u>a series of slides</u> on this history, extending into the present.

2025-07-23. State of Society Report

Hans-Jurgen Lehmann (member-at-large, New York Yearly Meeting) and other members of the State of Society Committee read that committee's <u>report</u>.

2025-07-24. Budget

Albert Hsu (Wilton Meeting) & Laura Cisar (New Brunswick Meeting) presented the report of the Budget Development Committee (BDC). Albert presented a review of how the yearly meeting reached its current financial position, with a deficit budget for 2025. He indicated that the budget for 2026 will also be a deficit budget. Although the Sharing Fund and Designated Funds Reports are not part of this year's budget report, the BDC is planning to include them in the budget for 2026 and subsequent years.

Laura reviewed the current budget funds available and anticipated regular expenses. She then shared the public budget, which was sent to Friends earlier, with space for comments. There are two potential budgets for 2026, one assuming that Summer Sessions would be held at Oakwood School and the other assuming they would be held at Silver Bay. The difference is approximately \$20,000.

Albert spoke to the difference in deficit projections between the two estimates for 2026. He stressed that the higher expense for attendance at Silver Bay could be made up if Friends will be more generous with their contributions and if enough of them attend sessions at Silver Bay. The

Budget Development Committee, with input from coordinating committees and individuals, will discern how to decrease the projected deficit.

2025-07-25. Sharing Fund Appeal

Nadine Hoover (Buffalo Meeting) made an appeal to Friends to increase their support to the Sharing Fund by including it as well as the operating budget in their monthly meeting budgets for support of the yearly meeting. Individual Friends explained briefly the variety of activities the Sharing Fund supports.

2025-07-26. Closing

Having run over the allotted time, the meeting ended without consideration of the minutes, which will be read at the meeting on Tuesday morning.

2025-07-27. Welcome and Readings

2025-07-28. Introductions

After a period of silent worship, Gloria introduced the clerks' table and reviewed the agenda. Visitors attending for the first time introduced themselves: Steven Farmish, 15th St; Abby Daia, Brooklyn MM; Yohannes (Knowledge) Johnson, Bulls-Head Oswego MM; Monica (last name withheld at her request), Buffalo MM; and Dwight Huey, Manhattan.

2025-07-29. Epistle from Black, Brown, Indigenous, and People of Color Friends Meeting

Matt Sunderland (Scarsdale Meeting), Epistle Committee, read <u>the epistle</u> from the online meeting of Black, Brown, Indigenous, and People of Color from many yearly meetings on May 31, 2025.

2025-07-30. Minutes from last meeting approved

The minutes from Saturday morning's business meeting were read, and with one substantive correction, they were approved.

2025-07-31. White Privilege Conference Report

Karen Snare (Bulls Head-Oswego MM) gave the <u>attached report</u> of 10 members of NYYM who attended the White Privilege Conference in Hartford, Connecticut in March, 2025.

2025-07-32. Friends World Committee for Consultation Report

Jayant Singh (Bethpage Preparative Meeting) and Dwight Huey (Manhattan Meeting) gave reports from the Friends World Committee for Consultation (FWCC) Section of the Americas meeting. Dwight related some of his memorable experiences as a young Friend within a Youth Gathering group from about 50 countries. He then played a recording of a spoken report given by Sylke Jackson. The transcript is here.

2025-07-33. Epistle First Draft

Matt Sunderland (Scarsdale Meeting) and Carol Clarke presented the first reading of the epistle from this year's Summer Sessions. Friends offered ministry in response. Those with more comments were invited to send them by email to epistles@nyym.org.

2025-07-34. Report from Sessions Committee

Anne Collins, clerk of Sessions Committee (Saratoga Meeting) gave the slide-show <u>report</u> on the current sessions.

She reported that the Summer Sessions in 2026 are tentatively scheduled for July 12 to 18 at Silver Bay. She warned that if registrations for those sessions, by the end of January, 2026, are not sufficient in number, and if not enough volunteers step forward, the plan will be cancelled.

2025-07-35. Minute from NYYM Trustees

Albert Hsu (Wilton MM), reported that the Trustees had met on July 27, and had approved the following minute:

Minute 2025.07.01: Trustees authorize the Clerk of Trustees and the Financial Clerk of Trustees, as an ex-officio member of General Services Coordinating Committee, to sign the agreement with Silver Bay, contingent upon the inclusion of the signatories and Clerk of GSCC in (a) the establishment of a binding mitigation plan with benchmarks that must be met for the securing of necessary resources, including financial and volunteer, (b) regular meetings to check on the progress of the mitigation plan, and (c) the final decision to move forward with Summer Sessions at Silver Bay made in advance of the cancellation date.

One Friend asked how the Sessions Committee will work to address the needs at Silver Bay of Friends who have hidden or visible disabilities.

Another commented that the cost to attenders of attendance at Silver Bay is prohibitive to many young Friends.

The concerns raised above were addressed by another Friend, who commented that over decades of attendance she observed that Silver Bay was a location that nurtured the bonding of our faith community; that Silver Bay had added golf carts after observing NYYM's use of them; and that we have time in advance of Summer Sessions to figure out ways to address the full range of disability concerns.

A Friend asked if the contract has been signed, and the answer is that it has been and will go into the email this afternoon.

Specifics of a mitigation plan need to be developed and agreed to by Sessions Committee and Trustees, and will include financial, registration, volunteer, and staff milestones. If the agreed-to benchmarks are not met, the contract will be voided.

Friends emphasized that enough of us must register and pay for attendance at Silver Bay by the end of January. Further, those who can afford more must be prepared to give more.

Further discussion on this topic is postponed until the meeting on Friday.

2025-07-36. Minutes Approved

The minutes were approved, pending insertion of several corrections.

2025-07-37. Closing

The meeting closed with a brief period of silent worship.

2025-07-38. Greeting and Reading

The meeting began with a period of worship, out of which Fred Dettmer (Purchase), clerking this Business session, read the following excerpt from Marilyn Robinson's book *Reading Genesis* (page 39):

"Quoting from Genesis: 'out of the ground made the LORD God to grow every tree that is pleasant to the sight', she asserts: "This world is suited to human enjoyment ... in anticipation of human pleasure, which the Lord presumably shares. This is an extremely elegant detail. . . . It is a rich goodness that the Lord intended and created for our experience. Two things are signified, that God as the creator of beauty intends it for us to see and enjoy, and that He gives us the gifts of apprehension this pleasure requires, which is nothing less than a sharing of His mind with us in this important particular. That God Himself in some celestial sense has and enjoys this kind of perception gives us an insight into the meaning of our being made in His image. The world is imbued with these reminders that there is a beautiful intention and assurance expressed in every perception we have of loveliness in the natural world."

2025-07-38. Clerk's Table

The clerk introduced the Clerk's Table.

2025-07-39. Introductions

The clerk invited visitors and first-time attenders to introduce themselves. Christa Farmer from Westbury Monthly Meeting introduced herself. The clerk noted that we have received a letter of travel for Windy Cooler, who was with us earlier in sessions. Friends directed the clerk to endorse the letter of travel for Windy.

2025-07-40. Agenda Review

The clerk reviewed the agenda. Two reports will be deferred to Fall Sessions: Writing Statements of Conscience, and the report on the work of the New York State Council of Churches.

2025-07-41. Readings

2025-07-42. Reading of German Yearly Meeting's 1938 Epistle

Anne Barschall (Scarsdale) read German Yearly Meeting's <u>epistle from 1938</u>. It spoke of Jesus Christ's power over evil and death, the helping power of receiving epistles from other Friends past and present, and quoted extensively from one received from Australian Yearly Meeting,

which called us to be living epistles, and asked, "Can we help each other to remember more often that the power we long for is already waiting for us, and that to think of it, rather than our weakness and difficulty, is the way to victory?" The epistle from German Yearly Meeting ended with the call to Friends to "Let us be Friends!"

2025-07-43. Statement from Quaker Organizations Naming Genocide in Gaza

Lu Harper (Rochester) shared a joint statement from eight international Quaker organizations naming their belief that Israel's actions in Gaza constitute genocide. Witness Coordinating Committee will be forwarding the statement to monthly and regional/quarterly meetings, as well as sending it out in the Weekly Update, for Friends' discernment. The yearly meeting will be scheduling Zoom listening and sharing sessions to learn what is happening with the statement among our meetings and worship groups, to identify ways in which the yearly meeting and Witness Coordinating Committee could be helpful, and to discern whether the yearly meeting should endorse the statement. Look for announcements of those listening and sharing sessions in next week's Weekly Update and separate emails. Friends here tonight were invited to share the statement with their meetings. Meetings were asked to let the clerks of WCC know the results of their discernment by emailing us at wcc-clerks@nyym.org.
