Leadership Report

- Classrooms are filled. Staffing.
 - Garden teacher has been hired part time. All classrooms will get garden once a week.
 - Music teacher has been hired full time. All classrooms getting music once a week.
 - Assistant opening- in process of hiring one more assistant for lower elementary.
 - Special Ed is fully staffed this year
 - 1.0 FTE paraeducator in the building. Paraeducator is written in based on IEPs.
 - School psychologist will be available at 0.4 FTE
 - 1.5 case manager. New person is Ellen- coming with a lot of experience. Francesca (0.5)
 - Erin Bishop (0.8) speech language therapist.
- Positive Discipline workshop
 - Parent workshop with over 50 participants
 - In person workshop- Wednesday 6-8
 - After parent workshop, positive discipline training with staff (2 full days)
- Montessori Training
 - One upper and one lower elem teacher in Montessori training
- School lunch- free lunch for all students. All from scratch food free of charge regardless of income.
 - Big milestone!
 - Hoping to see more participation in the program
 - Snacks and breakfast also available for all students.
 - Opportunities for support in food prep?
 - Some students earned food handlers cards last year- there is an opportunity to have students with these cards help in the kitchen.
 - Much work to get to this milestone including - following the data and partnership and coordination with ODE. Great relationship with ODE nutrition department. Work over the summer.
 - Antonia and Thea really were the two that made this happen.
 - Kudos Antonia and Thea and admin!
- OLR- Online Registration
 - A big step forward from long lines
 - Reminders have been sent out consistently to families to register
 - Opened August 8.
 - First week of school there will be tables set up for families to register online who need to register.
- Building updates
 - Sidewalk repair
 - This summer- painting and small building repairs
 - Plot of land outside of door on Maryland is turning into garden for elem students.
