ARTICLE I — PURPOSE AND MANDATE

Pursuant to the Royal Charter of Solmeria and the sovereign authority vested in the Monarch under Article I, Section 2 thereof, this Royal Decree hereby establishes the Ministry of Citizen Affairs (hereinafter "MCA") as an official ministry of the Nation of Solmeria.

To administer all matters pertaining to the citizenship, identity, welfare, and civil records of the people of Solmeria, including immigration, the issuance of official identification documents, and the maintenance of the national census and population registry.

ARTICLE II — RESPONSIBILITIES

1	Process and adjudicate all applications for Solmerian citizenship
2	Issue and maintain official passports, identification cards, and civil documents
3	Oversee immigration policy and the lawful entry of non-citizens into Solmeria
4	Maintain an accurate and up-to-date national census and population registry
5	Administer civil records including births, deaths, marriages, and residency
6	Serve as the primary point of contact for citizen services and public inquiries

ARTICLE III — APPOINTMENT OF THE MINISTER

Pursuant to Royal Decree 2026-05-17 H, the Ministry of Citizen Affairs shall be led by a Minister of Citizen Affairs. The Minister of Citizen Affairs is appointed solely and exclusively by Sovereign Monarch Nolan Hartigan under the authority of Article I, Section 2 of the Royal Charter of Solmeria, which grants the Monarch exclusive power to appoint and dismiss heads of government bodies.

No confirmation, approval, or consent from the Royal Advisory Council is required for the appointment or dismissal of the Minister of Citizen Affairs. The Monarch may, at their sole discretion, consult the Council before making an appointment, but the Council holds no veto or blocking power over such decisions.

The Minister of Citizen Affairs serves entirely at the pleasure of Sovereign Monarch Nolan Hartigan and may be dismissed at any time by Royal Decree without cause, explanation, or Council review. Upon appointment, the Minister of Citizen Affairs shall swear an oath of loyalty and service to the Monarch and to the Nation of Solmeria before assuming their duties.

ARTICLE IV — RELATION TO THE ROYAL CHARTER AND POWER RESOLUTION ACCORDS

The Ministry of Citizen Affairs operates under the full authority of, and in accordance with, the Royal Charter of Solmeria. Nothing in this Decree shall be construed to grant the MCA any authority that conflicts with the Royal Charter or any lawfully enacted Royal Decree.

Pursuant to the Power Resolution Accords (Royal Decree: 2026-05-14 B), the Royal Advisory Council — presently composed of five (5) members — holds the right to author and introduce bills that, upon passage by Simple Majority of the Council and Monarchal assent, carry the force of law. Such legislation may govern the operations and conduct of the Ministry of Citizen Affairs within the bounds established by the Royal Charter and the Power Resolution Accords.

The Council may not, however, direct, override, or remove the Minister of Citizen Affairs, nor may any bill diminish, circumvent, or nullify the Monarch's lawful authority over the MCA as guaranteed by Article I of the Royal Charter and Article 5 of the Power Resolution Accords. The Monarch retains full veto power over any bill affecting this Ministry per Article 3 of the Power Resolution Accords, and the Council may override such a veto only by Supermajority as defined in the Royal Charter.

In the event of a Wartime Suspension invoked under Article 1, Section I of the Power Resolution Accords, the Council's legislative authority over this Ministry — along with all other ministries — is suspended for the duration of the qualifying condition, and the Monarch resumes sole legislative authority.

ARTICLE V — ROYAL ASSENT

This Decree is issued on 2026-05-17 under the full sovereign authority and seal of the Monarch of Solmeria, Nolan Hartigan, and takes effect immediately upon issuance in accordance with Article VI, Section 1 of the Royal Charter of Solmeria.
