Executive Council Code of Conduct

(Every Candidate must read and agree)

The Executive Council is the legally authorized governing body for the Associated Student Body. Members of the Executive Council are expected to act at all times in a manner that positively represents the students at Rocklin High School. They are expected to carry out the duties of their office in an efficient and ethical manner.

The following policy will be in effect for all members of the Rocklin High School Associated Student Body.

Academic Code

In order to be eligible for Executive Council, a student must have and maintain a minimum grade point average (g.p.a.) of 2.50. This g.p.a. must be maintained, regardless of any No Credits. If an Executive Council member does not obtain this minimum, they will be put on academic probation and placed in a mandatory study hall until their g.p.a. is raised to the minimum 2.50. Executive Council members may carry one NM. If a 2.5 gpa has not been re-established within one month after the grading period, the student is declared ineligible. At this point, the Executive Council Cabinet and Director of Student Activities may take disciplinary action including but not limited to lowering their grade in the leadership class and possible removal from position.

Behavior Code

Executive Council members *must*:

- Be a positive example of the Student Code of Conduct found in the RHS Student Handbook;
- Be present at school on the day of an Executive Council sponsored activity in order to participate in that activity.

Executive Council members *must not*:

- Use tobacco, alcohol, or illegal drugs; either on or off campus, during school or non-school activities;
- Cheat in their course work.

Violation of the Code of Conduct

Violation of the Code of Conduct will result in disciplinary action. Determination of the action taken will be made by a review committee consisting of Cabinet, the Director of Student Activities, and one administrator. The Principal will be the final appeal and/or review authority. The review committee may recommend:

- Removal from leadership class and Executive Council. Elected and appointed officers may be removed from their positions;
- Suspension from the leadership class and Executive Council;

- Any other discipline deemed appropriate.
