New Business

- Finance Motion regarding Funding. Scott W discussed a motion to amend the process for funding travel for Coaches, Athletes and Officials. While the criteria for funding will remain the purview of the respective committees (coaches, athletes or officials committee as appropriate for the class of constituents) and the LSC. The submission for funding will be standardized and simplified by the creation of a JotForm method. This JotForm method will require proof of attendance, acknowledging that the LSC support being requested is not reimbursement, but rather funding support. Coaches, Officials and athletes regularly have a greater financial investment than the allotted funding levels set forth by the LSC. Appropriate criteria for eligibility is remanded to the coaches committee, officials committee and athletes committee for determination of class attributes. Approved on M Brittany G and S Donna B, and unanimous approval of the BoD.
- Service Awards discussed by Luke M. Discussion was held regarding service awards. Lifetime Membership to USA swimming has historically the benefit accrued. Consider presenting an option to award in the honor of recipient to a charitable entity of the LSC.
- AVC Policy and Bylaw review. AMS is required to reflect in its organizational documents all elements required by USA Swimming. Valerie discussed new updates to the AMS By-laws required by USA Swimming. The documents will be housed on the shared drive for review and comment by the Board. Governance Committee should be reviewing and amending documents with the involvement of Valerie, the AVC.
- Valerie continued her presentation with discussion of the Operating Manual.

- o Suggested edits will be submitted in February and after review and comments period will be finalized in March.
- Allegheny County Pool issue and response
 - o A letter was received by all teams with a prior relationship with the Allegheny County Pools alerting them that no practice time will be given due to a shift toward community programming. Due to the fact that the impacted athletes are community constituents, A unified response by AMS, involving USA Swimming is required. It is estimated that 1,300 community athletes are impacted.
- Proof of Times and Scratch Rule language discussion. Donna B updated the BoD that the Officials Committee was in the process of reviewing and clarifying language for the LSC operating documents and Meet Announcement language concerning Proof of times, as well as scratch rules as set forth in the USA Swimming Rules and regulations.
- Donna Beyerl also updated the BoD on the review of criteria for the LSC regarding the benefits from, and requirements for, meets requiring a Meet Referee as opposed to a responsible single or coordinated duo/trio of session referees working in concert for consistency of experience.
