collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (dissemination, provision, access), deletion, and destruction of personal data.

The purpose of processing Personal Data is to ensure compliance with the laws of the Russian Federation and other regulatory legal acts, to enable participation in the Open Call, to provide application materials to the Open Call jury members for evaluation of compliance with the Open Call requirements and criteria, and to perform and fulfill other functions, powers, and duties in accordance with the legislation of the Russian Federation.
