

Timeline of Events

2003 I became enlisted to provide mortgage financing to Derek & Kathy Broes.

2018 I became in contact with Kathy Broes, we started an online friendship. I was Living in Mexico and she was in Snohomish WA. I had just begun a spiritual healing practice in Mexico working with plant medicines to help individuals in resolving addictions and past traumas.

2019, September. Kathy Broes asked to to reach out to her daughter Grace Broes to help her with overcoming her addictions with prescription medications and address the past traumas revolving around her father Derek Broes: Provided Methamphetamines to her at the age of 14 to use and distribute to her friends with the intent of molesting her friends. She carried much guilt around this. A lived for a month at Derek's Sister property, with Grace and her husband Poly, Derek and his new wife Meliea and Derek's sister Tish and her husband Mark.

2019, October. Kathy Broes solicits my services to address the abuse inflicted by her then ex-husband Derek Broes: She was raped by him for 12 hours while he was high on Methamphetamines.

2019, November 2 I was a speaker for Derek's 3 day convention for the "global witness" I spoke about Sacred medicines. And This was my first intuition Derek was noticing my knowledge of his abuse. https://youtu.be/JN2_fjaq3XU

2019, December 7 Derek Started his accusations publicly. And I responded with a video outlining the abuse of Derek Broes to myself and Jeanette- a young lady living at his sisters property. <https://youtu.be/lqjLvRxJEss> this video was taken down via copyright claim from Derek Broes and shortly after his attacks diminished to almost nothing and he was non-existent in my world.

2022, July 18 Dereke reaches out to me to make amends after choking out his current wife and fleeing to Mexico. <https://youtu.be/bnonsZGSV3c> I accepted his apology and started healing services with him on July 28th. <https://youtu.be/vuVq7eADGm4> Which were ultimately unsuccessful. As after his initial use of sacraments Derek became self righteous wanting to exploit the medicines I work with and on August 27th I distanced myself from Derek, his daughter Grace, her husband Poly, and Kathy Broes. Derek had admitted to me in a phone conversation that Grace, Poly and himself were conspiring to mix and sell Marijuana and 5-Meo-Dmt in the Night Clubs that Grace and Poly frequented and provided DJ services to.

2023 Jan 23 Unbeknownst to me Ogselena (tiktok handle) posted a video reporting she was a recovering drug and sex addict <https://youtu.be/eirnGG5EfgQ>

2023 Jan 30 Since our parting of ways on Aug 27th, I did provide Derek with an ear to lean on from time to time to keep his negative behaviors off me as a target. I was fully aware that I am dealing with an extreme narcissist and thought it better to not stir the bees nest. Derek sends

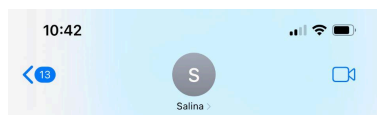
me a message inquiring how to give a street drug Molly/MDMA in conjunction with 5-MEO-DMT aka Bufo Alvarius a healing sacrament to, unknown to me, Selena Pepe aka Ogselena on tik tok. <https://youtu.be/Nrko28VYUb8> I politely disapproved of such practice, again retreating from being his next victim.

2023 February 24 I was very surprised to see Derek Broes serving sacred medicines to, unbeknownst to me, Selena Pepe aka Ogselena on tik tok. 2023 May 8 Around this time I had made a comment on Selena's tik tok video with Derek providing medicine to her, insinuating I could help her finish off dealing with her past trauma. We started texting each other and having conversations on the phone. She was very interested in my retreat. I was providing limited information and let her know about our partner program as she was having financial difficulties. On Tuesday May 9th at 7:38 am I provided a link for her to sign up as a partner on my InnerSerenity.org partner program. She responded with her agreement addressing my concerns. She signed our online partner agreement on 5/9/2023 at 9:46pm <https://drive.google.com/file/d/1xmUrDUaDjwI0TTaiu6jNrAJdEeYoAPx3/view?usp=sharing> Salina was now officially working to promote InnerSerenity.org. Moving forward I started confiding in Salina about my plans and desires as to how I am building my retreat business. I felt this was ok considering our discussion and the contract we now had in place. We then made a plan to have Selena come to Mexico and attend our retreat.

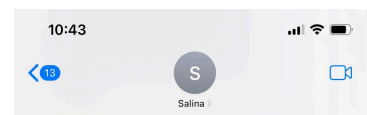

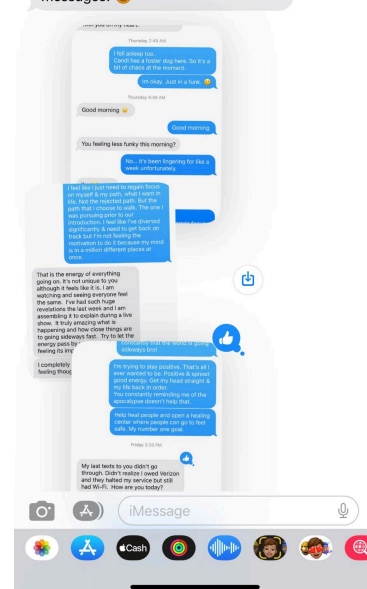

2023 June 30 Derek makes threats to my life and my daughters and partners life, he insinuates that the cartel is protecting him and will carry out his extermination orders.
