Delegate Representation and Voting Strength

Each local president has received an email listing the local's delegate representation and voting strength [sample email]. If the president has not received an email, please email convention@aft-oregon.org with the current president's name, email and mobile phone number.

All Delegates and Alternates must be elected in a secret ballot by the local's members. Please see the **Local Delegate Election Guidelines** for election requirements.

One person at each local should complete the <u>Delegate and Alternate List</u>, in order of rank, and email the list to <u>convention@aft-oregon.org</u> by **April 9, 2025**.

All delegates and alternates shall be required to provide **proof of identification** at registration to be seated at Convention.

Hybrid Convention

A referendum passed by AFT-Oregon members in 2022 specifies that all conventions must be **hybrid events**. Delegates and alternates can choose to attend either **in-person** or **remotely** using **Zoom** software.

This year, all in-person delegates and alternates will be required to have a fully charged smartphone each day at the convention.

Electrical outlets at the Seaside Center are extremely limited, so laptop computers are NOT recommended. We will be providing mobile chargers for smartphones, but not for laptops. In person attendees are recommended to bring their charging cable for their smartphone to the convention center to utilize the portable charger units.

Voting will be done via Zoom and text message or email, so delegates must be able to receive emails on their smartphones to the accounts that they used to register for the convention. The minimum version requirements are Android: 5.8.0 or higher and iOS: 5.8.0 or higher.

Remote attendees will need **Zoom** software and be able to access the email that they used to register.

Payments

The registration fee of \$75 applies to *both* in-person and remote delegates, alternates, and staff. A \$55 fee applies to guests. Payments are due at the AFT-OR office by **April 14, 2025.**

Amendments to the AFT-Oregon Constitution and Bylaws

Per Article X of the AFT-Oregon Constitution, all amendments shall bear the signature of at least two elected officers of the federation introducing the amendment. The officers signing the amendment shall certify that the amendment was approved for submission to the convention by the executive council or membership of the local. It must be submitted to the AFT-Oregon office postmarked or as a PDF document emailed to convention@aft-oregon.org by March 9, 2025.

This year, we are requesting that all amendments also be submitted as a **Google Doc** in addition to the signed PDF. The Google Doc must also be emailed to **convention@aft-oregon.org** by **March 9, 2025.** Please be sure to set the sharing option to: *Anyone with the link* can *view* the document, and make **convention@aft-oregon.org** an editor.

Resolutions

Per <u>Article IV</u> of the AFT-Oregon Bylaws, resolutions may be introduced by locals or the executive council. It shall contain the title and shall be submitted to the AFT-Oregon president as a <u>Google Doc</u> and a PDF. The resolution PDF shall bear the signature of at least two elected officers of the local and must be submitted to the AFT-Oregon office postmarked or emailed to <u>convention@aft-oregon.org</u> by **April 9, 2025.** Please be sure to set the Google Doc sharing option to: *Anyone with the link* can *view* the document, and make <u>convention@aft-oregon.org</u> an editor.

Convention Registration
