

# Privacy Policy

## **Welcome:**

When you play our games you use our service with the trust of your information. So we've designed a privacy policy that covers how we collect, use, disclose, transfer and store your information.

## **Collection:**

The information we collect depends on the context of your interactions in the game, the options you choose, including the privacy setting and the games and features you use. The information we collect can comprise JavaScript code version, IP address, ISP(Internet Service Provider, time zone, Mobile data or WIFI, your device model, Software Development Kit, Application Program Interface, the browser you are using, Application Identifier, distribution channel like Google Play or App Store, terminal manufacturer, device operating system version, In/Out time, language, location, age, time zone, Android ad master identifier, ad identifier (IDFA), the terminal manufacturer and so on, etc...

Some of our games might require you to sign up and when you do, you'll enter some personal information like your email address, phone number and store it with your account. Sometimes we collect this information from your social media accounts when you sign up with your social media. Some features would like you to must sign up with social media like Facebook and store your Display picture, Name, and some other information required.

## **Data usage:**

Whenever you use our services, we give you access to edit, delete, or update your personal and professional information. If somehow the information is wrong we notify you to update it. Or delete it unless we have to keep it for legal or legitimate business purposes. We protect your data to be deleted or updated by accident or malicious destruction. Because of this when you delete your data, we may not delete the data from our backup servers or any other copies we made.

## **Sharing of Data:**

Your data is protected with us and we take good care of our customer's data. We don't share personal information with any organization, company, or individuals outside of Game Mart Games Studios. Until the following situations:

- 1) With your permission:

When you opt-in to share your personal information with companies, organizations, or individuals based on the agreement.

- 2) Third-Party Processing:

We share your data with other trusted organizations or businesses to process it for us based on our agreement and compliance with our Privacy Policy or any other confidential or security measures.

- 3) For legal reasons

We will share personal information with organizations, companies, and businesses when it's needed for the Legal process, Governmental requests, Terms of Service, Fraud, Security or Technical Issues, or any other permitted by law request.

We might share your data with our trusted partners like publishers and advertisers or connected sites.

We might share your data with Analytics companies to process and compare our data with multiple trends. The companies must follow our privacy policy and security requirements. If we sell, merge, or acquired by a third party we will ensure that your confidential information is secured and ask you before transferring your data.

#### **Data Security:**

Our team put hours of effort to protect your data and avoid any unauthorized access. We've restricted access to our servers, and your data is totally encrypted.

#### **International Transfers of Personal Data:**

Due to business purposes, we might require to share your personal data from country to county. We take full appropriate measures to ensure that your data is confidential and secure.

#### **Children's Use of the Games**

Game Mart Studios has developed its Platforms to be an enjoyable experience for users of all ages. Some parts of the Platforms are primarily targeted at children, such as many of our games. Whenever we refer to children in this Privacy Policy, we mean children under the age of 13, unless otherwise indicated.
