## 9.3 Superintendent's Report (10 minutes)

Andrea Sheridan discussed the fall surveys. Data indicated parents feel the superintendent isn't visible in the community. Andrea shared that she is taking this to heart, and has been able to attend activities such as the chili supper and holiday programs. She is also in all of the primary classrooms throughout the year.

Regarding finances and budget, Andrea Sheridan shared that the Board of Education is gathering information to make an informed decision about going back to the referendum in April. Each school has had separate meetings about budget reductions.

Kelly Hirn asked what would help make the decision to go back to a referendum in April. Andrea Sheridan indicated that their model strongly recommends returning to a referendum.

Discussed trying to find ways to generate income by selling items that we may no longer need, or have extra of. Andrea Sheridan indicated wanting to pursue reduction options that are furthest from affecting students. Kelly Soczka-Steidinger suggested thinking out of the box and thinking about selling extra land and/or logging/trimming it down.

- 9.4 <u>School Board meeting updates</u> Link: School District <u>Budget reduction</u> information (10 minutes)

  Angie Servi reviewed the above documents and what she learned from the last school district meeting. Andrea Sheridan relayed that the meeting on December 19<sup>th</sup> will be conversational and about generating ideas. A resolution would need to be made by 1/24 to be on the ballot in April.
  - 9.5 Maple Grove Foundation Updates (time allocation: 5 minutes)

Peter Wade spoke to item 9.4 and encouraged the administration and district to support and communicate to the public the advantages of acquiring Maple Grove. He shared his opinion that a non-recurring referendum might have a better chance of passing. He indicated that surrounding school districts are going through budget reductions as well and encouraged the Athens School District to keep something attractive that might encourage out-of-district students to open enroll.
