Background

Many of the Global Health Issues that face our world nowadays Stem From the Lack of Financial resources and weak financial Management from countries around the world. Recognizing the direct relationship between Economy, Finances and health is fundamental for the prosperity of Global health and Universal Health Coverage. This is the big challenge that the Health systems face worldwide and impacts the road to providing patient- oriented, cost - effective and quality health services needed without facing financial hardships. From this issue, the well-known Science of Health Financing emerged as a core Function of every Health System. Today, millions of people do not access health services due to the out-of-pocket costs that impact negatively on their sustainability. Many others receive poor quality of services even when they have the means to pay for these services. This is why carefully designed and implemented Health Financing policies can make a difference and accelerate progress toward universal health coverage and SDG Goal Number 3, Goal number 5 and Goal number 8.

According to the World Health Organization, payments made by people for using health services are usually out of pocket payments/expenditures that cause Financial Hardships, especially in LICs and LMICs.

The foundation of Financial Management, regardless of how funds are administered remains the same. In other words, the principles of Finances are stationery, it is the applied environment that changes. Through this Online course, the common Financial Management skills executed in NMOs will be discussed, appended and reformed to be applied on Health Systems and the achievement of Universal Health Coverage

Our aim is to strengthen the IFMSA Member Knowledge On finances and facilitate the understanding of Health Financing and its importance in tackling today's health issues. Through this course we will discuss the different functions of health financing and health economics in detail with extensive country illustrations, to build capacity in resource administration, priorities for health packages, liaising for sponsorships. This, to offer a clearer understanding of how health financing policy is developed, how the key policy decisions around each of the four core functions intertwined, and to get an understanding of how each can support progress towards UHC.

Objectives

- 1. Participants Acquire Clear understanding and knowledge on the core functions of health systems, Universal health coverage, health financing and Health Economics.
- 2. Acquire clear understanding on the role of Finances in Health
- 3. Participants understand how Health Financing policies are applied and developed Worldwide.
- 4. Link the importance of having sustainable finances for health with universal health coverage and quality healthcare services.
- 5. Apply relative NMO Financial Management Skills on health systems
 - Associated Indicators
- 70% Participants filled the pre assessment and post assessment survey
- 90% of the participants got clear understanding of the role of health financing in UHC which will be evaluated in the post assessment survey
- 80% of correct answers on interactive question in sessions
- 80% of participants share their feedback via wooclap at the end of each session

Methodology

The advanced online course will take place through Zoom Meetings/Google Meetings and will be held over a period of 2 weeks, (3 sessions/Week). Focus areas will be discussed throughout the sessions as demonstrated above. Participants will be assigned homework after each session. This will be moderated using Google Class Room for easier accessibility and Tracking. HomeWork will either be Individual work performed by each participant, or group homeworks to encourage collaborative thinking, open discussion between team members and build up teamwork skills. In addition, readings will be distributed and will either be suggested readings for further knowledge or compulsory readings that complement the topics and facilitate further understanding and comprehension. A pre and post assessment form will be distributed as a method of evaluation.

Avenues of Engagements and interaction:

- 1. Dialogues will be conducted and facilitated through Google Classroom or Miro to provide participants with an additional platform to share their perspectives and examine other viewpoints as well.
- 2. Upon participants' agreement, an online group on a preferred social media platform (Whatsapp, Facebook, Telegram, etc.) will be created for easier communication and accessibility.

Finances in Global Health Course, is an overarching and interdisciplinary Course, using real life experiences and application from different countries. The Knowledge explained will be divided into:

1/3 Health systems and Universal Health Coverage.

3/3 Health Financing and Economics.

The Course will be Composed of 6 Sessions given over 2 weeks:

Session 2: Health Financing - Basics
Session 3: Health Financing - Advanced (1)
Session 4: Health Financing - Advanced (2)
Session 5: Health Economics - Principles and Evaluations
Session 6: Road to Sustainable Finances in health + wrap up.
