This section includes the background of the problem, a literature review of previous research and the novelty of the study. In the last paragraph of the introduction, the research objectives are stated.

The introduction should be written based on the rules of scientific writing. Arabic-Indonesian transliteration refers to the results of a joint decision between the Minister of Religion and the Minister of Education and Culture of the Republic Indonesia written in the Joint Decree of the Minister of Religion and the Minister of Education and Culture of the Republic of Indonesia No. 158 of 1987 and No. 0543b/U/1987.

They should not contain raw data that still requires further processing. Thus, the readers can directly obtain important information from them without having additional data analysis or processing. This section consists of a brief description in the form of answers to the problems raised. It is written in paragraphs (not numeric) and contains research conclusions and recommendations given to the involved parties in the research. (Font: Constantia, font size: 12, paragraph: justify, single-spaced)

REFERENCE (Font: Constantia, font size: 12, paragraph: justify, single-spaced, font style: bold)

The article should consist of references that includes only the sources used in the citation. It should be organized alphabetically by the author's last name or the institution's name from which the citation is taken. The authors are required to use recent sources within the last 10 years with at least 15 references used. The references should include sources that are relevant and support the content of the article.

The authors should pay attention to the ratio between primary and secondary sources. 80% sources come from primary sources, such as scientific journals. While 20% sources come from secondary sources, such as books, proceedings, magazines, newspapers, internet pages, thesis, legislation, and interviews.

The citation and referencing system used in the article should follow *American Psychological Association* 7th edition. This applies to all references included in the text and reference. It is highly recommended to use reference management applications, such as Mendeley, Zotero, or other applications to facilitate drafting and management of the reference in accordance with the provisions mentioned earlier.
