Senator DJ- Have an extra week in between the committees, the DJs committee constantly doing stuff outside of the Committee. People are going away because of the amount of meetings. Underclassmen have more say because they have more flexibility. Meetings are getting shorter and the time is not representative of what is going on inside of SGA. Talked to Adam about changing the timeline for how student Organizations get funding. Believes people are scared to change. “If it ain’t broke do not fix it” is not representative of this case according to Dj. People who want to stay but do not have the time to stay because of how often meetings are happening. Believes suggestions given would not be good. Believes in change with this, possibly waiting a month. More reflective of what a “vacancy intern person would say”. Adam- Both advocate for change but have different priorities and the time commitment is not efficient from others to SGA.

President Olusesi- Committee leaders shouldn't be able to decide meeting times, how would this work?

Senator DJ- Senate Culture to brainstorm ideas about how this would work.

President Olusesi- Leadership to small, speakers to come to leadership meetings and invite senators and other SGA members.

Vice President Issiah- Tweak the time limits, limit speakers possibly.

Senator DJ- start explaining time limits to speakers before they come.

Vice President Issiah - Disagrees with times.

President Olusesi- Biweekly GA meetings, 2 separate dates for committee and GA.

Vice President Isaiah - “Is there something we all want to change on the Bill?”

President Olusesi- Toss it back and have further discussion.

Senator DJ- “How can it be referred to?”

Adam- Use your enhanced officer report

Senator DJ- “Leave it as it is, come back next week?”

President Olusesi- Return to GA unfavorable.
